
1. I am 62 years old and was born in Greece. I moved to the United States in 1954 when I was 10. I became a citizen of the United States in about 1965.

2. I have lived in Ohio since 1954.

3. I registered to vote when I became a citizen. I believe that I have voted in most primary and general elections since then. I plan to vote in the November 2006 general election and the elections that follow. My right to vote is precious to me, and I believe it is one of my responsibilities to vote.

4. It is my understanding that, if my eligibility to vote were challenged at the polls for being a noncitizen, I would be required to present my original certificate of naturalization.

I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge. Executed this 28 day of August 2006 in Cuyahoga County, Ohio.
