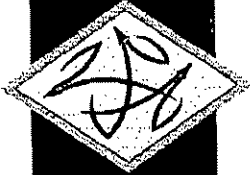

Dear Chairman Wolf and Congressman Serrano,

On behalf of the Asian American community and the undersigned organizations and in partnership with the Brennan Center for Justice at NYU School of Law's National Campaign to Repeal the Legal Services Corporation's Private Money Restriction, we greatly appreciate your efforts to secure funding for the Legal Services Corporation (LSC) in the 2005 Commerce, Justice, State, the Judiciary, and Related Agencies (CJS) Appropriations bill. We share your commitment to the federal government's provision of affordable legal services to our country's neediest families.

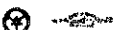
We write today because we are increasingly concerned about a provision in the CJS Appropriations bill that severely restricts the use of private, state and local funds by nonprofit legal services providers that receive LSC funds. This "private money restriction" encumbers more than \$300 million annually in non-federal funds that otherwise would be available to provide critical forms of legal assistance to many of our society's most vulnerable members, particularly the immigrant community.

The LSC private money restriction imposes particular hardships on low-income Asian Americans, who are part of the fastest growing minority group in the nation. More than 60 percent of the members of the Asian American community are immigrants; and a significant portion, including many in refugee communities, is low-income. These individuals and families have an enormous and pressing need

for linguistically accessible legal assistance on a variety of common legal problems – including those involving domestic violence, healthcare, housing, labor, immigration, education, and discrimination matters – that is often unavailable because of the LSC private money restriction. And this need has only worsened due to the increase in discrimination against certain Asian American communities that persists in the wake of the terrible 9/11 attacks on our nation.

We urge you to continue your leadership on behalf of America's families by guiding efforts to end this unfairness as the provisions of the 2005 CJS Appropriations bill are considered in further budget discussions this year. Later this week, members of the Brennan Center's Coalition with legal services program experience will be visiting with members on the hill for the Brennan Center's Education Day in an effort to provide a local community's perspective on the harsh ramifications of the LSC private money restriction.
