I write to encourage you to support House Bill No. 70 (HB 70), which has passed out of the House and is now before the Senate. This bill would place before the voters of the state a constitutional amendment to restore voting rights to people who have fully completed their sentences and paid their debt to society, excepting those convicted of murder and certain sex crimes who would still be required to seek an executive pardon to restore their rights.
