
Arkansas

Registration Deadline

Forms must be received or postmarked 30 days before an election.¹



Database Implementation Status

Arkansas is in the midst of constructing a statewide database in top-down fashion, in which county officials will have direct access to a centralized state database. The state signed a contract with Election Systems & Software in January 2005 to develop the database system.²

Entering Voter Registration Information

Who inputs voter registration information? County registrars generally review and enter information from voter registration forms in their jurisdictions into the statewide system.

What happens to voter registration forms submitted at state registration agencies? The Secretary of State's office collects all mail-in registrations and forwards the original forms to county registrars for review and entry. Applicants processed by the Office of Driver Services ("ODS") do not submit physical voter registration forms, but information is taken from each applicant in person, and is entered into an electronic file. That file is then sent to the appropriate county, where a county clerk reviews and enters the information into the statewide system.

How are most forms submitted? Arkansas reported that in 2004, 28% of forms were submitted by mail, 36% were submitted in person to election officials, 26% were submitted at the DMV, 6% were submitted at another voter registration agency, and 4% were submitted by other means.³

Processing of Forms Without Identifying Numbers

How will the state treat an application with an affirmative indication that the applicant has no valid identifying number? The applicant will be assigned a unique voter registration number. If the applicant is otherwise eligible, she will be considered registered.⁵

Making the List AR - 1

How will the state treat an application without an identifying number and without an affirmative indication that the applicant has no such number? If the applicant is otherwise eligible, her registration will be considered pending. An applicant whose registration is still pending on Election Day may vote if she presents state-issued photo identification at the polls.

How will the state treat an application listing an identifying number that is either incomplete or illegible? If the applicant is otherwise eligible, her registration will be considered pending. An applicant whose registration is still pending on Election Day may vote if she presents state-issued photo identification at the polls.

Matching Against Motor Vehicle and Social Security Records

What fields from the voter registration form will the state seek to match to motor vehicle or Social Security records? Identifying number, date of birth, and last name.

How precise is the match standard? Arkansas will use a "substantial match" standard to match information on voter registration forms.

How much human intervention is involved in determining whether information is matched? Arkansas intends to use a system that returns a list of records, and gives the registrar the discretion to determine whether a likely match exists among the possible matches returned. Arkansas, however, has not yet completed system design and has not yet fully determined the extent of human discretion that will be involved.

Description of matching process: Arkansas has not yet determined the process by which a match for information on voter registration forms will be sought. The state intends, however, to design the system such that once a registrar enters information from a new application into the statewide database, the system will automatically search for matches. The system will return a list of possible matches, and the registrar has the discretion to determine if a likely match exists among the possible matches returned.

What are the consequences if the state cannot find a match? If the applicant is otherwise eligible, her registration will be considered pending; an applicant whose registration is still pending on Election Day may vote if she presents state-issued photo identification at the polls.

Notice and Opportunity to Resolve Errors

Does the applicant have the opportunity to correct a missing or incomplete identifying number, without submitting a new form? Yes. The applicant may correct missing or incomplete information at any point that leaves the county registrar enough time before Election Day to verify an identification number. The State Elections Board estimates that most counties will be able to verify corrected information up to 48 hours before an election.⁶

Does the applicant have the opportunity to resolve a failed match, without submitting a new form? Yes. The applicant may submit information to resolve a failed match at any point that leaves the county registrar enough time before Election Day to verify an identification number. The State Elections Board estimates that most counties will be able to verify corrected information up to 48 hours before an election.⁷

If information on an otherwise timely application is corrected after the voter registration deadline, is the correction timely? Yes.

Description of notice and correction process: An applicant with a missing, incomplete, incorrect, or unverified identifying number will be placed on a list of "pending" registrations; the registrar will also mail the applicant a notification and a new registration form. The notification will ask the applicant to provide a correct and verifiable identifying number or a photocopy of a state-issued photo identification to her county registrar with enough time for the county registrar to verify the identification number before the next election. The notification will also inform the applicant that if the identification number is still unverified by Election Day, she may nevertheless vote if she presents a state-issued photo identification card.

Identification Requirements at the Polls

Who must provide identification at the polls? Every voter whose registration status is "pending" – including those who submitted identifying numbers that have not been verified – will be required to show state-issued photo identification at the polls in order to vote a regular ballot.⁸

Every other voter will be requested to show identification at the polls, but may still vote a regular ballot even if she fails to provide acceptable identification.

What forms of identification are accepted? Every voter whose identifying number has not been verified must show state-issued photo identification. Every other voter will be requested to show current and valid photo ID, or a copy of a current utility bill, bank statement, government check, paycheck, or other government document that shows the

What are the consequences of failing to show identification? Every voter whose registration status is "pending" – including those who submitted identifying numbers that have not been verified – will be given a provisional ballot that will likely not be counted, at the discretion of the county board of election commissioners. Every other voter may vote a regular ballot.
