

**Threats to law enforcement detected by BRIC analyst on 7 December 2021:**

Quick update-I spoke to the BEST clinician and she told me that [REDACTED] has been sent to Bridgewater for further evaluation until 12/23. He is due back in Dorchester Court on that date at which time a decision will be made as to whether he is held for a longer period of time or placed in another hospital.

Regarding this threat that was found by a BRIC analyst earlier today-[REDACTED] was arrested a short time ago by C-11 units. I spoke to the BEST team clinician from C-11, and sent her the background information on the original Tweets. They are going to evaluate to determine what else they can do from a mental health perspective.

Prior to that, a detective from Revere PD responded to the address at [REDACTED] in Revere and determined that he was not there. They also interviewed his sister who stated that [REDACTED] was believed to be residing at [REDACTED]. That address is believed to be his mother's apartment. Earlier this morning, before becoming aware of the threatening Tweets, C-11 units responded to that address after [REDACTED] assaulted a neighbor by punching him in the face. He was gone at the time of their arrival but they returned after I called them and were able to locate him and arrest him on his outstanding warrants.

The BEST clinician interviewed him and stated that he was making delusional and bizarre statements and was exhibiting signs of paranoia. Those observations coupled with the threat information that we shared with them should provide the judge with enough information to take necessary action. She said she has spoken to the Forensic Psychologist at the Court and they are in agreement that he should be Sectioned. If for some reason, it is too late to see a judge, they are pushing to have him sent to Bridgewater for the night to come back for court tomorrow. She will update me as soon as she knows.

Nice job by the BRIC analyst on the original threat and thanks to Revere PD for the quick response to the location there.

I found several concerning Tweets this morning sent by Twitter user [REDACTED]

[REDACTED]. I was able to ID the user as [REDACTED] [REDACTED] has warrants, a BOP, and a current restraining order.

As you can see in the below in select Tweets, [REDACTED] makes several threats to police and mentions both Revere and Boston. There is also a [video](#) of a phone call with [REDACTED] where someone states the address [REDACTED] and states "we're going to come and shoot your head off" in the audio. [REDACTED]

who is threatened via Tweet and in the audio from the video, has the same address [REDACTED]

[REDACTED] has two warrants (attached) from September 2021:

ABUSE PREVENTION ORDER, VIOLATE [REDACTED]  
LICENSE SUSPENDED, OP MV WITH [REDACTED].

[REDACTED] also has a BOP (attached), which includes a current restraining order, violation of a restraining order, MV charges, and drug charges from 2007 & 2005.

**Threats to Mayor Wu detected by BRIC analyst on 27 December 2021**

Content was posted about the B Together initiative requiring vaccine passports in the city of Boston on the "Official New England Proud Boys" telegram channel.

In the comments section of this post, a user with a screen name of "██████████" and a username of "██████████" posted the following comments on December 22nd, 2021:

*Boston has 60% of the states residents, add in the metro area and that jumps to about 80%  
A vast majority of that 80% are liberal faggots. Nothing is changing here unfortunately  
The only thing that'll work at this point is a 308 and a set of balls*

It is worth noting that another member of the channel replied to "██████████" comments with "Negative on the dirt nap approach. That's what Soros and his deep state want" possibly indicating that they also perceived the comment as a threat.

Screenshots are attached. The user's telegram bio states "Patiently waiting" and his profile picture consists of Nazi symbology.

A quick open source assessment was done on the username "██████████". This username has been re-used on at least two different bodybuilding forums, and the members of one of these forums have stated that they know "██████████" to be from the Boston area.

Next steps to attempt to identify this individual could be to join these bodybuilding forums to see if ickyrica's user profile there could give any further information from which to pivot. Another approach could be to attempt to add the Telegram profile to our contacts to see if the user allows the public to view their phone number. Outside of finding more information from those two options, identification of this individual is unlikely in my opinion.

Social media workup assistance provided to NYPD on 16 November 2021

I think the individual behind these social media profiles is [REDACTED]. The latest address in Mark43 for [REDACTED] is [REDACTED] this may be his mother's house as it is the only address associated with her profile in Mark43. The facebook page for [REDACTED] was examined. Through targeting friend lists of individuals who engaged with the original profile, a second Facebook profile was located for the subject, [REDACTED]. Posts on both this profile and [REDACTED] indicate that a possible day of birth is March 11, screenshots included below. Further examination of profiles which had closely engaged with [REDACTED] led to a Facebook profile for [REDACTED] through an intermediary [REDACTED]. The facebook profile for [REDACTED] indicated in at least two different posts that she and [REDACTED] were siblings. [REDACTED] specifically states in one comment "Our Mom Is Fire Sis" screenshot attached. The individual behind the [REDACTED] profile was identified as [REDACTED] via a newspaper article included in her cover photo and selfies posted wearing a nametag. Mark43 returns records for a [REDACTED] who visually matches the individual in the facebook profile. The profile for [REDACTED] was tagged in the post revealing the sibling relationship between [REDACTED]. [REDACTED] has at least three Facebook profiles, matched through common associates and visual identification: [REDACTED]. Mark43 returns records for a [REDACTED] who visually matches the individual on the Facebook profiles and has an existing relationship with [REDACTED]. An examination of [REDACTED] posts identified a photo with an individual who looks similar to the Subject posted on November 28, 2017 with the caption "My handsome son" screenshot attached. Further examination revealed a second photo posted by [REDACTED] on July 29, 2016 which shows an individual who looks visually similar to the subject and has the [REDACTED] on his right forearm visible in an [instagram post](#) on August 28, 2021 from the provided account [REDACTED], screenshot attached. Open source third party data aggregators reported that [REDACTED] MA were also associated with one [REDACTED]. Mark43 returns records for one [REDACTED]. No picture is returned, however, the description states that [REDACTED] has a [REDACTED] - Forearm, Tattoo" as well as [REDACTED], Right Arm - Upper Arm, Tattoo" both of which can be clearly seen in the second picture mentioned from [REDACTED] page posted on July 29, 2016. Further, the day of birth matches that which was originally suspected from examination of [REDACTED] profile. Additionally the profile [REDACTED], believed to be associated with [REDACTED] posted a photo on July 7, 2009 with the caption "My youngest son..." screenshot attached.

Ok After re-reading this one I think it's worth some effort to attempt to ID the individual based on these facebook pages. Evans, could you take the lead on that? Lets compile a couple good ID wanted style images from the pages and then Shea can run those by the gang unit for their awareness and to see if anyone there recognizes the individual from the pages. Looks like we do have several older incidents w BATTs in the 2002 - 2004 timeframe attached in case they help. At a minimum later today we can send those to this detective.

Good Evening,

We've had two shooting incidents in which we have identified an unknown individual who is using the moniker "[REDACTED]". It appears he is from Boston and we can not get a hard ID on him.

He associates with a known individual from Brooklyn who he claims he is his manager for his rap career [REDACTED]. [REDACTED] does have a criminal history in Boston.

Below is the Social media pages of the individual we are attempting to identify. Any help would be greatly appreciated.

## Threats detected by BRIC analyst on 8 November 2021

On November 8 at 9:54 AM twitter account [REDACTED] (twitter screen name '[REDACTED]') tweeted the following:

*"IF THE BOSTON POLICE DONT PROTECT ITS CITIZENS, WE MUST BRING LARGE WEAPONS AT ALL OUR RALLIES AND PROTECT OURSELVES!!!"* Please find a screenshot of the tweet attached below as well as links to [original tweet](#) and the [archived version](#).

Further examination of this account revealed the following additional tweets

At 8:54 AM on November 8 this account tweeted *"IF THIS CONTINUES WE PATRIOTIC AMERICANS MUST ALLY WITH RUSSIA, GET THE WMDS WE NEED AND PURGE OUR GOD BLESSED HOMELAND!!!!"* Screenshot attached as well as [original](#) and [archived](#) versions.

At 9:03 AM on November 8 this account tweeted *"ITS TIME FOR " MASS REVOLUTION " ACROSS OUR " GOD BLESSED HOMELAND " IMMEDIATELY!!!!"* Screenshot attached as well as links to [original](#) and [archived](#) versions.

At 9:19 AM on November 8 this account tweeted *"ITS TIME TO WAGE WAR!!!"* Screenshot attached as well as links to the [original](#) and [archived](#) versions.

It is my assessment based on open source information that it is possible that the [REDACTED] who appears to be a real person, a retired Lt from the Boston Fire Department and is associated with an address in South Boston, may also be the same [REDACTED] associated with the twitter account which shared the tweets detailed above this morning.

Research located a facebook page for a [REDACTED] in Boston posting similar rhetoric to that on the twitter account detailed above. Older posts do appear to show that the individual behind this account has engaged with family and friends on the platform. The account has posted pictures of grandchildren and interacted with other accounts. This may indicate that it is not simply a fake or troll account. Additionally, this facebook account has also shared firefighter related content in the past and engaged with local "America Backs the Blue" content.

A LinkedIn page was also identified which stated that [REDACTED] " was or is currently a Lieutenant with the Boston Fire Department, screenshot attached.

A document containing General Orders for the Boston Fire Department in [REDACTED] was located on the Boston Fire Historical Society website which stated that a [REDACTED] " from [REDACTED] retired. The order goes on to state that [REDACTED]

Threats to local journalist detected by BRIC analyst on 8 November 2021

Below is an overview of the Twitter account [REDACTED], which posted the following on 11/6/2018:

*Hey jeff jacoby who writes for the Boston Globe*

*I'll kill your entire family*

Jeff Jacoby is a conservative writer for the Boston Globe who published an article today outlining three reasons to vote "No" on question three today (transgender rights question). [REDACTED] appears to be a transgender individual. Article [REDACTED]

The Twitter User [REDACTED] " appears to be the "evil" side of another Twitter User "[REDACTED] or "[REDACTED] [REDACTED]. There are several references to the relationship between the two. This Twitter User claims to be a [REDACTED], autistic, depressed/anxious transperson. The user appears to identify as a female.

I've included relevant screenshots of both Twitter profiles and another social media site (mastodon) that appear to be associated with the same user. Screen shots below show threatening language, pictures of the user's potential location, and pictures of the individual. Note that I was able to find the address of one picture posted [REDACTED]

- On 8/20/15, the BRIC received an email from Hynes security regarding a possible threat on social media to the Pokémon World Championship
- The BRIC evaluated the following screenshots, identified the users involved, and put out a bulletin
- The two men who issued the threat were stopped by police at the Hynes Convention Center shortly after
- A search warrant was later executed on their car and the men were arrested at a hotel in Saugus after police found guns and ammunition
