- (U//NP) On 28 October 2024, ballot boxes in Oregon and Washington state were set on fire by incendiary devices in what local authorities believe to be connected incidents. The ballot box arsons are also believed to be connected to a third ballot box incident that occurred earlier this month in Vancouver, Washington. Law enforcement officials have reported that the incendiary devices that were found at all three of these locations were marked with the words "Free Gaza." Approximately 475 ballots were damaged in the incident in Vancouver, WA but election officials have stated that they will be able to pull voter information from the ballots despite the damage to them.
BRIC Notes: Following the reports of these incidents, there have been calls for individuals to conduct similar criminal action towards election infrastructure. Some online users have called for individuals to "do this EVERYWHERE" while others have stated that they will do the same to drop boxes in their communities. Currently the BRIC has not observed any calls for similar activity to take place within the Metro-Boston Homeland Security Region.
- (U//NP) On 23 October 2024, Jeffrey Kelly, 60, was arrested in connection with three separate shootings involving a Democratic National Convention (DNC) campaign office in Phoenix, AZ. According to police, Kelly allegedly fired BB gun pellets and later bullets at the front of the campaign office on 16 September, 23 September, and 6 October 2024. Prior to this, on 21 October 2024, it was reported that John Pollard, 62, was arrested for allegedly threatening to "skin alive" a state party representative's employee who posted about recruiting poll watchers for election day.
- (U//NP) On 23 October 2024, California resident Nathaniel James McGuire, 20, was charged with three felony counts in connection with committing a bomb attack targeting a courthouse in Santa Maria, CA, injuring several individuals. McGuire stated during his arrest that the government had taken his guns, and that people needed to "fight, rise up, and rebel." After a search of McGuire's car officers found a shotgun, a rifle, ammunition, a suspected bomb, and ten Molotov cocktails.
BRIC Notes: Amidst claims that election will be stolen in favor of the Harris-Walz campaign, online users continue to threaten violence, with many stating there is "no option" besides a civil war should Harris win. The BRIC is not aware of any specific or credible threats related to these statements or any calls for similar activity to take place within the Metro-Boston Homeland Security Region.
