Re: Minnesota Government Data Practices Act

Dear Mr. Lane,

This is a request under the Minnesota Government Data Practices Act ("GDPA"), Minn. Stat. § 13 (2011), *et seq.*, on behalf of the Brennan Center for Justice at NYU School of Law a Freedom of Information Act (FOIA) request on behalf of the Brennan Center for Justice at NYU School of Law.

The Brennan Center seeks copies of successful Grant Agreements between the State of Minnesota's Department of Public Safety- Division of Homeland Security and Emergency Management (HSEM) and the City of Minneapolis under the Homeland Security Grant Program (HSGP) for Fiscal Year (FY) 2014. Minnesota applied for, and successfully received federal funding from the Federal Emergency Management Agency (FEMA) via two HSGP sub-programs: 1) the State Homeland Security Program (SHSP) and 2) the Urban Areas Security Initiative (UASI). As a sub-grantee, the City of Minneapolis in turn has been awarded federal funding to support operations related to Homeland Security and emergency preparedness under HSGP.

Formal Request

According to the HSEM Grant Manual,² all sub-grantees are required to maintain appropriate supporting documents for each sub-grant, as listed below:

- A signed Grant Agreement (detailing standard conditions of the sub-grant, including the total dollar amount; the sub-grant period start- and end-date; and any applicable special conditions).
- A project narrative or work plan; and detailed budget.
- Quarterly narrative progress reports.
- FSRs with all supporting documentation.
- Correspondence with HSEM or others regarding this sub-grant.

The Brennan Center hereby requests a copy of the successful grant agreements and supporting documents, as listed above pertaining to the City of Minnesota's application for federal funding from the SHSP and UASI for FY 2014 (Catalog of Federal Domestic Assistance No. 97.067) in relation to the specific grants listed below. In particular:

- 1. Minnesota applied for federal funding through the UASI for FY 2014. FEMA approved the application and allocated \$5,500,000 to the Twin Cities Urban Area. Of this amount, the City of Minneapolis received a sub-grant of \$990,000 under UASI.³ We request the signed Grant Agreement between Minnesota HSEM and Minneapolis including all supporting documentation, as listed above. The Brennan Center also requests any communications between HSEM and Minneapolis regarding modifications to the city's FY 2014 application.
- 2. FEMA allocated \$3,978,000 through the SHSP to Minnesota. We understand that the City of Minneapolis applied for funding as a sub-recipient. The Brennan Center requests a copy of the signed Grant Agreement between Minnesota HSEM and Minneapolis, including all supporting documentation, as listed above. The Brennan Center also requests any communications between HSEM and Minneapolis regarding modifications to the city's FY 2014 application.

Response Requested

Consistent with the GDPA, we ask that you acknowledge this request promptly. Please provide the date, within a reasonable time, when the information will be available. ⁴ To the extent that your office chooses to withhold any information based on one or more of
