The Missouri General Assembly passed Senate Joint Resolution 38 during the 2020 legislative session, which proposes to amend Article III of the Missouri Constitution and will be submitted to voters at the November 3, 2020 general election. Under § 116.155, RSMo, the General Assembly included in the Resolution a summary statement that is 50 words or less to summarize the measure and that will appear on voters' ballots. Plaintiffs filed the lawsuit challenging the fairness and sufficiency of the General Assembly's summary statement. After a bench trial on stipulated facts, the Circuit Court entered judgment in favor of Plaintiffs, wrote a revised summary statement, and ordered that Defendant Ashcroft certify that revised language.
