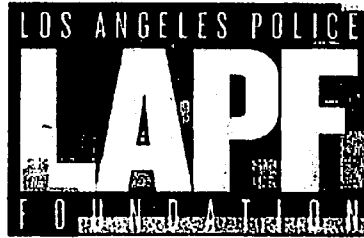

It is requested that the grant to fund \$72,000 for the renewal of the 80 Geofeedia licenses be approved. Approval of this grant benefits the Los Angeles Police Department (LAPD) as follows:

Geofeedia is the only patented location-based social media monitoring, analysis and engagement platform for law enforcement. This program enables law enforcement agencies to derive social intelligence to understand, in real-time, what's happening at the locations most important to them. Geofeedia will give us the ability to search seven social media sources by geo-location, from a specific address to an entire neighborhood, and then filter the results by timeframe, keywords or specific individuals. Geofeedia has the capability to instantly translate over 50 languages.
