The software will provide measurable accomplishments in terms of: generation of tips/leads, investigative support around domestic and international extremism, real-time situational awareness for emergency management (to include terrorism, California wildfires, and mass casualty events), managing disinformation and fostering crisis communications, [redacted] democratization of information (i.e. open source information is inherently publicly available and UNCLASSIFIED, and thus can be more easily shared), support to traditional cybersecurity, protective intelligence regarding [redacted].
