**STIPULATION OF EVIDENCE**

---

**WHEREAS**, in each of the above-captioned cases (nos. 2021-1193, 2021-1198, and 2021-1210), the Ohio Supreme Court has entered an order providing that parties shall file any evidence they intend to present no later than Friday, October 22, 2021; and

**WHEREAS**, counsel for relators in all three cases have met and conferred with counsel for the Ohio Redistricting Commission and have agreed that the documents attached to this stipulation are authentic copies of documents posted by the Ohio Redistricting Commission on its website, accurately reflect proceedings before the Commission, and may be presented to this Court as evidence in these cases, without waiving any arguments as to the meaning or interpretation of those documents;

**NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED BY AND BETWEEN RELATORS AND THE OHIO REDISTRICTING COMMISSION IN EACH OF THE ABOVE-CAPTIONED CASES THAT:**
