- Alabama declined a second time to enter into agreements for sharing SNAP and TANF data with no reason given in October 2016. Discussions first occurred from Jan 2014-Dec 2015. In Dec 2015, the state declined the first time citing no reason. Discussions resumed in the summer of 2016, and the second declination followed a few months later. During the lengthy discussions, the questions from the state focused around data security and data confidentiality, especially regarding potential data breaches.

After graduating from Auburn University in 1967, Kay worked as a high school teacher and a bank officer. She served as Reading Clerk of the Alabama House of Representatives under Speaker Joseph C. McCorquodale and was Assistant Director of the Alabama Development Office, where she worked to spur job creation and economic development across the state.

In 2002, Kay became the first Republican elected State Treasurer since Reconstruction and she was re-elected in 2006. As Treasurer, Kay was committed to making the office more open, transparent, and efficient. Kay was elected Lieutenant Governor in 2010, becoming the first Republican woman to hold the office in Alabama's history.

She again made history on November 4, 2014, by becoming the first Republican Lieutenant Governor re-elected to the office. The Lieutenant Governor's primary Constitutional duty is to preside over legislative proceedings of the upper house as President of the Senate.

Kay has been honored to receive numerous awards for her service to the State of Alabama, including the 2015 ALFA Service to Agriculture Award, Newmax's 50 Most Influential Female Republicans in the country and, most recently, the American Institute of Aeronautics and Astronautics (AIAA) 2016 Public Service Award; 2017 Citizen of the Year, by River Region Living Magazine.

On April 10, 2017, Kay was sworn in as the 54th Governor of the State of Alabama in the Old Senate Chamber in the Alabama State Capitol by Acting Chief Justice Lyn Stuart. Following a successful nineteen months in office, the people of Alabama made history again in November 2018 by electing Governor Ivey to a full term. She is the first Lt. Governor of Alabama elected to a full term after taking over as governor due to a vacancy in the governor's office.

On January 14, 2019, Governor Ivey was officially sworn in for her full term by Associate Justice Will Sellers. Kay will continue to bring conservative leadership with effective results to make this generation more productive and the next generation more prosperous.

She is a member of the First Baptist Church of Montgomery, the Montgomery Rotary Club, and the Board of Directors of the Montgomery YMCA. Kay is also the first Girls State alumnus to be elected to an Alabama Constitutional Office.

Phil Bryant was sworn in for his second term as Mississippi's 64th governor on January 12, 2016. Before becoming the state's chief executive, Bryant was lieutenant governor from 2008-2011. He also served as state auditor and represented his legislative district in the Mississippi House of Representatives for five years.

The Moorhead native earned an associate's degree in criminal justice from Hinds Community College and completed his bachelor's degree at the University of Southern Mississippi. He holds a master's degree in political science from Mississippi College, and before assuming his role as governor, Bryant served as an adjunct professor of government there.

Gov. Bryant began his career as a deputy sheriff in Hinds County and later worked as an insurance investigator before being elected to the House of Representatives in 1991. In 1996, then Gov. Kirk Fordice appointed him state auditor, a position he was re-elected to in 1999 and 2003.

He is also an avid outdoorsman and is a longtime member of the National Rifle Association's Institute for Legislative Action.

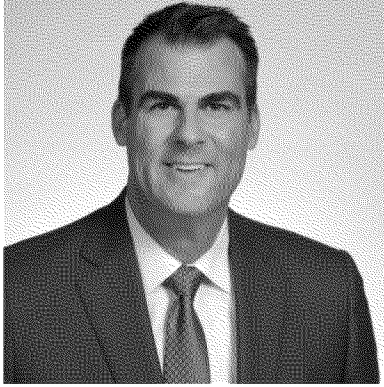

J. Kevin Stitt is the 28th governor of Oklahoma. Stitt is leading the state with a vision to become Top Ten in critical categories, from government efficiency to job growth, infrastructure, education, and healthcare.

Governor Stitt is an Oklahoman entrepreneur and businessman who founded a mortgage company, Gateway, in 2000 with \$1,000 and a computer. By delivering strong leadership and vision, Stitt grew Gateway into a nationwide mortgage company that today employs 1,200 people, has 164 field offices in 41 states, and holds a loan servicing portfolio of more than \$16 billion.

Governor Stitt is a fourth-generation Oklahoman, raised in Norman where his dad was a pastor of a Bible church and spent many summers as a youth in Skiatook where his grandfather owned a dairy farm. 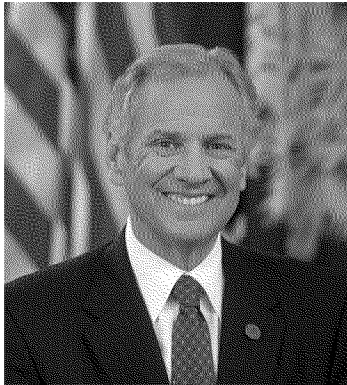

Background of the Honorable Henry McMaster (R-South Carolina)

McMaster was the first U.S. attorney appointed by President Ronald Reagan, and was unanimously confirmed by the United States Senate. During his tenure as U.S. Attorney, his “Operation Jackpot” investigation into international drug smuggling produced over 100 convictions in South Carolina.

As attorney general, McMaster made prosecution of criminal domestic violence a priority and harnessed the resources of law enforcement and prosecutors to crack down on child Internet predators. He extended the state grand jury’s jurisdiction to environmental and gang crimes and broadened its authority to include securities crimes following the collapse of Carolina Investors and Home Gold, convicting those responsible.

In 2003, McMaster issued a landmark opinion to protect our marsh islands from encroachment and later won the Life Sciences Act case in the South Carolina Supreme Court, which enhanced the state’s economic potential through its universities for research, development and investment in the knowledge-based economy.

As lieutenant governor, McMaster served as president of the South Carolina State Senate and headed the Lieutenant Governor’s Office on Aging. McMaster was chairman of the South Carolina Republican Party from 1993-2002, winning reelection three times.

He is admitted to practice in all courts, state and federal, in South Carolina, as well as the U.S. Court of Claims (1974), the U.S. Court of Appeals for the Fourth Circuit (1975) and the Supreme Court of the United States (1978).

Governor McMaster is a recipient of the Order of the Palmetto, the highest civilian honor in the state, and was named “Public Servant of the Year” by the Sierra Club and “National Law Enforcement Officer of the Year” by The Humane Society of the United States.

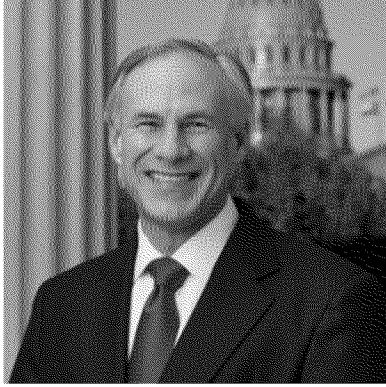

Other notable successes include protecting free speech on campus, ensuring medical care for babies born alive after attempted abortions, banning red light cameras and more—all of which were accomplished in a 140-day session noted for its bold ideas and collaboration.

These successes build on Governor Abbott's prior legislative victories making Texas even freer, stronger, safer and smarter: investing in critical border security; reforming the child protective system; investing more in early and higher education; cutting billions in taxes to stimulate job growth; reining in regulatory regimes that strangle innovation; improving Texas roads; and expanding protection of Texans' constitutional rights.

Before his election in 2014, Greg Abbott was the 50th and longest-serving Attorney General of Texas, where he earned a national reputation for defending religious liberty and protecting Texas communities and children. He also previously served as a Justice on the Texas Supreme Court and as a State District Judge in Harris County.

A native Texan and avid sportsman and hunter, Governor Abbott was born in Wichita Falls and raised in Duncanville. After graduating from The University of Texas at Austin, he earned a law degree from Vanderbilt University Law School. Shortly after graduating from law school, he was partially paralyzed by a falling tree while jogging.

Governor Abbott and his wife, Cecilia, a former teacher and principal, and the first Hispanic First Lady of Texas, were married in 1981. Their daughter, Audrey, is a recent college graduate.

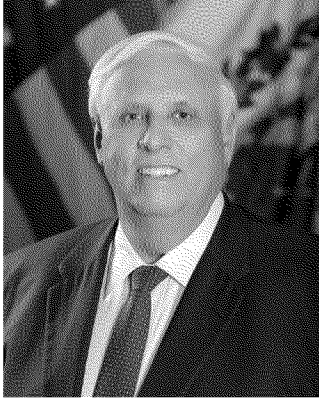

James C. Justice, II was born April 27, 1951, to James Conley Justice and Edna Ruth Justice. He attended Raleigh County public schools and graduated from Woodrow Wilson High School in 1969, attended Greenbrier Military Academy as a post graduate. Governor Justice went to Marshall University in Huntington, West Virginia, and was captain of the golf team for two years before earning his undergraduate degree and a Masters in Business Administration.

The Governor joined his family's business in 1976. Because of his strong interest in nature and the outdoors, he started Justice Family Farms in 1977 in beautiful Monroe County, West Virginia. Under his direction, Justice Farming Operations has grown to be a major agricultural enterprise. His companies farm more than 50,000 acres of corn, wheat, and soybeans in West Virginia, Virginia, North Carolina and South Carolina.

Gov. Justice is the largest farmer east of the Mississippi River. He is a long-time member of the National Corn Growers Association and a seven-time national corn growing champion. Jim, a passionate sportsman himself, developed Stoney Brook Plantation, a 15,000-acre hunting and fishing preserve in Monroe County, West Virginia. In 2016 Jim and his great bird dog companion, Lilly, bagged 73 grouse in our Mountain State.

Upon the death of his father in 1993, Jim became the President and CEO of Bluestone Industries, Inc. and Bluestone Coal Corporation. Over the next 15 years, Jim launched a massive expansion of multiple businesses which included significant coal reserve expansion, Christmas tree farms, cotton gins, turfgrass operations, golf courses, timber enhancement and land projects just to mention a few. Before being elected governor, Jim was the president and CEO of 102 different companies.

Governor Justice spent his career creating thousands of jobs and understands how to put people to work.

During late 2008 and early 2009, Jim successfully negotiated the sale of Bluestone Industries, Inc. and affiliated companies, which comprised all of the family's West Virginia coal mines at the time,

to Mechel, OAO, one of Russia's leading mining and metal companies. The Russian company failed, laid off coal miners, and was going to walk on their financial obligations.

In 2015, Jim reacquired all of these Bluestone assets back from Mechel and, in a short time, reopened most of the mines and created more than 200 new mining jobs. Had Mr. Justice not stepped up, these mines would have stayed closed, back taxes would not have been paid, and UMWA pensioners would have been left in the cold.

In 2009, Justice rescued The Greenbrier resort in White Sulphur Springs, West Virginia, from bankruptcy. The workforce was facing deep cuts in jobs and benefits. Immediately after purchasing The Greenbrier, Jim Justice reversed many of the benefit cuts and invested in renovations and expansions. He brought major events like the PGA Tour, training camps for the NFL and NBA, and countless high-profile acts and conferences to The Greenbrier. As governor, he wants to do everything possible to put West Virginia in a positive light.

Justice saw an opportunity to grow tourism in Raleigh County so he acquired The Resort at Glade Springs, Black Knight Country Club, and Brier Patch Golf Links.

Governor Justice thinks big. In 2015, he started building a \$1 billion dollar mountain complex with housing, skiing, and a championship golf course to bring the U.S. Open to West Virginia. It's history in the making -- something that has never been done before— a golf course designed by Gary Player, the late Arnold Palmer, Lee Trevino, and Jack Nicklaus, all in our great state. The Greenbrier is where Arnie got his first professional check and will be where he designed his last course.

Jim has carried on his family's tradition of being major supporters of youth programs in Southern West Virginia. Since 1992 he has been President of Beckley Little League. His participation has helped the program expand to over 1,000 kids playing on 80 teams. He has coached basketball teams of all ages for the past 36 years and is currently the head girls and boys basketball coach at Greenbrier East High School in Lewisburg, WV. On November 29, 2016, Jim was honored when he coached his 1,000th career win in basketball.

As part of his involvement with the West Virginia Coal Association in the early 1990's, Jim became Tournament Director of the Mountain State Coal Classic Basketball Tournament. The Classic was moved to Beckley and has enjoyed tremendous success by awarding hundreds of thousands of dollars in scholarships and direct support to participating schools. Jim used his contacts to bring sports greats to Beckley as guest speakers for the Classic, including: Hot Rod Hundley, Terry Bradshaw, Dick Vitale, Jerry West, Joe Theismann, Kareem Abdul-Jabbar, Dr. "J" Julius Erving, Bo Jackson, Bob Pruett, Don Nehlen, Doc Holliday, Rich Rodriguez, Chad Pennington, Lou Holtz, Larry Bird, Bill Walton, John Elway, Bill Stewart, Shaq, Charles Barkley, Tim Tebow, Denny Hamlin, Sean Payton, Cam Newton and Pat White. The Tournament, now known as The Big Atlantic Classic has become even bigger and better.

Giving back to the community is at the core of who the governor is. He is guided by his commitment to the Good Lord, his family, and helping West Virginia's youth. Every Christmas, Jim puts on his custom made Santa Claus suit and visits local churches to give away \$1 million in gifts to children in need.

Jim was the 1998 Recipient of the Beckley-Raleigh County Chamber of Commerce's Community Service Award as a result of his involvement with youth programs in the area, the 1998 Recipient of the "Spirit of Beckley" Award from the Beckley-Raleigh County YMCA, the 2000 recipient of

the City of Hope Medical Center's "Spirit of Life" award, the 2009 Charleston Gazette's "West Virginian of the Year". In 2010, he was named a "Distinguished West Virginian" by Governor (now Senator) Joe Manchin and the 2011 Honoree at the National Multiple Sclerosis Society's Blue Ridge Chapter "Dinner of Champions". Jim was chosen Mountain Athletic Conference "Coach of the Year" and West Virginia High School "Coach of the Year" in 2012 and was named "West Virginian of the Year" in 2014 and again in 2016 by the Clarksburg Exponent Telegram.

In May 2015, Jim announced his campaign to seek the office of governor of West Virginia. After 19 months on the campaign trail sharing his vision for transforming West Virginia, Jim was elected the 36th governor of West Virginia. He won with a broad coalition of support from Democrats, Republicans, and Independents.

Jim and his wife Cathy have been best friends since high school. Last year, they celebrated their 40th anniversary.

The Governor and the First Lady have two children, James (Jay) C. Justice, III, a Virginia Tech graduate who runs the Justice family's coal and agriculture operations, and Dr. Jill Justice, a graduate of Marshall University and The Edward Via Virginia College of Osteopathic Medicine in Blacksburg, VA. After graduating from Auburn University in 1967, Kay worked as a high school teacher and a bank officer. She served as Reading Clerk of the Alabama House of Representatives under Speaker Joseph C. McCorquodale and was Assistant Director of the Alabama Development Office, where she worked to spur job creation and economic development across the state.

In 2002, Kay became the first Republican elected State Treasurer since Reconstruction and she was re-elected in 2006. As Treasurer, Kay was committed to making the office more open, transparent, and efficient. Kay was elected Lieutenant Governor in 2010, becoming the first Republican woman to hold the office in Alabama's history.

She again made history on November 4, 2014, by becoming the first Republican Lieutenant Governor re-elected to the office. The Lieutenant Governor's primary Constitutional duty is to preside over legislative proceedings of the upper house as President of the Senate.

Kay has been honored to receive numerous awards for her service to the State of Alabama, including the 2015 ALFA Service to Agriculture Award, Newmax's 50 Most Influential Female Republicans in the country and, most recently, the American Institute of Aeronautics and Astronautics (AIAA) 2016 Public Service Award; 2017 Citizen of the Year, by River Region Living Magazine.

McMaster was the first U.S. attorney appointed by President Ronald Reagan, and was unanimously confirmed by the United States Senate. During his tenure as U.S. Attorney, his "Operation Jackpot"

investigation into international drug smuggling produced over 100 convictions in South Carolina.

As attorney general, McMaster made prosecution of criminal domestic violence a priority and harnessed the resources of law enforcement and prosecutors to crack down on child Internet predators. He extended the state grand jury's jurisdiction to environmental and gang crimes and broadened its authority to include securities crimes following the collapse of Carolina Investors and Home Gold, convicting those responsible.

In 2003, McMaster issued a landmark opinion to protect our marsh islands from encroachment and later won the Life Sciences Act case in the South Carolina Supreme Court, which enhanced the state's economic potential through its universities for research, development and investment in the knowledge-based economy.

As lieutenant governor, McMaster served as president of the South Carolina State Senate and headed the Lieutenant Governor's Office on Aging. McMaster was chairman of the South Carolina Republican Party from 1993-2002, winning reelection three times.

He is admitted to practice in all courts, state and federal, in South Carolina, as well as the U.S. Court of Claims (1974), the U.S. Court of Appeals for the Fourth Circuit (1975) and the Supreme Court of the United States (1978).

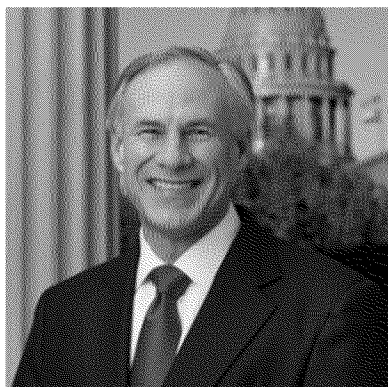

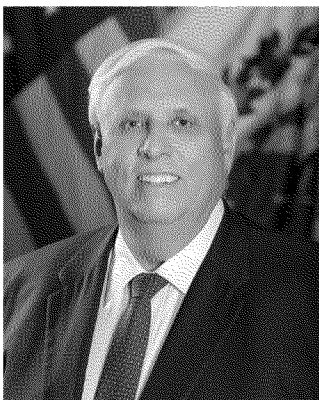

James C. Justice, II was born April 27, 1951, to James Conley Justice and Edna Ruth Justice. He attended Raleigh County public schools and graduated from Woodrow Wilson High School in 1969, attended Greenbrier Military Academy as a post graduate. Governor Justice went to Marshall University in Huntington, West Virginia, and was captain of the golf team for two years before earning his undergraduate degree and a Masters in Business Administration.

The Governor joined his family's business in 1976. Because of his strong interest in nature and the outdoors, he started Justice Family Farms in 1977 in beautiful Monroe County, West Virginia. Under his direction, Justice Farming Operations has grown to be a major agricultural enterprise. His companies farm more than 50,000 acres of corn, wheat, and soybeans in West Virginia, Virginia, North Carolina and South Carolina.

Gov. Justice is the largest farmer east of the Mississippi River. He is a long-time member of the National Corn Growers Association and a seven-time national corn growing champion. Jim, a passionate sportsman himself, developed Stoney Brook Plantation, a 15,000-acre hunting and fishing preserve in Monroe County, West Virginia. In 2016 Jim and his great bird dog companion, Lilly, bagged 73 grouse in our Mountain State.

Upon the death of his father in 1993, Jim became the President and CEO of Bluestone Industries, Inc. and Bluestone Coal Corporation. Over the next 15 years, Jim launched a massive expansion of multiple businesses which included significant coal reserve expansion, Christmas tree farms, cotton gins, turfgrass operations, golf courses, timber enhancement and land projects just to mention a few. Before being elected governor, Jim was the president and CEO of 102 different companies.

Governor Justice spent his career creating thousands of jobs and understands how to put people to work.

During late 2008 and early 2009, Jim successfully negotiated the sale of Bluestone Industries, Inc. and affiliated companies, which comprised all of the family's West Virginia coal mines at the time, to Mechel, OAO, one of Russia's leading mining and metal companies. The Russian company failed, laid off coal miners, and was going to walk on their financial obligations.

In 2015, Jim reacquired all of these Bluestone assets back from Mechel and, in a short time, reopened most of the mines and created more than 200 new mining jobs. Had Mr. Justice not stepped up, these mines would have stayed closed, back taxes would not have been paid, and UMW pensioners would have been left in the cold.

In 2009, Justice rescued The Greenbrier resort in White Sulphur Springs, West Virginia, from bankruptcy. The workforce was facing deep cuts in jobs and benefits. Immediately after purchasing The Greenbrier, Jim Justice reversed many of the benefit cuts and invested in renovations and expansions. He brought major events like the PGA Tour, training camps for the NFL and NBA, and countless high-profile acts and conferences to The Greenbrier. As governor, he wants to do everything possible to put West Virginia in a positive light.

Justice saw an opportunity to grow tourism in Raleigh County so he acquired The Resort at Glade Springs, Black Knight Country Club, and Brier Patch Golf Links.

Governor Justice thinks big. In 2015, he started building a \$1 billion dollar mountain complex with housing, skiing, and a championship golf course to bring the U.S. Open to West Virginia. It's history in the making -- something that has never been done before— a golf course designed

by Gary Player, the late Arnold Palmer, Lee Trevino, and Jack Nicklaus, all in our great state. The Greenbrier is where Arnie got his first professional check and will be where he designed his last course.

Jim has carried on his family's tradition of being major supporters of youth programs in Southern West Virginia. Since 1992 he has been President of Beckley Little League. His participation has helped the program expand to over 1,000 kids playing on 80 teams. He has coached basketball teams of all ages for the past 36 years and is currently the head girls and boys basketball coach at Greenbrier East High School in Lewisburg, WV. On November 29, 2016, Jim was honored when he coached his 1,000th career win in basketball.

As part of his involvement with the West Virginia Coal Association in the early 1990's, Jim became Tournament Director of the Mountain State Coal Classic Basketball Tournament. The Classic was moved to Beckley and has enjoyed tremendous success by awarding hundreds of thousands of dollars in scholarships and direct support to participating schools. Jim used his contacts to bring sports greats to Beckley as guest speakers for the Classic, including: Hot Rod Hundley, Terry Bradshaw, Dick Vitale, Jerry West, Joe Theismann, Kareem Abdul-Jabbar, Dr. "J" Julius Erving, Bo Jackson, Bob Pruett, Don Nehlen, Doc Holliday, Rich Rodriguez, Chad Pennington, Lou Holtz, Larry Bird, Bill Walton, John Elway, Bill Stewart, Shaq, Charles Barkley, Tim Tebow, Denny Hamlin, Sean Payton, Cam Newton and Pat White. The Tournament, now known as The Big Atlantic Classic has become even bigger and better.

Giving back to the community is at the core of who the governor is. He is guided by his commitment to the Good Lord, his family, and helping West Virginia's youth. Every Christmas, Jim puts on his custom made Santa Claus suit and visits local churches to give away \$1 million in gifts to children in need.

Jim was the 1998 Recipient of the Beckley-Raleigh County Chamber of Commerce's Community Service Award as a result of his involvement with youth programs in the area, the 1998 Recipient of the "Spirit of Beckley" Award from the Beckley-Raleigh County YMCA, the 2000 recipient of the City of Hope Medical Center's "Spirit of Life" award, the 2009 Charleston Gazette's "West Virginian of the Year". In 2010, he was named a "Distinguished West Virginian" by Governor (now Senator) Joe Manchin and the 2011 Honoree at the National Multiple Sclerosis Society's Blue Ridge Chapter "Dinner of Champions". Jim was chosen Mountain Athletic Conference "Coach of the Year" and West Virginia High School "Coach of the Year" in 2012 and was named "West Virginian of the Year" in 2014 and again in 2016 by the Clarksburg Exponent Telegram.

In May 2015, Jim announced his campaign to seek the office of governor of West Virginia. After 19 months on the campaign trail sharing his vision for transforming West Virginia, Jim was elected the 36th governor of West Virginia. He won with a broad coalition of support from Democrats, Republicans, and Independents.

Jim and his wife Cathy have been best friends since high school. Last year, they celebrated their 40th anniversary.

The Governor and the First Lady have two children, James (Jay) C. Justice, III, a Virginia Tech graduate who runs the Justice family's coal and agriculture operations, and Dr. Jill Justice, a graduate of Marshall University and The Edward Via Virginia College of Osteopathic Medicine in Blacksburg, VA. 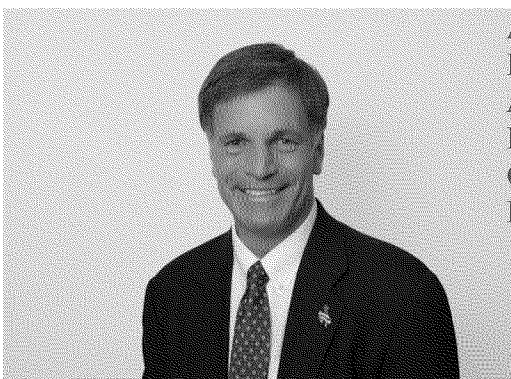

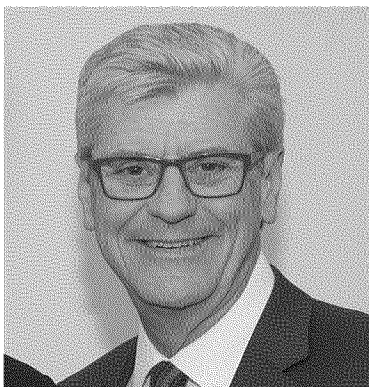

After graduating from Auburn University in 1967, Kay worked as a high school teacher and a bank officer. She served as Reading Clerk of the Alabama House of Representatives under Speaker Joseph C. McCorquodale and was Assistant Director of the Alabama Development Office, where she worked to spur job creation and economic development across the state.

In 2002, Kay became the first Republican elected State Treasurer since Reconstruction and she was re-elected in 2006. As Treasurer, Kay was committed to making the office more open, transparent, and efficient. Kay was elected Lieutenant Governor in 2010, becoming the first Republican woman to hold the office in Alabama's history.

She again made history on November 4, 2014, by becoming the first Republican Lieutenant Governor re-elected to the office. The Lieutenant Governor's primary Constitutional duty is to preside over legislative proceedings of the upper house as President of the Senate.

Kay has been honored to receive numerous awards for her service to the State of Alabama, including the 2015 ALFA Service to Agriculture Award, Newmax's 50 Most Influential Female Republicans in the country and, most recently, the American Institute of Aeronautics and Astronautics (AIAA) 2016 Public Service Award; 2017 Citizen of the Year, by River Region Living Magazine.

On April 10, 2017, Kay was sworn in as the 54th Governor of the State of Alabama in the Old Senate Chamber in the Alabama State Capitol by Acting Chief Justice Lyn Stuart. Following a successful nineteen months in office, the people of Alabama made history again in November 2018 by electing Governor Ivey to a full term. She is the first Lt. Governor of Alabama elected to a full term after taking over as governor due to a vacancy in the governor's office.

On January 14, 2019, Governor Ivey was officially sworn in for her full term by Associate Justice Will Sellers. Kay will continue to bring conservative leadership with effective results to make this generation more productive and the next generation more prosperous.

She is a member of the First Baptist Church of Montgomery, the Montgomery Rotary Club, and the Board of Directors of the Montgomery YMCA. Kay is also the first Girls State alumnus to be elected to an Alabama Constitutional Office.

McMaster was the first U.S. attorney appointed by President Ronald Reagan, and was unanimously confirmed by the United States Senate. During his tenure as U.S. Attorney, his “Operation Jackpot” investigation into international drug smuggling produced over 100 convictions in South Carolina.

As attorney general, McMaster made prosecution of criminal domestic violence a priority and harnessed the resources of law enforcement and prosecutors to crack down on child Internet predators. He extended the state grand jury’s jurisdiction to environmental and gang crimes and broadened its authority to include securities crimes following the collapse of Carolina Investors and Home Gold, convicting those responsible.

In 2003, McMaster issued a landmark opinion to protect our marsh islands from encroachment and later won the Life Sciences Act case in the South Carolina Supreme Court, which enhanced the state’s economic potential through its universities for research, development and investment in the knowledge-based economy.

As lieutenant governor, McMaster served as president of the South Carolina State Senate and headed the Lieutenant Governor’s Office on Aging. McMaster was chairman of the South Carolina Republican Party from 1993-2002, winning reelection three times.

He is admitted to practice in all courts, state and federal, in South Carolina, as well as the U.S. Court of Claims (1974), the U.S. Court of Appeals for the Fourth Circuit (1975) and the Supreme Court of the United States (1978).

Governor McMaster is a recipient of the Order of the Palmetto, the highest civilian honor in the state, and was named “Public Servant of the Year” by the Sierra Club and “National Law Enforcement Officer of the Year” by The Humane Society of the United States.

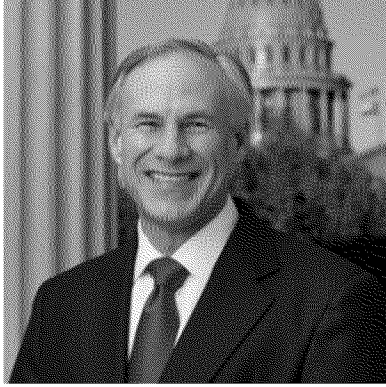

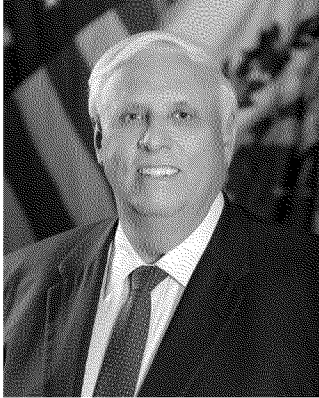

James C. Justice, II was born April 27, 1951, to James Conley Justice and Edna Ruth Justice. He attended Raleigh County public schools and graduated from Woodrow Wilson High School in 1969, attended Greenbrier Military Academy as a post graduate. Governor Justice went to Marshall University in Huntington, West Virginia, and was captain of the golf team for two years before earning his undergraduate degree and a Masters in Business Administration.

The Governor joined his family's business in 1976. Because of his strong interest in nature and the outdoors, he started Justice Family Farms in 1977 in beautiful Monroe County, West Virginia. Under his direction, Justice Farming Operations has grown to be a major agricultural enterprise. His companies farm more than 50,000 acres of corn, wheat, and soybeans in West Virginia, Virginia, North Carolina and South Carolina.

Gov. Justice is the largest farmer east of the Mississippi River. He is a long-time member of the National Corn Growers Association and a seven-time national corn growing champion. Jim, a passionate sportsman himself, developed Stoney Brook Plantation, a 15,000-acre hunting and fishing preserve in Monroe County, West Virginia. In 2016 Jim and his great bird dog companion, Lilly, bagged 73 grouse in our Mountain State.

Upon the death of his father in 1993, Jim became the President and CEO of Bluestone Industries, Inc. and Bluestone Coal Corporation. Over the next 15 years, Jim launched a massive expansion of multiple businesses which included significant coal reserve expansion, Christmas tree farms, cotton gins, turfgrass operations, golf courses, timber enhancement and land projects just to mention a few. Before being elected governor, Jim was the president and CEO of 102 different companies.

Governor Justice spent his career creating thousands of jobs and understands how to put people to work.

During late 2008 and early 2009, Jim successfully negotiated the sale of Bluestone Industries, Inc. and affiliated companies, which comprised all of the family's West Virginia coal mines at the time,

to Mechel, OAO, one of Russia's leading mining and metal companies. The Russian company failed, laid off coal miners, and was going to walk on their financial obligations.

In 2015, Jim reacquired all of these Bluestone assets back from Mechel and, in a short time, reopened most of the mines and created more than 200 new mining jobs. Had Mr. Justice not stepped up, these mines would have stayed closed, back taxes would not have been paid, and UMWA pensioners would have been left in the cold.

In 2009, Justice rescued The Greenbrier resort in White Sulphur Springs, West Virginia, from bankruptcy. The workforce was facing deep cuts in jobs and benefits. Immediately after purchasing The Greenbrier, Jim Justice reversed many of the benefit cuts and invested in renovations and expansions. He brought major events like the PGA Tour, training camps for the NFL and NBA, and countless high-profile acts and conferences to The Greenbrier. As governor, he wants to do everything possible to put West Virginia in a positive light.

Justice saw an opportunity to grow tourism in Raleigh County so he acquired The Resort at Glade Springs, Black Knight Country Club, and Brier Patch Golf Links.

Governor Justice thinks big. In 2015, he started building a \$1 billion dollar mountain complex with housing, skiing, and a championship golf course to bring the U.S. Open to West Virginia. It's history in the making -- something that has never been done before— a golf course designed by Gary Player, the late Arnold Palmer, Lee Trevino, and Jack Nicklaus, all in our great state. The Greenbrier is where Arnie got his first professional check and will be where he designed his last course.

Jim has carried on his family's tradition of being major supporters of youth programs in Southern West Virginia. Since 1992 he has been President of Beckley Little League. His participation has helped the program expand to over 1,000 kids playing on 80 teams. He has coached basketball teams of all ages for the past 36 years and is currently the head girls and boys basketball coach at Greenbrier East High School in Lewisburg, WV. On November 29, 2016, Jim was honored when he coached his 1,000th career win in basketball.

As part of his involvement with the West Virginia Coal Association in the early 1990's, Jim became Tournament Director of the Mountain State Coal Classic Basketball Tournament. The Classic was moved to Beckley and has enjoyed tremendous success by awarding hundreds of thousands of dollars in scholarships and direct support to participating schools. Jim used his contacts to bring sports greats to Beckley as guest speakers for the Classic, including: Hot Rod Hundley, Terry Bradshaw, Dick Vitale, Jerry West, Joe Theismann, Kareem Abdul-Jabbar, Dr. "J" Julius Erving, Bo Jackson, Bob Pruett, Don Nehlen, Doc Holliday, Rich Rodriguez, Chad Pennington, Lou Holtz, Larry Bird, Bill Walton, John Elway, Bill Stewart, Shaq, Charles Barkley, Tim Tebow, Denny Hamlin, Sean Payton, Cam Newton and Pat White. The Tournament, now known as The Big Atlantic Classic has become even bigger and better.

Giving back to the community is at the core of who the governor is. He is guided by his commitment to the Good Lord, his family, and helping West Virginia's youth. Every Christmas, Jim puts on his custom made Santa Claus suit and visits local churches to give away \$1 million in gifts to children in need.

Jim was the 1998 Recipient of the Beckley-Raleigh County Chamber of Commerce's Community Service Award as a result of his involvement with youth programs in the area, the 1998 Recipient of the "Spirit of Beckley" Award from the Beckley-Raleigh County YMCA, the 2000 recipient of

the City of Hope Medical Center's "Spirit of Life" award, the 2009 Charleston Gazette's "West Virginian of the Year". In 2010, he was named a "Distinguished West Virginian" by Governor (now Senator) Joe Manchin and the 2011 Honoree at the National Multiple Sclerosis Society's Blue Ridge Chapter "Dinner of Champions". Jim was chosen Mountain Athletic Conference "Coach of the Year" and West Virginia High School "Coach of the Year" in 2012 and was named "West Virginian of the Year" in 2014 and again in 2016 by the Clarksburg Exponent Telegram.

In May 2015, Jim announced his campaign to seek the office of governor of West Virginia. After 19 months on the campaign trail sharing his vision for transforming West Virginia, Jim was elected the 36th governor of West Virginia. He won with a broad coalition of support from Democrats, Republicans, and Independents.

Jim and his wife Cathy have been best friends since high school. Last year, they celebrated their 40th anniversary.

The Governor and the First Lady have two children, James (Jay) C. Justice, III, a Virginia Tech graduate who runs the Justice family's coal and agriculture operations, and Dr. Jill Justice, a graduate of Marshall University and The Edward Via Virginia College of Osteopathic Medicine in Blacksburg, VA. Jill is now president of Greenbrier Hotel Corporation and practices at the Greenbrier Clinic.

The Justice family has recently grown to include Jay's wife, Catherine Grainger Justice, and Jill's husband, Adam Long. Jim and Cathy live near downtown Lewisburg with Lucy, their Boston Terrier.
