Indra K. Nooyi

Chairman and Chief Executive Officer, PepsiCo

Indra Nooyi is Chairman and Chief Executive Officer of PepsiCo, which has the world's largest portfolio of billion-dollar food and beverage brands, including 19 different product lines that each generate more than \$1 billion in annual retail sales. With nearly \$60 billion in revenue, PepsiCo employs 285,000 people worldwide.

Mrs. Nooyi is the chief architect of PepsiCo's multi-year growth strategy, Performance with Purpose, which is focused on delivering sustainable growth by investing in a healthier future for people and our planet. Performance with Purpose encompasses PepsiCo's commitment to continue to build a portfolio of enjoyable and wholesome foods and beverages, find innovative ways to reduce the use of energy, water and packaging and provide a great workplace for our employees. In keeping with this growth strategy, PepsiCo is proud to be listed on the Dow Jones North America Sustainability Index and Dow Jones World Sustainability Index.

Mrs. Nooyi was named President and CEO on October 1, 2006 and assumed the role of Chairman on May 2, 2007. Prior to becoming CEO, Mrs. Nooyi served as President and Chief Financial Officer beginning in 2001, when she was also named to PepsiCo's Board of Directors. Between February 2000 and April 2001, Mrs. Nooyi was Senior Vice President and Chief Financial Officer of PepsiCo. Between 1996 and 1999, Mrs. Nooyi was Senior Vice President of Corporate Strategy and Development.

Before joining PepsiCo in 1994, Mrs. Nooyi worked with Asea Brown Boveri, a Zurich-based industrial company, Motorola, The Boston Consulting Group, Johnson & Johnson and Mettur Beardsell, Ltd., a textile firm.

In addition to being a member of the PepsiCo Board of Directors, Mrs. Nooyi serves as a member of the boards of U.S.-China Business Council, U.S.-India Business Council, The Consumer Goods Forum, Catalyst, Lincoln Center for the Performing Arts, The Peterson Institute for International Economics and Grocery Manufacturers Association and the U.S. Soccer Federation. She is also a Successor Fellow of Yale Corporation and was appointed to the U.S.-India CEO Forum by the Obama Administration.

She holds a BS from Madras Christian College, an MBA from the Indian Institute of Management in Calcutta and a Master of Public and Private Management from Yale University. Mrs. Nooyi is married and has two daughters.



Honorable Cory A. Booker, Mayor

City of Newark

The Honorable Cory A. Booker, 41, is the Mayor of Newark, New Jersey. He took the oath of office as Mayor of New Jersey's largest city on July 1, 2006 following a sweeping electoral victory and was re-elected to a second term on May 11, 2010.

Elected with a clear mandate for change, Mayor Booker has begun work on realizing a bold vision for the city. Newark's mission is to set a national standard for urban transformation by marshalling its resources to achieve security, economic abundance and an environment that is nurturing and empowering for individuals and families.

Mayor Booker and his Administration have made meaningful strides towards achieving the City's mission. On April 1, 2010, the City of Newark experienced its first homicide-free month in more than forty years and was recognized in July 2008 for leading the nation among large cities for reductions in shootings and murders, achieving decreases of more than 40% reductions in both categories. Radical transformation of the Newark Police Department under Mayor Booker's leadership, together with the deployment of over 100 surveillance cameras throughout City, has led to Newark setting the nationwide pace for crime reduction.

Among other recent notable achievements under Mayor Booker's leadership, the City of Newark has committed to a \$40 million transformation of the City's parks and playgrounds through a ground-breaking public/private partnership. The Booker Administration has also doubled affordable housing production.

Mayor Booker's political career began in 1998, after serving as Staff Attorney for the Urban Justice Center in Newark. He rose to prominence as Newark's Central Ward Councilman. During his four years of service from 1998–2002, then-Councilman Booker earned a reputation as a leader with innovative ideas and bold actions, from increasing security in public housing to building new playgrounds. This work was the foundation for his leadership as Mayor. For this work, he has been recognized in numerous publications, including, among others, *Time*, *Esquire*, *New Jersey Monthly* (naming him as one of New Jersey's top 40 under 40), *Black Enterprise* (naming him to the Hot List, America's Most Powerful Players under 40) and *The New York Times Magazine*.

Reflecting his commitment to education, Mayor Booker is a member of numerous boards and advisory committees including Democrats for Education Reform, Columbia University Teachers' College Board of Trustees and the Black Alliance for Educational Options. Mayor Booker received his BA and MA from Stanford University, a BA in Modern History at Oxford University as a Rhodes Scholar, and completed his law degree at Yale University.



Patricia Bauman & The Hon. John Landrum Bryant

Patricia Bauman is President and Co-Director of the Bauman Foundation, which supports public policy and advocacy with particular emphasis on civic participation and election reform as well as environmental issues.

Ms. Bauman is on the Board of Directors of the Brennan Center for Justice. She is a Vice-Chair of the Board of Trustees at the Natural Resources Defense Council, and a member of the Board of Montefiore Medical Center. She is a graduate of Radcliffe College and the Columbia University School of Public Health, and earned her JD degree from the Georgetown University Law Center.

The Hon. John Landrum Bryant is a designer of jewelry, furniture, lighting and objects for the home and bath. A graduate of the University of Virginia and the Georgetown University Law Center, he is Co-Director of the Bauman Foundation. Earlier, he was President of the National Park Foundation.

Mr. Effron received his AB from Princeton University and MBA from Columbia University. He is married to Cheryl Cohen Effron and is the father of one son and two daughters.

He headed BCG's Americas region from 1991 to 1997. In 1997, Mr. Stern was elected president and CEO, a position that he held from 1998 through 2003. He has since served as chairman of the board.

Mr. Stern remains active in client service, assisting a number of global companies—consumer, industrial, and financial—in developing competitive strategies for their businesses and in shaping their corporate portfolios. He spends a quarter of each year in Asia. Mr. Stern has published several articles in BCG's widely read *Perspectives* series and is co-author of *The Boston Consulting Group on Strategy*.

Mr. Stern serves on the boards of the Initiative for a Competitive Inner City and the Friends of the World Food Program. He is a trustee or member of several organizations; among them are the Chicago Symphony Orchestra, Rush University Medical Center, the Civic Committee of The Commercial Club of Chicago, and the Chicago Club.

Prior to joining BCG, Mr. Stern served in the U.S. Navy as a lieutenant. He graduated from Harvard, *cum laude*, with a BA in economics. He earned an MBA from the Stanford Graduate School of Business in 1974.

James E. Johnson

Chair

James E. Johnson is Chair of the Brennan Center and a Partner at Debevoise & Plimpton representing individuals and corporations in connection with a wide variety of regulatory, enforcement and Congressional matters. He has also been co-counsel in several of the Brennan Center's high profile voting cases. He served as Under Secretary of the Treasury for Enforcement and Assistant Secretary of the Treasury for Enforcement, prior to which he was an Assistant U.S. Attorney for the Southern District of New York. Mr. Johnson was appointed chairman of the New Jersey Advisory Committee on Police Standards by Governor Corzine in August 2006. His Committee's recommendations have been codified in a pathbreaking law: The Law Enforcement Professional Standards Act of 2009. In August 2009, he was appointed monitor to oversee the consent decree intended to promote fair and affordable housing in Westchester. Mr. Johnson clerked for the Hon. Robert E. Keeton, U.S. District Court for the District of Massachusetts. He received his JD *cum laude* from Harvard Law School and received his AB *cum laude* from Harvard College



Wendy Kelman Neu

Wendy Kelman Neu is Senior Vice President of Hugo Neu Corporation. She began her career as a social worker for Trenton State Prison and Yardville Correctional Facility, where she developed and implemented inmate work programs. She now actively advocates for business and environmental integrity and leadership through her professional work, and personally within the industry and with environmental and social justice grassroots organizations. She has chaired the Government Relations Committee for the Institute of Scrap Recycling Industry (ISRI). In 2002 Wendy along with environmental partners helped to lead the creative effort which resulted in an economically positive New York City curbside recycling program.

Wendy has been honored by NY/NJ Baykeeper, the New York League of Conservation Voters and Earthday 2006. In 1989, focusing on the areas of social welfare and animal

In September 2006 Wendy was made a Trustee of the Natural Resources Defense Council (NRDC) and is a co-chair of the E2 (Environmental Entrepreneurs) initiative on the east coast which advocates for environmental legislation on behalf of NRDC. She joined the Board of Director of the Brennan Center for Justice in 2009. She is a graduate of American University and Benjamin N. Cardozo School of Law.

Executive Director

Michael Waldman is Executive Director of the Brennan Center. Mr. Waldman was Director of Speechwriting for President Clinton from 1995–99, serving as Assistant to the President. He wrote or edited nearly 2,000 speeches, including four State of the Union and two Inaugural Addresses. Previously, he was Special Assistant to the President for Policy Coordination (1993–95). Mr. Waldman was the top administration policy aide working on campaign finance reform, one of the Center's signature issues. He is author or editor of five books on public policy, law and history, including *A Return to Common Sense* (Sourcebooks, 2008). Previously, he was the director of Public Citizen's Congress Watch, a full faculty member at Harvard's JFK School of Government, and an attorney in private practice.

THE SCOTTSBORO BOYS

The Brennan Center for Justice is pleased to highlight a special performance tonight from *THE SCOTTSBORO BOYS*, the thrilling final collaboration by musical theatre giants John Kander and Fred Ebb (*Chicago*, *Cabaret*). This critically acclaimed show recently opened on Broadway at the Lyceum Theatre. Tonight company member Rodney Hicks will sing, “Go Back Home,” accompanied by conductor Paul Masse.

Directed by 5-time Tony® Award winner Susan Stroman (*The Producers*) and featuring a book by David Thompson (who adapted the script for Chicago’s record-breaking revival), this daring and wildly entertaining musical explores a fascinating chapter in American history with arresting originality.

The show is based on the notorious “Scottsboro” case in the 1930s, in which 9 African-American men were unjustly accused of a terrible crime. And it tells the story of a landmark case in American law, which led to a Supreme Court decision ensuring the constitutional right to counsel for criminal defendants. The Brennan Center works to protect this right.

We congratulate Producers Barry and Fran Weissler—longtime friends of the Brennan Center—for this terrific new show which brings to light this important story.

ABOUT THE BRENNAN CENTER

The Brennan Center for Justice at NYU School of Law is a nonpartisan public policy and law institute that focuses on fundamental issues of democracy and justice. A singular institution—part think tank, part public interest law firm, part advocacy group—the Brennan Center combines scholarship, legislative and legal advocacy, and communications to win meaningful, measurable change in the public sector. We were founded fifteen years ago by the family and clerks of Justice William J. Brennan, Jr., dedicated to his vision of “common human dignity.” Today, with a staff of 55 and dozens of students and pro bono lawyers, we have grown to become one of the country’s most respected and effective legal organizations. *The Boston Globe* called us “indispensable.”

We lead the legal defense in the aftermath of *Citizens United*. We stopped an effort to freeze Maine’s public campaign funding system, and persuaded a federal appeals court to uphold most of Connecticut’s landmark law. We are defending Arizona’s Clean Elections law against potential Supreme Court action.

We serve as constitutional counsel to the Fair Elections Coalition fighting for bipartisan reform. In March we convened “A-list First Amendment scholars” (*New York Times*) to map a new jurisprudence for money in politics.

Our Voter Registration Modernization plan would add up to 65 million to the rolls permanently, while minimizing error and fraud. This year seven states began to implement parts of the reform, registering hundreds of thousands.

Our widely covered study on criminal justice debt revealed how states charge poor defendants fees for everything from their supposedly free counsel to their stays in jail. Now we work to repeal onerous fees collection practices across the country.

Our long drive to revitalize legal services for the poor bore fruit in December when Congress lifted one of the most onerous restrictions on advocacy by Legal Services Corporation-supported lawyers.

We drafted the new law to end prison-based gerrymandering in New York. In the next redistricting cycle, people in prison will be allocated to their home communities rather than where they are incarcerated.

Released with Justice Sandra Day O'Connor, our report showed that special interest money in state judicial races has doubled in the last decade. We help lead a national movement to boost judicial independence.

We blew the whistle on comically flawed instructions on New York City's sample ballot—within a week the Board of Elections chair resigned.

Spurred by our advocacy, the Justice Department warned state courts to follow civil rights laws and provide adequate interpreters for non-English speakers.

We published or hosted thinkers including Richard Posner, Michelle Alexander, John Grisham, Dahlia Lithwick, Mickey Edwards, David Remnick, Linda Greenhouse and Tom Wolfe.

Our Community Oriented Defender Network convened thirty defender offices to endorse principles of effective representation of clients.

We released a groundbreaking report, introduced by Harvard Law Professor Charles Ogletree, that exposed the Jim Crow roots of New York's criminal disenfranchisement law and was cited as the inspiration for legislation that would restore voting rights to people on parole.

Brennan Center experts appeared before numerous Congressional committees and on dozens of television and radio shows, from PBS to Fox News. We have been quoted hundreds of times in major newspapers and magazines, including *The New York Times*, *Washington Post*, *Wall Street Journal*, *USA Today*, *Time* and *Newsweek*.



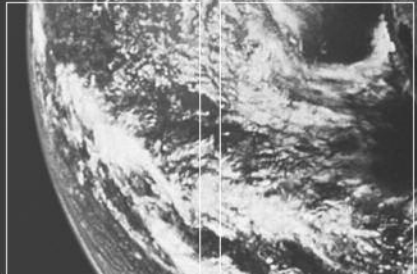
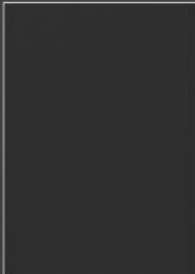
