## Robert M. Morgenthau

Robert M. Morgenthau was born in 1919 in New York City. In June 1940, while still an undergraduate at Amherst College, he enlisted in the United States Navy's v-7 program. Upon his graduation in 1941, Mr. Morgenthau joined the Navy and on December 7, 1941, he was an ensign on a destroyer in Boston Harbor. He served throughout World War II aboard destroyers, in

the North Atlantic, the South Atlantic, the Mediterranean, and the Pacific Theater, rising to the rank of Lieutenant Commander. Mr. Morgenthau was the Executive Officer and Navigator aboard the USS Lansdale when that ship was torpedoed and sunk by German aircraft while protecting a convoy. He was then the Executive Officer and Navigator on a new destroyer assigned to support the Iwo Jima and Okinawa invasions. That ship, the USS Harry F. Bauer, was torpedoed and was hit by a Kamikaze carrying a 550 pound bomb that failed to explode. The ship's crew received a Presidential Unit Citation for its conduct during the Okinawa campaign.

After the war Mr. Morgenthau attended the Yale Law School. He entered private practice in Manhattan, working for Robert P. Patterson, a former Judge of the Second Circuit Court of Appeals. In 1961 he was appointed by President Kennedy to the position of United States Attorney for the Southern District of New York and continued in that role until 1970. Mr. Morgenthau successfully ran for District Attorney of New York County in November, 1974.

Mr. Morgenthau was District Attorney from 1975 through 2009, and was the longest serving incumbent of that position. In his nine terms in office, his staff conducted about 3.5 million criminal prosecutions. During that period, homicides in Manhattan were reduced by over 90%. Mr. Morgenthau vigorously prosecuted white collar criminals as well, becoming the nation's leading proponent of the enforcement of state law to combat "crime in the suites."

Mr. Morgenthau serves as the Chairman of New York City's Police Athletic League and as Chairman of the Museum of Jewish Heritage — A Living Memorial to the Holocaust. He lives in Manhattan and on a farm in Dutchess County with two of his seven children and with his wife, the Pulitzer Prize-winning journalist Lucinda Franks.

Since January, 2010, Mr. Morgenthau is Of Counsel in the law firm of Wachtell, Lipton, Rosen & Katz.

### Jane Sherburne

Jane Sherburne became Senior Executive Vice President and General Counsel of Bank of New York Mellon in May 2010 after practicing law as the principal in her own firm. Until January 2009, she served as Senior Executive Vice President and General Counsel of Wachovia Corporation, assisting the company in confronting the challenges of the financial crisis.

Prior to joining Wachovia in June 2008, Ms. Sherburne served in various capacities at Citigroup, her last post being General Counsel of Citi's Global Consumer Group, with responsibility for a global legal department with over 800 employees world-wide. Before joining Citigroup in 2001, Ms. Sherburne had been a partner at the Washington law firm of Wilmer, Cutler & Pickering, specializing in litigation, crisis management and congressional investigations. She interrupted her practice at Wilmer from 1994 to 1997 to serve as Special Counsel to President Clinton with responsibility for managing investigations into ethics matters by Congress and the Independent Counsel.

Ms. Sherburne is a graduate of the University of Minnesota and Georgetown University Law Center. In July 2010 she was appointed by President Obama to serve on the 10-member Advisory Council of the non-partisan Administrative Conference of the United States (ACUS). She serves on the Boards of the National Women's Law Center, The Lawyers' Committee for Civil Rights Under Law, New York Lawyers for the Public Interest, New York Legal Aid Society and is a member of the New York City Bar Executive Committee.



## Patricia Bauman & The Hon. John Landrum Bryant

Patricia Bauman is President of the Bauman Foundation, which supports public policy and advocacy with particular emphasis on civic participation and election reform as well as environmental issues.

Ms. Bauman is Co-Chair of the Board of Directors of the Brennan Center for Justice. She is a Vice-Chair of the Board of Trustees at the Natural Resources Defense

Council, and a member of the Board of Montefiore Medical Center. She is a graduate of Radcliffe College and the Columbia University School of Public Health, and earned her JD degree from the Georgetown University Law Center.

The Hon. John Landrum Bryant is a designer of jewelry, furniture, lighting and objects for the home and bath. A graduate of the University of Virginia and the Georgetown University Law Center, he is Co-Director of the Bauman Foundation. Earlier, he was President of the National Park Foundation.

Michael is head of the U.S. litigation practice at Allen & Overy LLP. Michael is a former Assistant United States Attorney for the Southern District of New York, and has experience

He is a Trustee of the 92d Street Y and of Facing History and Ourselves. Michael and his wife Ruth Lazarus live in New York City.

Ruth Lazarus has sat on the Brennan Center Board for 11 years. She is a professional volunteer, working primarily with her Therapy Dog Coop. Michael and Ruth have three children: Rachel, a New York City public school teacher; Jesse, who teaches preschool in New York; and Ben, a senior in college; and one grandchild, Anabelle Eve, daughter of Rachel and her husband Jimmy Levin.



### Reid M. Figel

Reid M. Figel is an experienced trial lawyer and litigator at Kellogg, Huber, Hansen, Todd, Evans & Figel, P.L.L.C. He represents corporations, financial institutions, and individuals in federal and state criminal and regulatory matters, and in complex financial litigation. His practice centers on securities, banking, and antitrust law enforcement; Foreign Corrupt Practices Act; internal corporate investigations; administrative law; and

complex civil litigation. Prior to joining Kellogg Huber, Mr. Figel was Chief (1995–1998) and Deputy Chief (1993–1995) of the Securities and Commodities Fraud Unit at the United States Attorney's Office for the Southern District of New York. During his years as a federal prosecutor, he was twice given the Attorney General's Award for Distinguished Service, as well as the Securities and Exchange Commission's Stanley Sporkin Award. He received his B.A., cum laude and with Honors from Middlebury College in 1978, and was awarded a Thomas J. Watson Fellowship. He is a frequent speaker at conferences, and has been a guest lecturer at New York University School of Law, University of Pennsylvania School of Law, Georgetown Law School, and Fordham Law School.



#### Dr. Gail Furman

Dr. Gail Furman is a child and adolescent psychologist. She has worked as a school psychologist at the Dalton and Fieldston schools and founded one of the first innercity full service alternative schools in Harlem. She is involved in a wide range of civic and professional activities. She served on the Board of the Women's Commission for Refugee Women and Children from 1994–2011, and participated in fact finding missions to

explore children's programs in Angola, Rwanda, Uganda, Kosovo and the Thai/Burma border. Dr. Furman also serves on the boards of the Brennan Center for Justice at the

NYU Law School, Human Rights First, and Auburn Seminary, particularly working with the Face to Face/Faith to Faith Program that fosters conflict resolution for youth in the Middle East. She is also a member of the Council on Foreign Relations and very active politically.



### Brad S. Karp

Brad S. Karp is Chair of Paul, Weiss, Rifkind, Wharton & Garrison, where he previously chaired the firm's Litigation Department. Mr. Karp has achieved national prominence as both a litigator and corporate adviser. Mr. Karp has extensive experience defending financial institutions and other companies in "bet the company" litigations and regulatory matters. Mr. Karp has been profiled as one of the leading lawyers in the United States

by The Wall Street Journal, The New York Times, The Financial Times, Crain's, The American Lawyer, The Lawyer (U.K.), The National Law Journal, Chambers, Lawdragon, Best Lawyers in America, Legal 500, Euromoney Institutional Investors, Law360, and Benchmark/Institutional Investor.

#### Jason Kravitt

Jason Kravitt is the former chairman of Mayer Brown and founder and current co-head of the firm's securitization practice. Co-Founder of the Securitization Industry's preeminent trade association, the American Securitization Forum, Jason

was chosen by the Financial Times as one of the 10 most innovative lawyers in America in 2010. Jason is currently best known for three achievements: he was one of the lawyers chosen to help lead the proposed \$100 billion rescue of SIVS by means of an SPV called Liquidity Enhancement Conduit, or "M-LEC"; he represented Bank of New York Mellon, as Trustee, in the proposed precedent setting \$8.5 billion settlement with Bank of America concerning RMBS issues; and he represented Citigroup and Morgan Stanley in the structuring of Straight-A Funding LLC, the \$60 billion conduit to help rescue the financing of student loans. He is regularly ranked as a leading lawyer in the industry by legal directories. Chambers USA 2011 describes him as "one of the godfathers of securitization," while the 2010 edition describes him as "an incredible legal strategist and a fantastic leader."



### Matthew Ingber

### William J. Perlstein

Executive Director

Michael Waldman joined the Brennan Center in 2005 after a distinguished career in public service and advocacy. Mr. Waldman was Director of Speechwriting for President Clinton from 1995–99, serving as Assistant to the President. He wrote or edited nearly 2,000 speeches, including four State of the Union and two Inaugural Addresses. Previously, he was Special Assistant to the President for Policy Coordination (1993–95). Mr. Waldman was the top administration policy aide working on campaign finance reform, one of the Center's signature issues.

He is author or editor of five books on public policy, law and history, including *My Fellow Americans* and *A Return to Common Sense*. He has served as the director of Public Citizen's Congress Watch, a full faculty member at Harvard's JFK School of Government, and a partner at the law firm Cuneo, Waldman & Gilbert LLP. The Brennan Center for Justice at NYU School of Law is a leading nonpartisan force for democracy and justice. Part think tank, part advocacy group, we start with rigorous research. We craft innovative policies. And we fight for them—in Congress, the courts, and in the court of public opinion.

We were founded fifteen years ago by the family and clerks of Justice William J. Brennan, Jr., and are dedicated to his vision of "common human dignity." Today, with a staff of 55 and dozens of students and pro bono lawyers, we have grown to become one of the country's most effective and respected legal organizations. *The Boston Globe* calls us "indispensible."

#### **Protecting Voting Rights**

We lead the legal strategy to combat the rash of restrictive voting laws—including harsh photo ID and proof of citizenship requirements. In Texas, voters can't use a student ID, but can use a gun permit. Florida's new law has effectively shut down registration drives.

Our authoritative study showed that because of these new laws at least *five million* could find it harder to vote in 2012. Hardest hit: minorities, students, the elderly and the poor.

The report appeared as the lead story in *The New York Times. Rolling Stone* Magazine called us a "leading advocate for voting rights."

### Accountability After Citizens United

We lead the legal response to *Citizens United*, the U.S. Supreme Court decision fueling secret Super PAC election spending.

We defended Arizona's Clean Elections program before the U.S. Supreme Court. The high Court narrowly struck down a provision of the law—but we persuaded the Justices to broadly uphold the constitutionality of public financing.

Money, Politics, and the Constitution: Beyond Citizens United—penned by the nation's top First Amendment scholars and published by the Brennan Center—launches a jurisprudential movement that puts a self-governing democracy at the center of the Constitution.

#### Fighting for Justice

States have begun to rein in excessive criminal justice fees, which impose unfair debt on defendants and undermine successful reentry. Our advocacy prompted the chief judge in Tallahassee, Florida to cancel 8,000 bench warrants for overdue court costs, a Massachusetts panel to reject new inmate fees, and the Maryland legislature to reform its "parole supervision fee" policy.

Justice is nearly impossible for millions of non-English speakers. Based on our study on the disturbing need for adequate translation services in state courts, Utah adopted a sweeping series of language access changes this spring.

In advance of Rep. Peter King's (R-NY) hearings on the radicalization of American Muslims, we critiqued the way some law enforcement agencies seek to spot and deter "homegrown" terrorists and urged an evidence-based approach.

At a time when fair courts are under new threat, the American Bar Association urged states to adopt new judicial disqualification rules, based on our proposal. These procedures are central to promoting public confidence in the judiciary.

### Strategic Communications

Brennan Center experts appeared before numerous Congressional committees and on dozens of television and radio shows, from ABC's "Good Morning America" to Comedy Central's "The Colbert Report." We have been quoted thousands of times in major newspapers and magazines, including *The New York Times, Washington Post, USA Today, Time,* and *Newsweek*.









It alleges that a new village zoning ordinance discriminates against the Muslim community, violating its rights under the First Amendment and the Equal Protection Clause. #### AOSI v. USAID

Wilmer Cutler Pickering Hale and Dorr LLP helped with the Brennan Center's 2nd Circuit victory in this case challenging USAID's anti-prostitution pledge.

Milbank Tweed Hadley & McCloy LLP assisted with a FOIA request relating to this case.

#### Arizona Free Enterprise Club v. Bennett

The Brennan Center, with pro bono partner **Munger, Tolles & Olson LLP**, represented the Arizona Clean Elections Institute before the U.S. Supreme Court to defend the state's public financing system. Brad Phillips argued the case. Other attorneys at Munger Tolles include Grant Davis-Denny and Elisabeth Neubauer. Seventeen amicus briefs were submitted in support of the law, including briefs drafted by **Simpson Thacher & Bartlett LLP** (led by Partner Alexis S. Coll-Very) and **Davis Polk & Wardwell LLP** (led by Partner and Brennan Center Board member Dan Kolb).

## Conservative Party of New York State and Working Families Party v. New York State Board of Elections

**Emery Celli Brinckerhoff & Abady, LLP** partner Andy Celli and associate Zoe Salzman and **Cuti Hecker Wang LLP** partner Eric Hecker helped bring this case to satisfactory conclusion by consent decree, ensuring third parties in New York State have equitable access to the ballot.

### Hurrell-Harring, et al. v. State of New York

In partnership with **Richards Kibbe & Orbe LLP** we authored an amicus brief signed by 62 former prosecutors arguing the state's legal services for the poor are

constitutionally inadequate. Founding Partner Lee Richards recruited amici and shaped the brief.

#### NAACP New York State Conference, et al. v. New York State Board of Elections, et al.

Low-income and minority voters sued the state and city Boards of Elections in federal court to block a voting machine configuration that would lead to tens of thousands of lost votes. **Jenner & Block LLP** is our co-counsel; attorneys include Stephen L. Ascher, Michael Ross, Prashant Yerramalli, Eric P. Brown, Joshua A. Block, and Randall T. Adams.

#### New York State Ethics Reform—The Public Integrity Reform Act of 2011

**Kaye Scholer LLP** attorneys led by James Herschlein conducted a multi-state study of ethics oversight entities. The study served as invaluable background for policy recommendations incorporated into the new ethics law passed in May 2011.

#### State of Florida v. United States of America

Florida has gone to federal court seeking approval of its controversial new voting law, which restricts voter registration drives and cuts back on early voting. **Bryan Cave LLP**, the Brennan Center and the Lawyers Committee for Civil Rights represent the League of Women Voters of Florida and Democracia, seeking to intervene. Bryan Cave attorneys include partners Daniel C. Schwartz, Rodney F. Page, and Alec W. Farr, and associates Dan O'Connor and Ian Barlow.

### Wisconsin Right to Life PAC v. Michael Brennan

**Sidley Austin LLP** was co-counsel with the Center and Stafford Rosenbaum LLP in defending Wisconsin's judicial elections public funding system, including filing an amicus brief in the Seventh Circuit on behalf of good government groups. Wisconsin later repealed public financing mooting the case. Attorneys at Sidley Austin include partner David Carpenter (a former law clerk to Justice Brennan) and associate Tacy F. Flint.

At press time, two new lawsuits: **Paul, Weiss, Rifkind, Wharton & Garrison LLP** will be assisting with another challenge to Florida's voting legislation and **Dewey & LeBoeuf LLP** will be counsel to the Brennan Center in preparation of an amicus brief defending West Virginia's campaign finance disclosure laws.
