

I will be happy to provide you what you need......How many analysts all together will be using the system across different investigative units? I can estimate the ratio between "Power users" and "analysts" but it will be helpful to see what population I am looking at. Furthermore, do you have a feel for how many collections per month (to start with) you are considering?

It would be best to "ramp up" into the collection and analysis based on our experience and do the "change management", one department (or group) at a time to get people (analysts) on board. The typical group to start is probably the group with the highest number of cases that need to be solved quickly (e.g. criminal investigations perhaps, or gang violence group).....I don't know if all the investigators are lumped into one group or each group will have their own budget and investigators......That is why I suggested to have a discovery day and discuss all the relevant issues.

Do you think we can have a conference call sometimes tomorrow around noon time to get a lay of the land as far as roll-out plans, number of analysts, etc. is concerned so we can hit your target estimates better? If you don't think you can assemble that level of granularity, that is fine, and we can work around it by just providing some pricing based on collection volume and let you figure out how to land on a number that makes sense.
