Subject: RE: Intelligence Subcommittee Meeting Notes for 2 March 2021

Good Afternoon,

MPD is aware of and monitoring social media chatter regarding the *potential* March 4th and 6th events. At this time, MPD is not aware of any real-world planning for an event on either day. Additionally, hotel and bus parking reservations in the NCR remain extremely low for the period of March 3rd-6th, indicating that there are no plans for a mass event in Washington, DC during this period.

With respect to the March 6th “worldwide day of action” proposed by England-based antifa groups, a few U.S. based antifa groups posted on social media that they are aware of this event and have forwarded the original posts in some cases, to include local antifa groups in the NCR. However, there is no indication of local groups organizing any sort of 1A demonstration or event in the NCR.

Finally, MPD is currently monitoring social media chatter regarding calls for a “national day of action” on March 6th and 8th in reference to the start of former Minneapolis PD Officer Derek Chauvin’s criminal trial or the death of George Floyd. However, MPD is not aware of any specific plans for demonstrations in the NCR at this time.

Summary:

Open source social media reporting discovered five planned demonstrations scheduled to take place in Washington, DC on 06/07/20, with unknown number of participants. As group numbers are obtained, PID will provide updates. The demonstration activity for 06/07/20 is summarized below:

1. Ongoing nightly, at 1930 hours EDT,, Twitter user @alloutdc202 (NRID) will host a demonstration called "**BECOME UNGOVERNORABLE: UNTIL THEY STOP KILLING US**" at McPherson Square. Participants are told to "wear a mask / bring water / bring a snack!" There was no indication of civil disobedience. Numbers of anticipated participants are unknown.
2. On 06/07/20, between 1200 hours EDT and 1900 hours EDT, the group Faith Works DC (NRID) will host a demonstration called "**A Christian Response to Racial Injustice**" at the US Capitol. The purpose of the event appears to be to "pray and sing" in support of peaceful demonstrations against racial injustice. According to the Twitter post, the group plans to march to the White House from the Capitol around 1630 hours EDT. There was no indication of civil disobedience. Numbers of anticipated participants are unknown.
3. On 06/07/20, 1300 hours EDT, the individuals ██████████ (NRID), ██████████ (NRID) and ██████████ (NRID) will host a demonstration at the Lincoln Memorial called "**March for Peace & Prayers in honor of George Floyd.**" The purpose of the demonstration is "Prejudice, racism, & injustice will no longer be tolerated in America in 2020." According to the Facebook event details, the group plans to hold an "8 minute 46 second moment of silence at the Lincoln Memorial then march to the White House for a peaceful, non-violent protest." There was no indication of civil disobedience. Numbers of anticipated participants are unknown.
4. On 06/07/20, from 1500 hours EDT – 2000 hours EDT, the individual ██████████ (NRID) will host a demonstration at Dupont Circle called "**D.C. BLACK LIVES MATTER MARCH**". Between 1545 hours EDT and 1600 hours EDT, the group will march from Dupont Circle to Lafayette Square. The purpose of the demonstration is to "bring awareness to the unacceptable police brutality that is threatening our black and minority communities across the nation." No civil disobedience is expected. Numbers of anticipated participants are unknown.
5. On 06/07/20, from 1700 hours EDT - 1830 hours EDT, DC Young Democrats(NRID), Begreatdc (NRID), NAACP DC Branch (NRID), Commissioner Salim Adofo (NRID) and National Black United Front (RID) will host, "**Next Steps:**

What Do We Do After We March?”. Their purpose is to stand in solidarity with the victim’s families and those raising the righteous call for justice. Tickets are available via Eventbrite. There was no mention of civil disobedience. Numbers of anticipated participants are unknown.

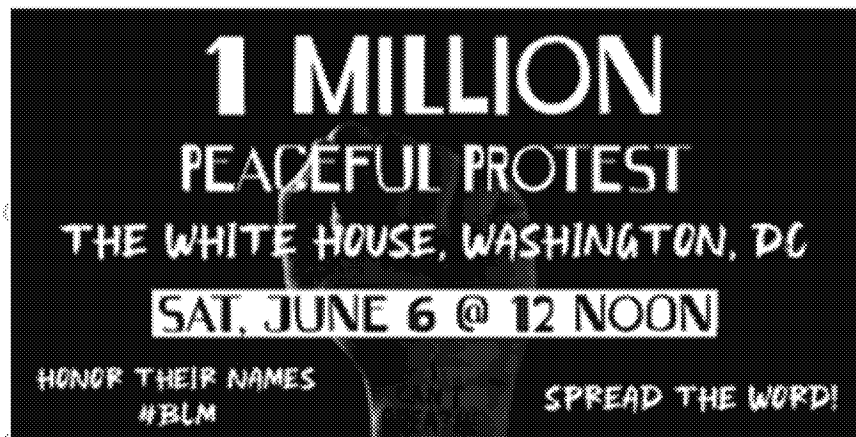

Group will meet at the Rock Creek Tennis Center Parking area at noon and travel through the streets of Washington, DC in a car caravan. Exact route unknown, but group has stated that the last stop will be the MPD First District HQ. This group had a similar demonstration a few weeks ago and was attended by approx.200 people. While no attendance is being released, it is expected that the group will at least meet this prior attendance.

SAY THEIR NAMES PROTEST

Group will meet at the Navy Memorial at 1400 hours. Their stated plan is to march to the Department of Justice however there have been multiple postings that individuals plan to then move onto the White House. While this group has always stated that their protest will be peaceful, over the course of yesterday afternoon into this morning, their tone has changed somewhat to a more confrontational tone (a separate email to this group will document some planning verbiage released by the group). This appears to be the "main" protest being held today in DC. Numbers are difficult to estimate, but we could easily see numbers around 2,500 once groups consolidate. There were MANY postings throughout the night from people who were upset that they "missed" last night's protest. It is highly likely that individuals will travel to downtown DC and join the demonstration. This large group will be made up of individuals with mixed intentions making predictive behavior very difficult.

BLM CAR CARAVAN "MOVING PROTEST"

Group will meet at 1600 hours at the Safeway Parking lot at 322 40th Street NE and perform a car caravan throughout DC. Unknown route, unknown number of people attending.

*** In addition to these demonstrations, there were also multiple individuals posting their disgust with the actions of protesters last night and this morning. There was also nationwide calls for law enforcement to begin to physically disperse protesters and stop the property damage. There is concern that some of these individuals may attempt to take matters into their own hands and lead to an incident such as when James Fields Jr drove his vehicle into a crowd of demonstrators in 2017 in Charlottesville, VA.

We will continue to work with our LE partners and will update information to this group throughout the day. Please call with any specific questions or concerns.
