Prior to the General Assembly, Dataminr sponsored a roundtable for New York-based partners assigned to work the event. Participating teams discussed a common operating approach and view of the event, including how Dataminr could best support its partners in advance of, and throughout, the event.

Establishing a game plan prior to the event allowed first responders to thwart a bomb threat and resolve potential delays in the NYC Subway system before such incidents affected travel to and from the event.

First Alert’s early notifications provided a clear operating picture to multiple agencies using common language that fostered better understanding, enabling users to coordinate among each other to respond quickly and maintain ongoing situational awareness.

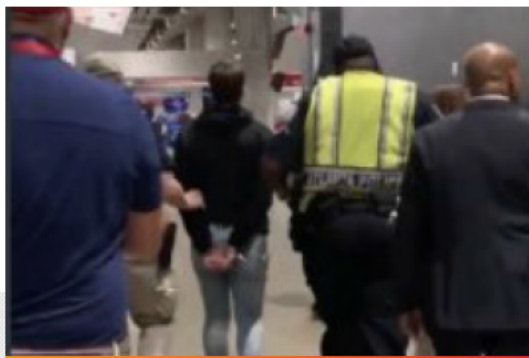
### RNC 2016 in Cleveland, OH



Dataminr supported various clients overseeing the 2016 Republican National Convention and provided crucial notifications on a variety of potential threats to public safety.

First Alert’s notifications enabled teams to maintain situational awareness throughout the entirety of the RNC.

### Super Bowl LIII in Atlanta, GA



Ahead of the Super Bowl in 2019, first responders in Atlanta used First Alert to mitigate a public safety threat circulated on social media. First Alert sent security-related notifications to users throughout the event, providing early warnings of possible threats around the stadium.

As a result, police were able to apprehend the suspects in question.

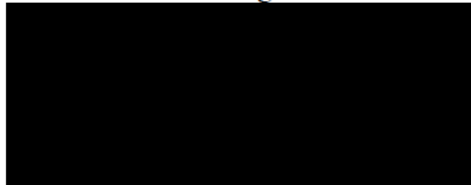

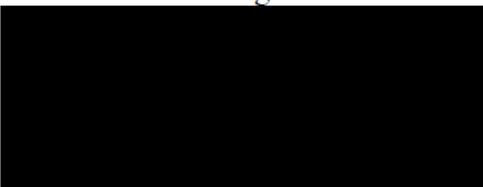
