1. On 06/07/20, 1300 hours EDT, the individuals [REDACTED] (NRID), [REDACTED] (NRID) and [REDACTED] (NRID) will host a demonstration at the Lincoln Memorial called "March for Peace & Prayers in honor of George Floyd." The purpose of the demonstration is "Prejudice, racism, & injustice will no longer be tolerated in America in 2020." According to the Facebook event details, the group plans to hold an "8 minute 46 second moment of silence at the Lincoln Memorial then march to the White House for a peaceful, non-violent protest." There was no indication of civil disobedience. Numbers of anticipated participants are unknown.

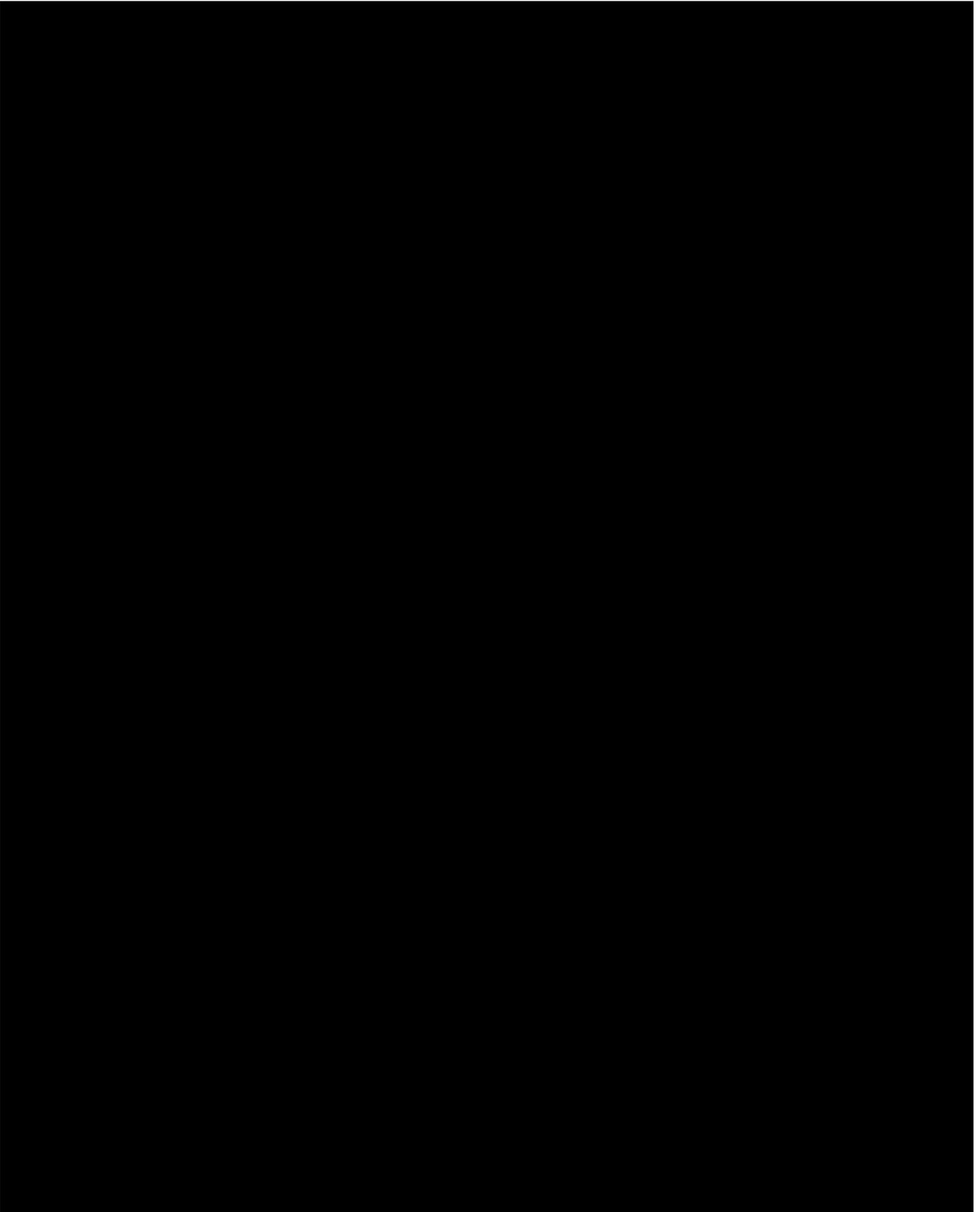

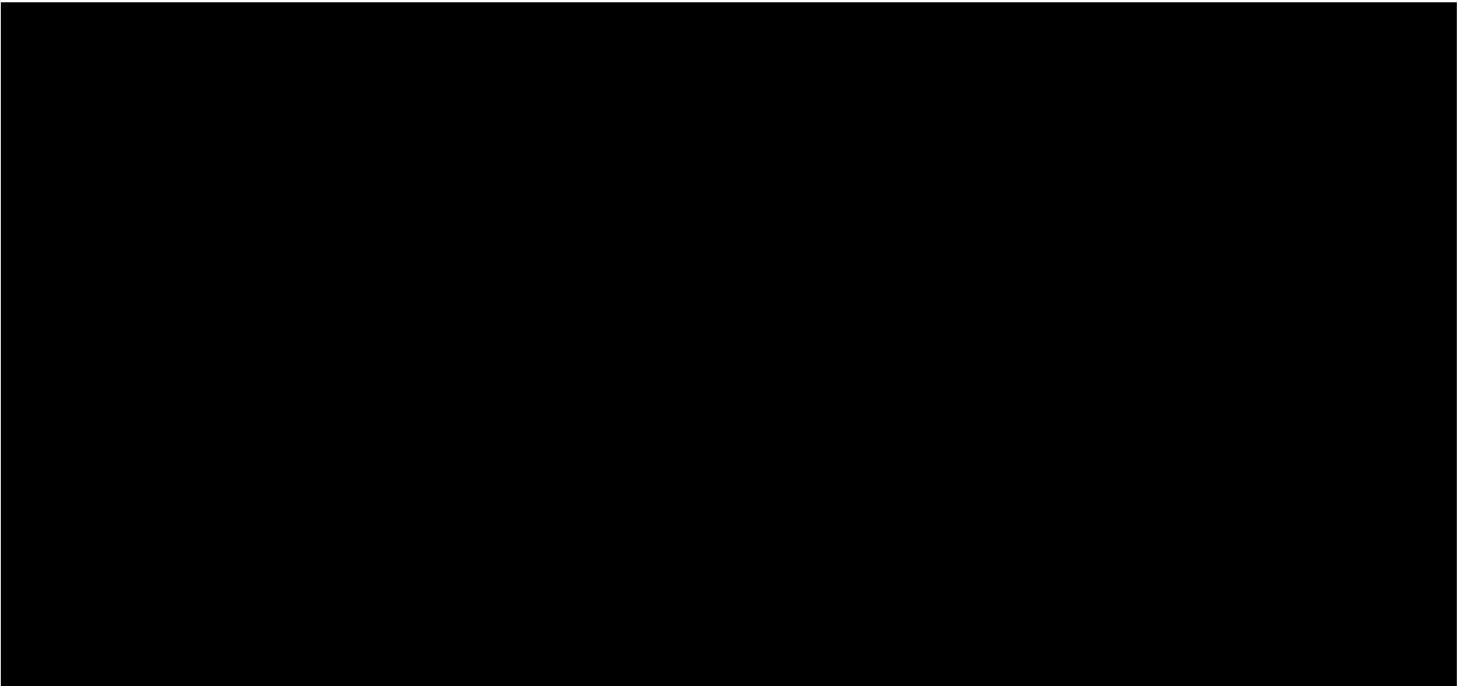

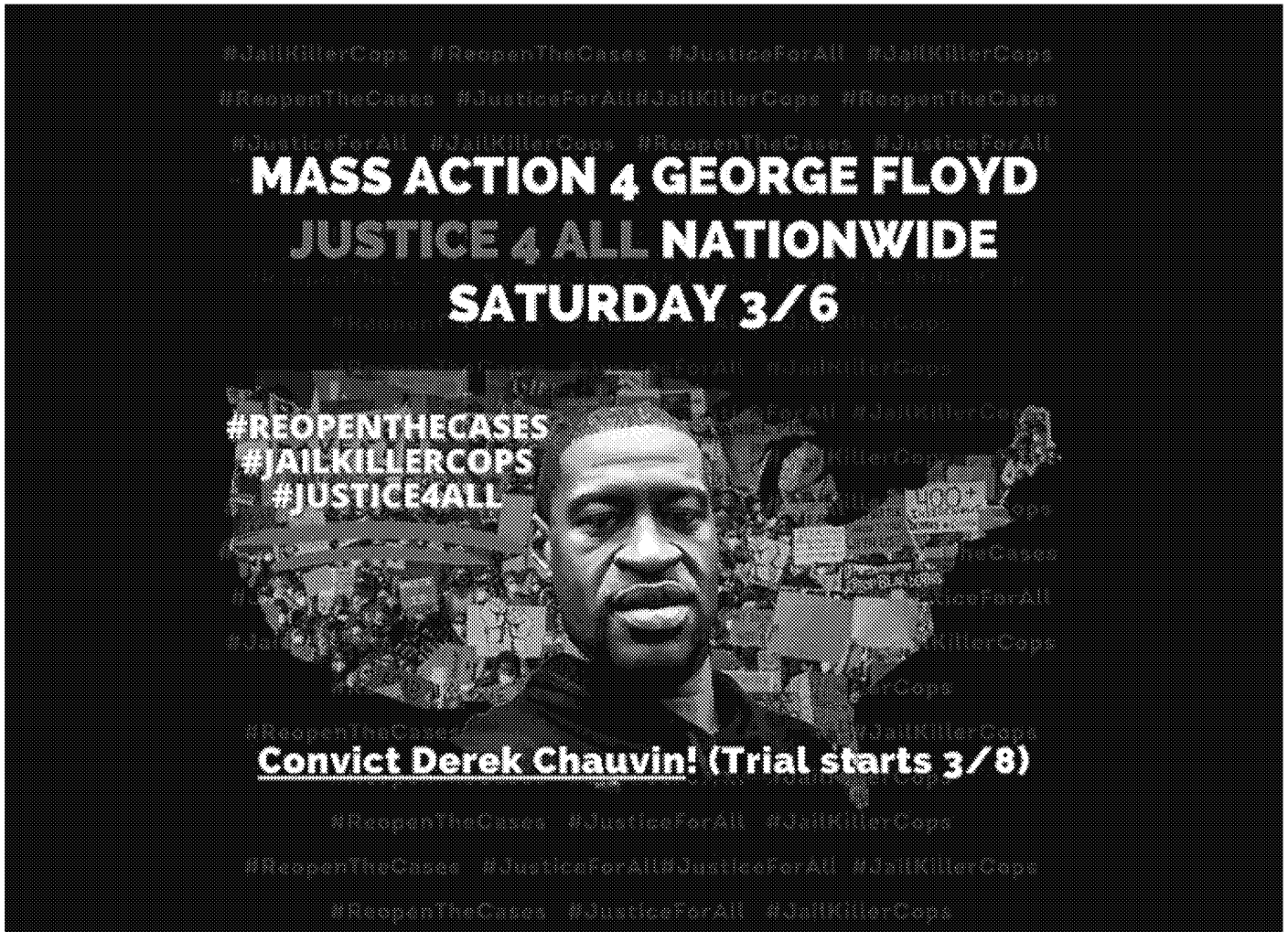

#1 - Justice 4 All 'national day of action' on 6 March



On 6 March 2021, campaigners have called for a “national day of action” in solidarity with social and racial justice movements in the US.

Organizers explained that the day of action would primarily focus on the Justice for George Floyd and defund the police campaign. According to the organizers, actions would take place in Boston, Baltimore, New York City, Dayton, Minneapolis, Chicago, and Washington, DC, as well as in multiple cities in Texas, Georgia, Nevada, North Dakota, Oklahoma, Michigan, and California. They asked for any groups who wanted to participate by organizing solidarity events in their city or state to reach out to national organizers to have their event added to the official list.

Specific protest details were not revealed. The call to protest has not been widely circulated. The event coincides with the start of the trial of Derek Chauvin, the Minneapolis Police officer accused of George Floyd’s death. The trial is scheduled to begin on 8 March 2021. Despite this, Chauvin’s trial has the potential to spark protests across the US, as has been seen with organizing for Derek Chauvin’s trial the anniversary of Breonna Taylor’s death.

The day of action demanded:

- *Justice for George Floyd! Justice 4 All families whose loved ones were brutalized or slain by police!*
- *Prosecute the police! Reopen all past cases of police brutality!*
- *End the system of policing as we know it!*

Mass Action Against Police Brutality (MAAPB) promoted the day of action. Established in 2015, it works to represent those affected by ‘police brutality’. MAAPB has a moderate following on social media. It had organized a Black Lives Matter protest in St. Paul, Minnesota.

On 8 March 2021, National Alliance Against Racist & Political Repression (NAAPR) has called for a 'national day of action' to mark the start of the murder trial of ex-Minneapolis cop Derek Chauvin in George Floyd's death in Hennepin County.

NAAPR explained that on the first day of the trial, jury selection, Minnesota organizers will hold a mass protest outside the Hennepin County Government Center in Minneapolis. It urged "all organizations that want justice for George Floyd to endorse this call" and to "hold solidarity rallies" in cities nationally.

The group asserted that "this trial is not only important for Minnesota, which has never seen a white police officer prosecuted for murdering a Black person. It is important for the entire country, which was set aflame in rebellion after Floyd's murder. We will not rest until we see all four of George Floyd's killers taken off the streets, and our communities have the power to decide who polices our communities and how our communities are policed."

NAAPR is assisting in the coordination of solidarity actions across the US. It advised those traveling to Minneapolis to contact Twin Cities Coalition for Justice 4 Jamar.

Based in Chicago, NAAPR promoted protests in response to George Floyd's death. The call to protest has not been widely circulated and NAAPR has a limited following on social media. Despite this, Chauvin's trial has the potential to spark protests across the US, as has been seen with organizing for the anniversary of Breonna Taylor's death.

#3 - Protests to mark start of Chauvin trial in Minneapolis on 8 March



On 8 March 2021, there will be protests to demand 'justice for George Floyd' at the Hennepin City Government Center. The day marks the start of the trial for former Minneapolis police officer Derrick Chauvin.

Protest organizers stated: "The people demand justice for all stolen lives. Convict all killer cops. The murder of George Floyd by these killer police officers is a devastating example of the many lives stolen at the hands of police in our community as well as the world at large. Derek Chauvin represents what is wrong with police in Minneapolis and in this country, and now is the time to demand due justice for George Floyd and set the precedent in seeking justice for every stolen life."

Twin Cities Coalition for Justice 4 Jamar said that it was going to protest because "... while our city was burning, county attorney Mike Freeman was negotiating a backroom deal with George Floyd's murderer, so Chauvin would plead to a lesser charge, and there would be no trial. Freeman wasn't going to charge his co-conspirators at all, so there'd be no trial for them either..."

It added: "You can be damn sure, now is not the time to stop demanding justice. If you want Chauvin to face the harshest possible legal punishment, then be in the streets to make sure the system knows that we won't accept a compromise. If you want Floyd's other killers brought to justice, then you have a duty to help keep the pressure on. And if you hope to someday see justice for the other lives stolen by police, this is the time to make sure you are heard, loud and clear."

Among the organizations planning to protest are the Anti-War Committee, Black Lives Matter MN, CAIR-MN, CAIR-MN, Climate Justice Committee, Communities United Against Police Brutality, Families Supporting Families Against Police Violence, Freedom Road Socialist Organization - Twin Cities, Good Trouble for Justice, MN Immigrant Rights Action Committee, MN Uprising Arrestee Support, MN Workers United, Native Lives Matter, On Site Public Media, Racial Justice Network, Students for Democratic Society at UMN, Twin Cities Coalition 4 Justice 4 Jamar, and Women Against Military Madness.

Protesters will gather at 8.30am outside of the Hennepin County Government Center.

#4 - Proud Boys leader warns more violence 'likely' if far-right members remain 'alienated'



Proud Boys leader Enrique Tarrio has suggested that if far-right groups and their members continue to be 'alienated' by the Biden Administration, it is likely that more violent events similar to the [riot at the US Capitol](#) will be organized.

In an interview conducted by *Channel 4 News*, Tarrio suggested that the Biden administration needed to "reach out" to those individuals and groups who were part of, or supported, the riot at the US Capitol. He argued that those people acted because they believed they were being marginalized, forgotten, and left behind, and that the Biden administration was going to exacerbate these feelings. "[Trump supporters] are being persecuted," Tarrio argued.

"If the Biden administration does not reach out to these people in one way or another, what you're seeing [at the Capitol] right now is what you are going to see for the next four years," Tarrio said. "Imagine [a similar incident] happens in Richmond, Virginia, with guns. Somewhere that its 'open carry' and [the rioters] are like 'Fuck you! We're not leaving here, not until we get what we want'. What's going to happen? What's the next step?"


Tarrio added that it was unlikely Trump supporters would 'de-escalate' during a future action because the 'movement' had 'transcended' Trump's re-election and the fight for the presidency. He suggested that Trump supporters and far-right groups were focusing on the perceived systemic opposition from the government to suppress them.

Open source social media reporting discovered the following demonstration(s) scheduled to take place in Washington, DC on 06/05/20, with an unknown number of confirmed participants. As group numbers are obtained, PID will provide updates. The demonstration activity for 06/05/20, is summarized below:

From 06/04/20 to 06/11/20, at 6:00 PM, social media user using **#logancircle** and **#protestdc** will host a vigil at Logan Circle. The vigil will last 8 minutes and 46 seconds. There is no indication of civil disobedience. Numbers of anticipated participants are unknown.

On 06/05/20, at 10:00 AM, an unknown individual utilizing the email address **kaxamadays@gmail.com** will host a demonstration at the White House called "National Marijuana Protest March/Weed Walk on Washington." The purpose of the event is "to express the countless reasons why marijuana is a huge benefit to our country." Participant numbers are unknown at this time. No civil disobedience is expected. No known permit has been issued for this event.

On 06/05/20, from 11:00 AM to 1:00 PM, approximately 32 members of **Shut Down the Dog and Cat Meat Trade Worldwide** will host a demonstration at the Embassy of China called "Shut Down the Yulin Dog Meat Festival!" The purpose of the event is "to urge public awareness and stop the cruelty of torturing and killing dogs for the Dog Meat Festival in Yulin, China." No civil disobedience is expected. No known permit has been issued for this event. The event has been postponed.

On 06/05/20, at 1:00 PM, **Black Lives Matter** will host a demonstration at Cathedral Lawn called "Die-In (Lie-In)." The purpose of the event is "to lie on the ground for 8 minutes and 46 seconds to represent how long the cop had his knee on George Floyd's neck." Participant numbers are unknown at this time. No civil disobedience is expected. No known permit has been issued. The group has conducted numerous demonstrations at USSS protected sites. Demonstrations have resulted in arrests. The group has conducted several demonstrations at/near the White House over the past seven days.

On 06/05/20, from 3:00 PM to 6:00 PM, approximately 151 members of **This Ends Now: A Peaceful Protest to End Police Brutality in America** (NRID) will host a demonstration at the White House. The purpose of the event is "to peacefully assemble outside of the White House and pressure the US Government to enact forceful policies against the systematic issues that this country faces." Participant numbers are unknown at this time. No civil disobedience is expected. No known permit has been issued for this event. This event could not be confirmed at this time.

On 06/05/20, from 2:00 PM to 6:00 PM, approximately 11 individuals will join **Kenny Sindoni** in hosting a march called "March for reform in Washington." The march will begin at the Lincoln Memorial and end at the White House. The purpose is "to bring about a new standard for the police and their actions." No civil disobedience is expected. No known permit has been issued for this event.

On 06/05/20, from 3:00 PM to 6:30 PM, **The Episcopal Diocese of Washington** will assemble at St. John's Cathedral near Lafayette Park. The purpose of the event is "to support racial justice by praying and witnessing." Participant numbers are unknown at this time. No civil disobedience is expected. No known permit has been issued for this event.

On 06/05/20, from 6:00 PM to 9:00 PM, approximately 20 members of **Diaspora en Accion** will host a demonstration at the White House called "Cacerolazo BLM / BLM Saucepan." The purpose of the event is "for the entire Latino community (black and non-black) to join the demands of the #BlackLivesMatter movement...we will do it in the most Latin way we know how: to the sound of a saucepan." No civil disobedience is expected. No known permit has been issued for this event.

Open source research for potential demonstration activity during the Presidential Inauguration revealed the following results:

1. On 01/20/21, at an unknown time, the group **1st Regiment of the Restored American Republic (NRID)** and **American Patriots USA (NRID)** led by [REDACTED] (possibly 671-0018261) will host a demonstration in Washington DC called “**Million Militia March.**” The purpose of this demonstration is unknown. There was no indication of civil disobedience, however, the event contains images of weapons and the group claims they will not attack, but will defend. Current numbers of planned participants was unavailable at this time, though the group is made up of approximately **348** members.

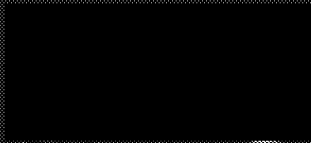
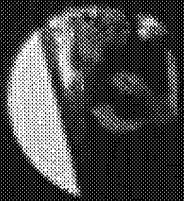

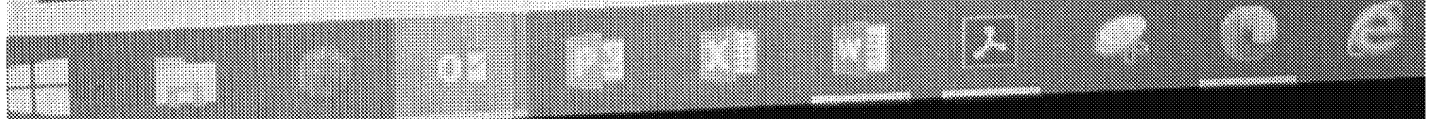

(U//LES) TTPs Utilized by Protesters

- Protesters flooding onto highway areas and stopping or hindering traffic.
- Agitators within the protest marches coordinating locations and other instructions through Signal App and Air Drops to communication devices.
- Social media posts to kill police officers.
- Use of laser pointers to target law enforcement and helicopters.
- Hoax phone calls to scatter law enforcement.
- Individuals following law enforcement and use of firearms to incite protesters.
- Protesters using umbrellas as shields and potential stabbing instruments to form a Roman Testudo formation and as a tactic to maintain distance and protect themselves from non-lethal projectiles.
- Pre-staging of projectiles, bricks, rocks, sledge hammers, brass knuckles, spray paint and other weapons at protest locations.

- Presence of heavily armed protesters wearing body armor and having long guns.

- Frozen water bottles being unloaded from trucks.
