Daily Situation Summary:

On Monday, May 25, 2020, George Floyd died in the custody of Minneapolis Police after being stopped for a crime that occurred earlier that day. During the stop of Mr. Floyd, Officer Derek Chauvin knelt on Mr. Floyd's neck for over eight minutes, before Mr. Floyd died. In the following days, protests swept the nation, in which at times, turned into riots. The District of Columbia experienced riots and there have been continued demonstrations since June of 2020.

In the aftermath, Minneapolis Police Department terminated Derek Chauvin and he was subsequently arrested and charged with second-degree murder, third-degree murder, and second-degree manslaughter. On Monday, March 8, 2021, jury selection began with opening statements occurring on Monday, March 29, 2021. The trial is expected to end sometime in the following week.

Due to the high-profile stature of this trial and the potential for civil unrest at the outcome, the Metropolitan Police Department (MPD) will be fully activated. This manual serves as an overview of MPD's activation and response to any demonstration and the goal to ensure demonstrations are conducted safely and to minimize any violence or destruction - if it happens. It should be noted this is a general overview and daily operations may vary based upon the day's intelligence.

On Monday, April 19, 2021, MPD will activate CDU platoons and staff traffic posts in case road closures are needed. MPD will work closely with the United States Park Police (USPP) and other law enforcement agencies to ensure the safety of the public and any potential demonstrators.

The Investigative Services Bureau (ISB), Professional Development Bureau (PDB), and the Internal Affairs Bureau (IAB) will provide personnel for road closures. NSID will suppose operations with personnel for Mass Arrest Processing and from the Electronic Surveillance Unit. Further, the Criminal Investigations Division, Internal Affairs Division, and Intelligence Division will activate personnel to assist and the Special Operations Division will be activated to assist with any demonstrations during this timeframe.

The objective of MPD is to assist with the safe execution of any First Amendment demonstration and ensure the safety of the participants, public, and the officers. CDU personnel and SOD members will monitor for any demonstration and/or violent activity and respond accordingly.

Officers are reminded to be vigilant and on the lookout for any suspicious activities, no matter how small, and immediately report it to their official. Officers shall have with them at all times their issued Personal Protective Equipment (PPE), Chem/Bio Equipment, and wear a face-covering while outside of their vehicle or anywhere in the public.

We are still going through the high volume of traffic on social media, but here is what we have so far for today. As an aside these "groups" are showing far more operational security than they have in the past leaving some unknowns in our reporting. Yesterday and early this morning this included violence against videographers and news crews who they believe were trying to record the identity of certain protesters. As in the past these loosely affiliated, often multi-leadered groups act very spontaneously in a "pack mentality". We will continue to monitor all available resources and update information throughout the day.

MAY 30

JUSTICE FOR GEORGE FLOYD! DC CAR CARAVAN (CANCEL THE RENT)

Group will meet at the Rock Creek Tennis Center Parking area at noon and travel through the streets of Washington, DC in a car caravan. Exact route unknown, but group has stated that the last stop will be the MPD First District HQ. This group had a similar demonstration a few weeks ago and was attended by approx.200 people. While no attendance is being released, it is expected that the group will at least meet this prior attendance.

SAY THEIR NAMES PROTEST

Group will meet at the Navy Memorial at 1400 hours. Their stated plan is to march to the Department of Justice however there have been multiple postings that individuals plan to then move onto the White House. While this group has always stated that their protest will be peaceful, over the course of yesterday afternoon into this morning, their tone has changed somewhat to a more confrontational tone (a separate email to this group will document some planning verbiage released by the group). 

We are still going through the high volume of traffic on social media, but here is what we have so far for today. As an aside these "groups" are showing far more operational security than they have in the past leaving some unknowns in our reporting. Yesterday and early this morning this included violence against videographers and news crews who they believe were trying to record the identity of certain protesters. As in the past these loosely affiliated, often multileadered groups act very spontaneously in a "pact mentality". We will continue to monitor all available resources and update information throughout the day.

MAY 30

JUSTICE FOR GEORGE FLOYD! DC CAR CARAVAN (CANCEL THE RENT)

Group will meet at the Rock Creek Tennis Center Parking area at noon and travel through the streets of Washington, DC in a car caravan. Exact route unknown, but group has stated that the last stop will be the MPD First District HQ. This group had a similar demonstration a few weeks ago and was attended by approx.200 people. While no attendance is being released, it is expected that the group will at least meet this prior attendance.

- According to open source information, a group called Mochella will purportedly assemble at Black Lives Matter Plaza to hold a Go-Go event. Attendance unknown. VERY LOW level of concern at this time.xviii *
- A Facebook user created an event called "Luciferian March for a One World Government Washington DC." The event will purportedly take place at the White House on June 21 at 1400 hours. IIICD assesses that this event page is a joke and included for situational awareness only. VERY LOW level of concern at this time, there is only a REMOTE chance that this event will take place. xix
- IICD and MPD-HSB are tracking a social media group called "2 Million March" which plans to hold a DC-area protest at an undetermined future date. The group has over 129,500 members.
 No further information available at this time. **

Analyst Comments

Organizers publicize their events on social media in order to maximize attendance and participation. While the above protests are purportedly peaceful demonstrations, extremists seeking to commit acts of violence or property destruction may attach themselves to these events. Protesters may also change their location in response to police presence and crowd control measures. Additional spontaneous or unadvertised protests may also occur without warning. Officers should remain vigilant at all times.

IICD will continue to monitor the situation, identify information gaps, and provide updates as needed.



- Pre-staging of projectiles, bricks, rocks, sledge hammers, brass knuckles, spray paint and other weapons at protest locations.
- Presence of heavily armed protesters wearing body armor and having long guns.
- Frozen water bottles being unloaded from trucks.

Situational Awareness - NCR Demonstrations for the 08/28/20 - March on Washington Anniversary

Details

USSS PID is currently aware of 22 demonstrations occurring specifically on the 08/28/20 and five (5) of the groups are of record. As of now, there is no civil disobedience associated with the planned demonstrations. Open Source Branch will continue to conduct social media analysis through 08/28/20.

March on Washington Anniversary

There are several demonstrations being organized to commemorate the 57th anniversary of Rev Dr. Martin Luther King's "I have a dream" speech at the Lincoln Memorial. The groups plan to hold a rally called the "Get Your Knee Off Our Necks" in the vicinity of the Lincoln Memorial, MLK Memorial, Reflecting Pool, Lafayette Park and the Washington Monument from 08/27/20 through 08/30/20. At this time, it is not known how many will participate, the Park Service permit request cites 50,000 persons and Law Enforcement Officials have estimated about 30,000 persons.

A ** at the end of a paragraph indicates the demonstration taking place on 08/28/20 may not be correlated to the March on Washington Anniversary actives.

Participating groups include, but are not limited to:

On 08/28/20, at 5:30 AM to 4:00 PM, Hey Sis Inc (NRID) will host "Get On The Bus! March on Washington 2020" at the Lincoln Memorial. The purpose will be to demonstrate a commitment to fighting for policing and criminal justice. Organizers have coordinated travel from New Jersey by bus, which is scheduled to leave at 5:30 AM. A projected arrival time to DC has not been provided at this time. There is no mention of civil disobetions of anticipated participants are unknown. However, according to Facebook 476 are interested. No civil disobedience is expected. No known permit has been issued for this event.

On 08/28/20, from 6:00 AM to 8:00 PM, the group All FOR ONE, ONE FOR ALL (NRID) will host an event called "I HAVE A DREAM 2K20." The group is set to meet at the Lincoln Memorial in Washington, DC. Numbers of anticipated participants are unknown. However, according to Facebook 654 are interested. No civil disobedience is expected. No known permit has been issued for this event.



OSB Intelligence

As of 08/23/20, PID has not identified any subject or group planning criminal activity. OSB has not identified any protective intelligence information related to demonstration activity scheduled on 08/28/20; however, social media research efforts will continue for the duration of the events.


The below diagram depicts the walking path of the National Action Network's event scheduled for 08/28/20. As previously noted, the Park Service permit request cites 50,000 persons and Law Enforcement Officials have estimated about 30,000 persons. However, the organization is estimating over 48,000 are interested, with social media reflecting 17,000. It has also been reported over 100 buses will be traveling to the DC area for this event, and all bus parking spots are sold out at the greyhound station. Additionally, organizers for this event are reaching out to RFK stadium for additional bus parking. OSB continues to verify numbers of participants interested, and are looking for additional demonstrations in the area. We will continue to work with our local partners to ensure all assets are aware of the possible volume associated with the upcoming demonstrations.
