The NYPD found the following issues with your firm's prediction, please update accordingly.

The precinct submissions include prohibited grid IDs (e.g. 79612, 58429)

The borough submissions have issues. Each patrol borough should have a different number of submissions by crime type and tour (depending on the number of boxes that comprise 1% of land area, as described above). For example, in PBBN, there should be 72 boxes predict for assault for the first platoon, 72 predictions for assault for the second platoon, and 72 predictions for assault for the third platoon. KeyStats borough submissions vary, sometimes below and other times above the number of allocated boxes per patrol borough, crime type and platoon.
