Brennan Center for Justice Draft Vaughn Index

Pursuant to Endorsed Memo dated December 23, 2016, the Court directs the FBI to prepare a draft *Vaughn* index for Plaintiff by January 30, 2017, "setting forth details regarding the agencies withholdings and claimed exemptions." <u>See</u> ECF, Document 27.

The index will be grouped by the four remaining FOIA requests at issue for this litigation: FOIAs 1318794-000, 1318911-000, 1339634-000, and 1339641-000. A fifth FOIA 1320714-000 has been dropped from litigation consideration pursuant to a voluntary partial dismissal (See ECF, Document 19).

Therefore, below is a description of the FBI processed responsive records grouped by specific FOIA requests for information withheld in full ("WIF"), or in part ("RIP"), for Plaintiff's Brennan Center for Justice FOIA requests 1318794-000, 1318911-000, 1339634-000, and 1339641-000. If a WIF page was a duplicate of previously processed material it will be annotated as "DUP," and a location will be provided as to where the duplicate was originally processed. Pages released in full will be annotated as "RIF." For index purposes responsive pages will be grouped into document types. For example, if a group of emails pertaining to the same conversation (email chains) contains twelve pages overall it will be categorized as one document for index purposes.

For this draft index the FBI applied Bates numbers to each processed page, and *Vaughn* coded each category of exemption asserted to withhold information. On its face, coded categories of exemptions indicate the nature of the information withheld pursuant to the provisions of the FOIA. The coded categories are provided to the Brennan Center for Justice to assist in there review of the FBI's explanations of the FOIA exemptions it has asserted to withhold certain material. Each instance of information withheld on the Batesnumbered document is accompanied by a coded designation that corresponds to the justification categories as listed on a coding chart provided to the Plaintiff below at pages 3-4. For example, if "(b)(7)(C)-1" appears on a document page, the "(b)(7)(C)" designation refers to FOIA Exemption 7(C) protecting against unwarranted invasions of personal privacy. The numerical designation of "1"

following the "(b)(7)(C)" narrows the main category into the more specific subcategory, of "Names and/or Identifying Information of Third Parties Merely Mentioned." Additional underlying exemptions were asserted at the litigation stage for certain withheld information if it was determined additional exemption support was applicable. An "*" next to an exemption on the draft index will denote the additional exemption(s) asserted. In addition, several asserted exemptions in the original production may have been dropped after further review, and/or changed to reflect a more accurate exemption determination. Finally, additional segregable information was released in several locations of the production. The draft index will note these changes in the "Description" portion of the index. Please refer to the coding chart below when reviewing the draft *Vaughn* index and the coded production provided separately.

The Montgomery County (Maryland) Intervention and Prevention of Violence Subcommittee; c. The Montgomery County's Faith Community Working Group; and/or d. The Los Angeles Countering Violent Extremism/Interagency Coordination Group.

2. Records uploaded to the Law Enforcement Enterprise Portal Special Interest Group referred to in the October 2014 FBI Law Enforcement Bulletin article entitled, *A New Approach to Countering Violent Extremism: Sharing Expertise and Empowering Local Communities* ("the FBI CVE article") that cite, discuss or otherwise refer to the following: [Same items a-d as described above],

3. Written correspondences (including e-mails, regular mail and faxes) sent to or sent by the CVEO since August 1, 2011 citing, discussing or otherwise referring to the following: [Same items a-d as described above],

4. Any memoranda, policies and guidelines created by the CVEO other than those records responsive to paragraphs 1 to 3 of this request that cite, discuss or otherwise refer to the following: [Same items a-d as described above], and 5. Records created by the CVEO, including memoranda, PowerPoint slides, directives, policies and guidelines, describing: a. The FBI CVE Model referred to in the FBI CVE article; and/or b. Community action plans produced in the course of Community Resilience Exercises (CREX) referred to in the FBI CVE Article.

Search for Records:

The CVEO [targeted office reasonably likely to have responsive records] was contacted by RIDS on 1/7/2017, and requested a search of the five items, and sub-items, of Plaintiff's FOIA request. To assist the search CVEO was provided a copy of Plaintiff's FOIA request. The CVEO responded 1/27/2015 providing 26 pages of responsive materials for Plaintiff's FOIA request items 1-2 and 5a. As to items 3-4 of the FOIA request CVEO located no responsive records. Additionally, as to Plaintiff's item 4 concerning any "memoranda, policies, guidelines created by CVEO," RIDS was informed by CVEO that as of the search cut-off date (1/7/2015) the FBI CVEO is still leveraging existing FBI programs, funding, and initiatives, and has no other approved FBI CVE policies, directives, or procedures that apply to these activities, other than the directive used to establish the CVEO. The directive, signed in August 2011 and issued December 2011, is titled, "*Strategic Implementation Plan for Empowering Local Partners to Prevent Violent Extremism in the United States.*." As to FOIA request item 5b, CVEO explained that CREX is a Department of Homeland Security (DHS), National Counterterrorism Center (NCTC) program initiative, and the FBI CVEO does not have any records responsive to Plaintiff's request. By letter dated 6/3/2015 plaintiff was advised 26 pages were reviewed and 25 pages were released. An additional inquiry with the CVEO at the litigation stage concerning Plaintiff's question 5a [CVE Model] led to an additional 11 pages processed. By letter dated 6/30/2016 Plaintiff was advised 11 pages released.

Search for Records:

The CVEO [targeted office reasonably likely to have responsive records] was contacted by RIDS on 1/21/2017. RIDS requested a search of the two items, and sub-items, of Plaintiff's FOIA request. The CVEO responded on 1/22/2015, providing 29 pages of responsive

materials for Plaintiff's FOIA request. As to Plaintiff's request concerning any "policies, procedures, and directives referencing FBI participation in CVE programs," RIDS was informed by CVEO that as of the search cut-off date (1/5/2015) the FBI CVEO is still leveraging existing FBI programs, funding, and initiatives, and has no other approved FBI CVE policies, directives, or procedures that apply to these activities, other than the directive used to establish the CVEO. The directive, signed in August 2011 and issued December 2011, is titled, "*Strategic Implementation Plan for Empowering Local Partners to Prevent Violent Extremism in the United States.*" By letter dated 6/3/2015 plaintiff was advised 29 pages were reviewed and 28 pages were released. Plaintiff appealed to OIP by letter dated 7/31/2015 concerning the adequacy of FBI's search and assertion of FOIA Exemptions b1, b3, b5, and b7E. Following plaintiffs appeal (request remanded), the FBI conducted further follow-up inquires to FBI Field Offices in Boston, Los Angeles, and Minneapolis and Saint Paul were made as to potential responsive records specific to Plaintiff's request. An additional inquiry with the CVEO concerning the directive FBI used to open the CVEO, and a new inquiry with the Office of Partner Engagement ("OPE) at the litigation stage concerning potential responsive Memo of Understandings (MOU), led to the identification of an additional 23 responsive pages. By letter dated 6/30/2016 Plaintiff was advised 23 pages were reviewed and 23 pages released.

Search for Records:

A search conducted 11/17/2015 of the Central Records System (CRC) and Sentinel led to no responsive records. The CVEO was contacted on 11/18/2015 concerning both subject lines of this request, and they referred RIDS to the Office of Public Affairs ("OPA"), since "Don't Be a Puppet" is an OPA developed interactive program. At the litigation stage the CVEO and OPA received a targeted search request (offices reasonably likely to have responsive records). CVEO and OPA were requested to search for the eight items of Plaintiff's FOIA request. OPA also requested the Office of Partner Engagement ("OPE") to assist in the search for responsive records. To assist the search CVEO and OPA were provided a copy of Plaintiff's FOIA request. CVEO, OPA and OPE responded to the search request with potentially responsive records for both subjects. For subject "Don't Be a Puppet" (items 1-6) RIDS reviewed and identified 1,428 pages responsive to Plaintiff's request. By letter dated 6/30/2016, the Plaintiff was advised for their first interim release 559 pages were reviewed and 328 pages released. Finally, by letter dated 9/29/2016, the Plaintiff was advised for their final interim release 584 pages were reviewed and 192 pages were released (inadvertently RIDS stated 584 pages reviewed, but it was actually 581).

Search for Records:

A search conducted 11/17/2015 of the Central Records System (CRC) and Sentinel led to no responsive records. The CVEO was contacted on 11/18/2015 concerning both subject lines of this request, and they referred RIDS to the Office of Public Affairs ("OPA"), since "Don't Be a Puppet" is an OPA developed interactive program. At the litigation stage the CVEO and OPA received a targeted search request (offices reasonably likely to have responsive records). CVEO and OPA were requested to search for the eight items of Plaintiff's FOIA request. OPA also requested the Office of Partner Engagement ("OPE") to assist in the search for responsive records. To assist the search CVEO and OPA were provided a copy of Plaintiff's FOIA request. CVEO, OPA and OPE responded to the search request with potentially responsive records for both subjects. For subject "Shared Responsibility Committees" (items 7-8), RIDS reviewed and identified 1,061 pages responsive to Plaintiff's request. By letter dated 7/28/2016, the Plaintiff was advised for their first interim release 567 pages were reviewed and 520 pages released. Finally, by letter dated 8/31/2016, the Plaintiff was advised for their final interim release 494 pages were reviewed and 343 pages were released.
