Overview

This memorandum outlines the criteria used to specify what is considered a restricted case and when is an Immigration Judge (IJ) decision required to accompany a Board decision for reporting purposes at the Board. Details of the criteria for a restricted case and IJ decision requirement can be found in the section below.

Identifying Restricted Cases

A restricted case includes at least one of the following relationships between entities consisting of the Case Monitoring Description, IJ Application Description, Special Issue Description, Appeal Type, Appeal Issue Description, Case Type, Board Decision, Release Information, Battered Spouse or Child, Protective Order Motion filed with the IJ, Alien Name, Claimed Status, and Court App Code.
