Hi Claudia and Frank,

A couple questions regarding the Predictive Policing evaluation on file specifications for the daily updates:

1. When we received the initial crime data, shooting and non-shooting crime data came in different files and different formats. For the daily data, what file and format can we expect? For example,
  - Will the shooting and non-shooting data come in different files or one file?
  - Will the format (of both headers and rows) match the original files or will it be different?
2. Are the 'OCC TIME' and 'Occurrence Time' fields localized to the US/Eastern timezone? (as opposed to UTC, for example)
3. For the evaluation, we are to provide borough-wide predictions and precinct-wide predictions. However, given the provided Prediction Template, how should we be indicating whether a prediction is borough- or precinct-wide?
4. The overall (composite) category isn't represented in the Prediction Template. What should this category be labelled in the predictions?
