Hi Jeremy,

I just wanted to give you a status update on the proposal/contract...

We are working with ITB here at NYPD. The goal is to have them review the technical aspects of the proposal and provide feedback. It is essential that we have their buy-in/support as they are a key stakeholder. We have asked that they be as quick as possible in their turnaround. However, as our priorities may not be in sync with theirs, the timing of their review is uncertain at this point.

As you know, we have also been working with our contracting group and they have asked for additional clarifications in the language of the proposal.

I am not sure how you want to handle these two possible revisions? I can provide the items we have now and then provide ITB's at a later date, or we could wait until ITB is done and do one set of revisions then.
