# Phil Murphy

#### Governor of New Jersey

Phil Murphy is the 56th governor of New Jersey. Prior to being elected governor in 2017, he and his wife Tammy founded New State New Jersey as a "think and do" organization to rebuild the state's economy from the middle

class out. Before that, he served as the U.S. ambassador to Germany under President Barack Obama and as finance chair of the Democratic National Committee. Governor Murphy has also proudly served as New Jersey's sole representative on the board of the NAACP, has helped lead local charities to support troubled teens and domestic abuse survivors, and has led national and state task forces on education and public employee pensions and benefits. As governor, his mission is to make New Jersey more fair and just for all residents. Governor Murphy is committed expanding access to democracy, including by restoring voting rights to individuals on probation or parole.



### **Justin Allen**

#### Community Organizer, Millions for Prisoners New Mexico

Justin Allen spent approximately 17 years in prison and has been witness to the detrimental effects that the prison industrial complex has on our society. Civic engagement

is what allowed him to reintegrate into the community. Justin is currently pursuing his BA in sociology and criminology at the University of New Mexico and is passionate about using his experience to help those directly impacted by mass incarceration.



### **Rachel J. Anderson**

#### General Counsel, Office of the Nevada Attorney General

Rachel J. Anderson is a professor at the William S. Boyd School of Law at the University of Nevada, Las Vegas. She earned her JD from U.C. Berkeley School of Law and her

MA in international policy studies from Stanford University. She hosted the Youth Voting Rights Project, in collaboration with Dr. Zachary Robbins, with the goal of helping educate Nevadan high school and middle school students on the topic of election law.



### Juan Cartagena

President & General Counsel, LatinoJustice PRLDEF

Juan Cartagena is the president & general counsel of LatinoJustice PRLDEF, a national civil rights public interest law office where he litigates, advocates and researches how Latinos are uniquely harmed by racial profiling, exces-

sive policing, prison gerrymandering, disfranchisement, outdated drug policies, the private prison complex, employment discrimination, and crimmigration.

Dauras Cyprian was formerly incarcerated and is currently on parole in California. The goal of All of Us or None is to unite and strengthen the voices, visibility, and leadership

of those formerly incarcerated. Cyprian is currently working to restore voting rights for people on parole. He holds a BS in social science and is pursuing his masters in nonprofit administration.



# **Anthony Dixon**

#### Director of Community Engagement, Parole Preparation Project

Anthony Dixon advocates on behalf of and provides direct support to currently and formerly incarcerated people serving long and life sentences in New York State. While

incarcerated, he received commendations for developing anti-violence and therapeutic anti-drug programs. Dixon is a National Lawyers Guild distinguished scholar and recipient of the RISE Award and Freedom Fighter Award.



# Jena Marie Griswold

#### Secretary of State, Colorado

Jena Marie Griswold grew up in a working-class family in rural Colorado and knows first-hand how important it is for every vote to count and for every Coloradan's voice to be heard, no matter their background or income. Griswold

holds a BA in politics and Spanish literature from Whitman College and a JD from University of Pennsylvania Law School.



# **Alexes Harris**

#### University of Washington Presidential Term Professor, Department of Sociology

Dr. Alexes Harris was recently awarded the Distinguished Teaching Award (2018) at the University of Washington. Her book *A Pound of Flesh: Monetary Sanctions as a* 

*Punishment for the Poor* (2016), details how fines and fees place an undue burden on disadvantaged populations. Dr. Harris earned her BA at the University of Washington and her PhD from the University of California, Los Angeles.



# **Holly Harris**

#### President and Executive Director, Justice Action Network

Holly Harris has led campaigns to pass significant criminal justice reforms across the country and at the federal level. She is also a veteran litigator, conservative commu-

nicator, and campaign strategist who has also served in senior leadership roles for elected officials in Kentucky. Harris graduated from the University of Kentucky College of Law.

Pastor Jim Liske was lead pastor at Christ Memorial Church in Holland, Michigan. He also served as president and CEO of Prison Fellowship Ministries and was on the Colson Congressional Task Force for Federal Prison

Reform. Before leading Prison Fellowship Ministries, he also served churches in Canada. Pastor Liske is chairman of the board of Crossroads Prison Ministries.



### **Jhody Devon Polk**

#### 2018 Soros Justice Fellow

Jhody Polk is a 2018 Soros Justice Fellow. In 2018, she established the Jailhouse Lawyers Initiative. She is also the founder of the Florida Council for Incarcerated & Formerly Incarcerated Women and Girls, and of the Legal

Empowerment & Advocacy Hub- L.E.A.H, the first participatory defense hub in the state of Florida.

deputy commissioner of the Minnesota Department of Corrections. Walker previously worked in public relations and government affairs, focusing on issues in public safety, corrections, and the judiciary.



### **Andrew Warren**

#### State Attorney, Florida's 13th Judicial Circuit, Hillsborough County

Andrew Warren is the elected state attorney for Florida's 13th Judicial Circuit. Since taking office in 2017, he has created successful diversion programs to hold low-level

offenders accountable while steering clear of the system's downward spiral. Warren studied at Brandeis University before receiving his law degree from Columbia University.
