Elisa Dreier Reporting Corp. (212) 557-5558 780 Third Avenue, NY, NY 10017 1 PROCEEDINGS 2 ROBERT SWEAT, having been first duly sworn by the Notary 3 Public (Donna L. Peterson), was examined and 4 testified as follows: 5 6 MS. SIMONOFF: My name is Jessica 7 Simonoff. I'm from Debevoise and Plimpton, and I am representing plaintiff, League of Women Voters. 8 9 Would you like to introduce yourself? MR. ANTONACCI: No. Go ahead. 10 11 MS. SIMONOFF: Okay. 12 EXAMINATION BY 13 MS. SIMONOFF: 14 All right. I am going to ask you some Ο. questions about facts related to this lawsuit. 15 you know, this deposition is being transcribed and 16 your testimony may be read at trial under certain 17 18 circumstances. Please answer all questions aloud so 19 that the reporter can make an accurate record. 20 you do not hear a question, please say so and I will 21 repeat it. If you do not understand a question, 22 please say so and I'll rephrase it. If you do not know or do not remember the information necessary to 23 24 answer a question, please say so. If you answer a 25

1 Can you briefly describe for me how an Ο. individual in this county can register to vote. 2 3 Α. Well, really pretty easy. We have upward to 250, 260 locations here in Manatee County 4 where they can pick up an application, they can get 5 it off our website, or they can call and we can mail 6 7 them an application if they -- if they need one that way. And then we -- I have a program where I go to 8 9 all the high schools and register high school seniors that are 17 or some 18 that are ready to 10 11 register at that time. So we have a pretty thorough 12 outreach opportunity for anybody that wants to register. 13 And could you please describe some of 14 Ο. the categories of these places where people can go 15 to pick up applications. 16 Almost any bank. Probably 60 percent of 17 Α. 18 the banks in Manatee County will have -- we have the 19 little counter folders that hold the applications. All of the elected officials have them in their 20 offices, the constitutional offices, the county 21 22 commissioners. The school board has them. We have real estate offices that have them. And junior 23 college, community college has them. So they are 24 all over the county, the applications are. 25

1 So you have said that people can 0. 2 register with paper applications or by telephone. Can they also register electronically? Is there any 3 other way? 4 No, they can't register by telephone. 5 Α. 6 Oh, okay. 0. 7 Okay? But they can download the Α. application, fill it out, and mail it in to us. 8 The 9 thing that we require other than the obvious boxes that they have to check, you know, to be qualified 10 11 to register to vote is the signature on the 12 application. 13 Okay. Who in your office is responsible Q. for ensuring that voter applications are processed? 14 My assistant will handle part of that, 15 Α. Linda Gabler, who is one of the deputies; Linda 16 Cobb, another deputy; and then I have -- I have 17 18 three others that can assist them in doing this if 19 they need help with it. 20 Q. What is your assistant's name? 21 I'm sorry? Α. 22 Your assistant's name? Q. 23 Α. Nancy Bignell, B-i-g-n-e-l-1. And are you describing for me the 24 Ο. full-time employees who process voter applications? 25

1 MS. SIMONOFF: Okay. Please mark as 2 Exhibit 2 a two-page copy of a Florida voter 3 registration application. 4 (Exhibit No. 2 was marked for identification.) 5 THE REPORTER: You will get this one. 6 7 THE WITNESS: I have thousands of them back there, so. 8 9 BY MS. SIMONOFF: Q. So could you please describe what this 10 11 document is? A. Okay. This is a Florida state voter 12 registration application that a person needs to fill 13 out and complete specific data on there, send it to 14 our office, and have it processed to be able to 15 register in Manatee County. 16 Okay. Could you please look at field 17 0. 18 16? 19 Α. Uh-huh. 20 Q. Do applicants always date this field? You mean by signing the application? 21 Α. 22 Q. By writing the date next to their signature. 23 I can't answer that. I don't know. 24 Α. I'd have to ask one of my staff. 25

1 Is it required for processing that the 0. 2 date be there? 3 Α. The date, a date there that the person put in that filled out the application? 4 Where it says "date" next to signature, 5 0. presumably the applicant is expected to write their 6 7 signature and then write the date next to it? Yeah, I -- I'm not sure, but I think we 8 Α. 9 require that. I mean, because that is part of the application so that we know when they, you know, 10 when they filled it out. 11 12 Q. Okay. A. We -- we time clock everything that 13 comes in here anyway, so we know the date that we 14 got it. But we don't always know the date that the 15 16 person filled it out, you know, what the date was when the person filled it out. So yeah. 17 18 Q. Okay. So presumably you could have a document -- sorry. You could receive a voter 19 20 registration application that's undated, and it might still be processed? 21 22 A. I don't know. And who would know? 23 Q. Well, I could ask Nancy or one of the 24 Α. processing agents back there. I just -- it's just 25

1 something that I have never crossed over before so I don't really have an answer for you. 2 3 MS. SIMONOFF: Thank you. Please mark as Exhibit 3, a one-page 4 5 document with a title "Voter Registration" written at the top which appears to be a record of voter 6 7 registration applications submitted by Pat Arends of the League of Women Voters of Manatee County on or 8 9 about August 7th, 2004. (Exhibit No. 3 was marked for 10 11 identification.) 12 THE WITNESS: That is in your paperwork 13 here, too. 14 MR. ANTONACCI: She just gave me a copy. 15 THE WITNESS: Oh. 16 BY MS. SIMONOFF: Do you recognize this form? 17 0. 18 Uh-huh. Α. 19 0. Could you please describe it for me? This is the log that -- I don't know who 20 Α. brought it in, but I'm assuming that Pat brought it 21 22 in. And she has got some information on here that "new or update, hasn't voted in many years." She is 23 just giving us some information on the -- on help, 24 to help us process the paperwork on that. 25

1 Then a change of address, another change 2 of address. And then she is telling us that she has 3 got three people on the bottom here that has 4 requested absentee ballots. 5 What is this form used for? 6 0. 7 This is a log form that we try to give Α. to the person that's going out and registering 8 9 voters, so. We -- Everyone doesn't take them, but we 10 encourage them to do it for their benefit and for 11 the registrant's benefit and our benefit. So that 12 when they come back in here, we have a little track 13 record of what's going on with them. 14 Why do you think it benefits the 15 0. 16 organization? The organization that's doing the 17 Α. 18 registering? 19 Q. Yes. Well, I think it helps them out because 20 Α. if they go out and register some people and then a 21 22 person calls me up and says, "We haven't got our voter registration card," and then I can find out 23 who registered that person. I can go back and look 24 on the log and see if it's not there. Then I could 25

1 call Pat and say, "Could you check, you know, your information or to see if maybe this is an 2 3 application that was missed being turned in?" So it kind of protects everybody really, 4 but mainly the person that is registering to vote. 5 6 Because it has happened in the past where a person 7 would come in on election day to vote and we would not have any record of that. And we would go back 8 9 and look, and we had absolutely no record of it but they said, "But I registered at the driver's license 10 11 bureau." And they are not going to get to vote that day, and that's unfortunate. So if we can remedy 12 that before the election, it helps everybody. 13 O. But you don't require organizations to 14 15 use this form? 16 A. No. O. And when do they receive this form from 17 18 you? 19 A. If they come in and tell us that they 20 are going to have a voter registration drive, we try to give it to them right then. If they have come in 21 22 and they have had a voter registration drive and they bring the applications in, we ask them if they 23 would just sit there and fill this out with each one 24 of the application's name. And then we date it and 25

1 the person that brought them in. 2 And I think I mentioned to you earlier, 3 some people just bring in a stack and throw them on 4 the counter. And we just log them in ourselves then on a sheet similar to this. You will find some of 5 6 them with the name of no one in there that brought 7 them in, because we don't know. Q. Okay. So a member of the third-party 8 9 organization fills this form out? A. Uh-huh. 10 11 Q. And no member of your office fills it 12 out? A. Well, I can't say that. Because 13 sometimes they will bring the applications back with 14 this form and sit down up at the counter. And it's 15 a little bit faster sometimes if my people assist 16 them with the -- with the -- you know, filling in 17 18 the applications on there. So it's not totally out 19 of the question to have one of my staff help them fill them out if they haven't got it filled out. 20 O. Is this form also used when applications 21 22 are mailed in? A. No. Oh, well, let me clarify that. If 23 someone were to mail me in 10 or 15, yes. And then 24 I would put the person that mailed them in, and then 25

- we would log it in. If it just comes in a daily
 mail, no.
- Q. Okay. Do you see the stamp near the top
- 4 of this document?
- 5 A. Uh-huh.
- Q. Can you read the date on that stamp?
- 7 A. No.
- Q. It's very difficult to read, but it
- 9 looks to me like it's August 10th, 2004.
- A. Uh-huh.
- 11 O. Does that -- is that what it looks like
- 12 to you?
- A. Uh-huh.
- Q. Okay. Can you see there is a stamp at
- the bottom of the document as well?
- 16 A. Yes.
- 17 O. Can you read the date on that stamp?
- A. August 9th.
- Q. Okay. What is the purpose of these
- 20 stamps?
- A. Well, the purpose of a stamp on here --
- I don't know why there is two on here. The purpose
- of the stamp is so we will know the date that they
- 24 brought them in and the time.
- Q. Is this primarily how you keep track of

1 when voter registration applications come into your 2 office? 3 A. From a third party? 4 O. From third parties. 5 A. Yes. 6 O. And you said that you don't know why 7 this application would have two stamps on it? A. No. 8 9 Q. Do you have any idea why those two stamps would be different from each other? 10 11 A. No. Q. Do you have any idea why those two 12 stamps -- well, withdrawn. 13 Do you see at the top of the page, it 14 says "date registration submitted"? 15 16 A. Yes. Q. And can you read the date there? 17 18 A. 8/7/04. 19 0. Do you have any idea why the dates on the stamps, either one of them, would differ from 20 the date written in the "date registration 21 22 submitted" line? A. Yeah. They could have -- they could 23 have been out there registering these people a week 24 or two weeks before or five days before and wrote 25

- that date in there before they brought it in to us.
- And we just stamp them in the day they come in. So
- 3 that could vary from, you know, application to
- 4 application.
- Q. Okay. Why do you have a space for the
- 6 staff member's name on this form?
- A. Because we would like to be able to go
- 8 back and reconcile with any problems that we have
- for it; or if we have any questions, we can go back
- and ask the staff member that put it -- you know,
- 11 checked it in.
- Q. On this particular example, it doesn't
- look to me like there is a staff member's name. Do
- 14 you agree?
- A. Uh-huh.
- 16 Q. Does that happen? Is that common?
- A. I don't think so. But it's -- it's very
- possible. And particularly if Pat brought them in,
- I can see them not signing. We see her every day.
- 20 She is very, very good at what she does. I can see
- 21 maybe a staff member not signing, you know, the
- 22 sheet.
- 23 Q. Thank you. Now, after your staff member
- completes Exhibit 3, does that person then record
- 25 the information in the form or associated with the

- or an error was brought to your office by a
- 2 third-party organization, do you also follow up with
- 3 that third-party organization?
- 4 A. No. Just the voter or just the person
- 5 that is trying to register to vote.
- 6 Q. And I think you said that you do not
- 7 keep track of applications with omissions or errors?
- 8 A. No. Well, keeping track, now, we keep
- 9 that application in file until we get the
- 10 information back from the voter. If we never get
- 11 the information back from a voter, then it stays in
- 12 a pending file.
- But we process those immediately, and
- then once we do that, it's in the hopper with
- everybody.
- Q. Okay. Are you familiar with the
- third-party groups that conduct voter registration
- 18 in your county?
- A. Some.
- Q. Which ones?
- 21 A. The League of Women Voters. We have the
- 22 community college register -- you know, they have
- 23 voter registration drives. We have a Kiwanis Club
- that does voter registration drives; they do it for
- 25 us. And there may be several others smaller groups

1 that do that if they are local. 2 And we don't keep -- I don't have a log 3 of, you know, these are the available people that 4 can --If -- and one of the things that we try 5 6 to do here, if we can assist a third party with a 7 voter registration drive, we can and we will. If we are busy, we can't. I always recommend they call 8 9 the league and ask for their assistance if they can help them, because they are very good at what they 10 11 do. And I have very few mistakes if any from, you know, the league; because, see, when they get a 12 13 registration, they check it over to make sure that people didn't leave out any information off of it. 14 The local third-party registration 15 are -- or the third-party people that we have here 16 17 in Manatee County are very, very, very good. We 18 have zero percent, hardly, problems with any of 19 those. It's the ones that are from out of town that 20 come in here and try to flood the market that don't 21 pay any attention to what's going on that we have 22 encountered problems with in the past. Okay. Well, let me go back a step. You 23 0. 24 said that certain groups conduct voter registration drives for you, for your office? 25

- or whatever they give to us is we had one that was
- 2 out of Texas that was down here. And there was just
- 3 no communication. They were very demanding. You
- 4 know, they would come in. They wouldn't talk to you
- 5 about the process or making sure they would fill it
- 6 out properly. They wouldn't talk to us about a time
- 7 frame. All they would do is come in here and want
- 8 200 applications, and then they would get those if I
- 9 had them and they would leave.
- 10 Q. Okay. And you had no contact really
- 11 with those groups, but you did -- sorry.
- 12 A. That's okay. Go ahead.
- 13 Q. But just for me to be clear, the
- 14 coordination efforts that you just described that
- 15 you do presently, did you do those efforts in 2004
- 16 with the local groups?
- 17 A. Oh, yeah, yeah. I didn't have any
- 18 problems with any local groups in 2004.
- Q. Okay. Did you keep track in 2004 of
- which applications were submitted by third-party
- 21 groups?
- A. No. Well, let me rephrase that. Yes,
- 23 they are in -- there is some in here, that
- third-party groups coming in and turning in
- 25 applications.

1 O. And when you say "in here," you are referring to the voter registration logs? 2 3 A. Uh-huh, yeah. Q. But that's it? 4 5 A. Uh-huh. Okay. How about in 2006, do you 6 0. 7 remember how many third-party groups were operating in your county in 2006? 8 9 Well, basically just our locals. Α. don't recall an outside, out-of-the-state group. 10 We had, obviously, the parties statewide 11 You know, they were getting signatures, 12 were out. they were getting everything, and they were 13 registering people. 14 But no -- and we did not -- we did not 15 have any -- I don't know how to -- I don't know how 16 to say this. But most of ours were local and state 17 18 and county that we had. We didn't have any problems 19 with that either. 20 Ο. Okay. And did your office conduct the same kind of outreach activities as you had just 21 22 described you're presently doing? Uh-huh. 23 Α. And did you keep track of which 24 0. applications were submitted by third-party groups in 25

1 2006? 2 Α. Yes. 3 Q. Did you keep track of them using the same voter registration log? 4 5 Α. Uh-huh, yes. Are you familiar with the term "book 6 0. 7 closing date"? 8 Yes. Α. 9 Could you please describe what it means? Q. Well, 29 days before the election, the 10 Α. state law says that all registration books will 11 close until after the election. 12 13 Q. Has the League of Women Voters ever submitted voter applications to your office after 14 the book closing date for a federal primary or 15 16 general election? Not to my knowledge. 17 Α. 18 Has the AFL-CIO submitted voter Ο. 19 applications to your office after the book closing date for a federal primary or general election? 20 Not to my knowledge. 21 Α. 22 0. Have other third-party voter registration organizations done the same? 23 In 2004 I had -- and I don't know how 24 Α. many, but I did -- we did pick up on some that came 25

- in after the books closed that were dated prior to
- the books closing, but they came into the office
- after the books closed. I don't know how many there
- 4 was, and there was not a great deal of them, but
- 5 there were some.
- 6 Q. Do you have any idea who delivered them?
- 7 A. The -- none of the local ones did. The
- 8 local people know the rules, and they know the law
- and they follow them. It's the ones that are from
- out of the state or someplace that try to skirt the
- issues every time.
- Q. Was there any reason given for the late
- 13 submission?
- 14 A. No. They just bring them in and throw
- them on the counter and leave.
- Q. Thank you. Do you remember
- approximately how many voter registration
- applications you received in the two months before
- book closing deadline for the 2004 presidential
- 20 election?
- 21 A. No.
- Q. Do you have any record of those numbers?
- A. There, you know, there is a possibility
- that we could give an estimate. Because what we
- would do is we would take the number of registered

1 voters prior to the two months, and then at the book's closing we would go back and figure out how 2 3 many registered voters we had, and that would 4 probably give you a guesstimate of how many people you had register. 5 MS. SIMONOFF: Okay. Please mark as 6 7 Exhibit 5 a copy of Roberts Sweat's testimony in the case of Diaz. 8 9 (Exhibit No. 5 was marked for identification.) 10 11 BY MS. SIMONOFF: Q. Could you please turn to the last page 12 of this handout. 13 Do you recognize this as your testimony? 14 A. Yes. 15 Q. Thank you. Could you please take a 16 moment to look at your answers on page 350, line 22, 17 18 down through page 351, line 7. 19 A. 350? 20 Q. Right here. A. Okay. 21 22 Q. Just through there. A. Okay. I said that, yes. 23 O. Okay. So what you are referring to is 24 your testimony in Diaz that members of third-party 25

1 groups kept applications in their cars for three to 2 five weeks before submitting them on the last day 3 before book closing deadline for the 2004 presidential election; is that correct? 4 5 A. Uh-huh. 6 Q. When did you first learn about this? 7 A. Well, when they would bring in a stack of applications. And I -- I don't know they kept 8 9 them five weeks or four weeks. But what we would get is, we would see the date on the application, 10 11 and we would look at the date that we got them. And we would see that they had been held longer than we 12 would normally ask people to bring them in to us. 13 I don't recall other than, like I 14 explained to you just a little bit earlier, and 15 maybe two or three instances where we found an 16 application, you know, that was turned in after the 17 18 books closed. There wasn't a lot of those, but 19 there was several that was like that. But they would hold them. You could see by the dates of when 20 we got them and, you know, when they filled out the 21 22 application. O. So all of these applications were dated? 23 A. I don't know that all of them were. I 24 mean, that's going back to 2004. And I don't recall 25

1 if they were all dated. But I would think that most 2 of them were, yeah. 3 Q. Did you see the applications yourself? 4 A. No. 5 Q. Was it a requirement that they be dated 6 in order for them to be processed? 7 A. No, not by me. Q. You said that third-party group members 8 9 kept these applications in the trunks of their cars. How do you know that? 10 11 A. They kept them. Q. They kept them? 12 A. I'm assuming that, you know, the back 13 seat or the trunk. That is usually where everything 14 15 goes. O. So you didn't see them in the trunk? 16 17 Α. No. Q. You didn't see them in the back seat? 18 19 Α. No. 20 Q. Did any members of these organizations tell you that they were storing documents -- sorry, 21 22 applications in their cars? 23 A. No. Q. Did any member of your staff tell you 24

that members were storing applications in the trunks

25

1 or backs of their cars? 2 A. No. Q. Did you see them taking applications out 3 4 of their cars? 5 A. No. 6 O. Did you see them with the applications 7 at any time before that, before they brought them to your office? I can withdraw that. 8 9 A. Just trying to -- I'm trying to determine if seeing them registering people and 10 11 seeing the applications were the same thing. Q. That's fair enough. Let me withdraw and 12 rephrase the question. 13 Did you see them putting the 14 applications in their cars or in any other storage 15 16 area? A. No. 17 18 Q. How many applications do you think were 19 delivered in this manner? A. I don't know. 20 Q. Would anybody in your office know? 21 22 A. If they did, it would be a guess. Q. Do you have any record of how many 23 applications were kept in cars for three to five 24 weeks before being delivered? 25

1 A. No. 2 O. How were these applications ultimately 3 delivered to your office? A. The individual would bring them in to 4 the front office, and we would accept them at that 5 6 time. 7 O. So they were all delivered in person? A. Well, I can't say that they were all 8 9 delivered in person, because from time to time -and I don't know about that particular time frame. 10 11 From time to time we will get some in the mail, you know, a package of three or five or whatever in the 12 mail. But most of those came in over the counter. 13 O. Over what period of time were these 14 documents delivered to your office? 15 A. I don't know. We started taking -- we 16 started taking --17 18 Started taking. 19 We never start taking. We take them all 20 the time. And you know, I don't know from special 21 22 interest groups or third-party groups. I don't know when they brought them in. They just -- they bring 23 them in all year. 24

Q. Sorry. Let me be more clear.

25

1 A. Okay. 2 Q. The documents -- sorry. The 3 applications that you think were kept in people's cars or back seats or perhaps elsewhere, over what 4 period of time do you think these were delivered to 5 6 your office? A. I don't know. 7 Q. But it wasn't just on book closing date? 8 9 A. We had -- we had quite a few, you know, the few days leading up to book closing. But I 10 11 don't know that either, how many. Q. Did your office date stamp these 12 applications when they were received? 13 14 A. Uh-huh. Q. Do you know who delivered these 15 applications when they were delivered by person? 16 A. Not unless they filled out one of the 17 18 forms. 19 And is it the same answer for which 20 voter registration organization they were with? 21 A. Uh-huh. 22 Q. Do you know when these organizations collected the voter registration forms from the 23 24 applicants? 25 A. No.

1 O. Do you know whether these organizations 2 collected and submitted the forms to you in the 3 course of one day or whether perhaps they were 4 collecting them over time? A. I don't know. 5 6 O. What did you do with these applications 7 once you had received them? A. We process them. 8 9 Q. Did you attempt to determine whether those applications were submitted close to the time 10 11 that the voter signed the registration form? A. Not really. 12 Q. Did any of the applicants complain to 13 vou about this issue? 14 A. I don't recall anyone complaining. 15 O. Did you follow up with anyone after this 16 had happened? Did you contact the Secretary of 17 18 State to talk about what had happened? 19 Α. No. 20 Q. Did you contact anybody else to talk about what had happened? 21 A. No. 22 23 Q. Did you process all of the applications that were submitted by eligible applicants? 24 A. If they were eligible, we processed 25

- them, yes, if they were turned in before the day of book closing.
- Q. And were they all able to vote in the
- 4 November election?
- A. If they wanted to. We processed them
- and sent them a voter registration card, so then it
- 7 was up to them to go. But, yes, I think they all
- 8 had the opportunity.

Is there a limit on how long you can 10 Ο. 11 wait before you enter the application? 12 Α. Not that I am aware of. 1 voter registration organizations that submitted 2 applications received those forms from voters? 3 A. No. We don't -- once they pick them up, it's rare that they sit down and discuss with us, 4 you know, "We got so many of them and did so many on 5 6 Tuesday." I mean, they just don't do that. So we don't ever really know how many they register until 7 the registration drive is over. Then we know how 8 9 many they bring in to us. Q. Did you make any attempt to determine in 10 11 2006 how much time had passed between the date when the voter signed the registration form and the date 12 when the organization submitted it? 13 14 A. No. Q. Do you have any information or knowledge 15 that third-party groups held on to these 16 applications for more than ten days at that time --17 18 A. No. Q. -- before submitting them? 19 20 Could you please describe generally the types of election preparation tasks that your office 21 22 was responsible for in 2004 before the presidential election. 23 You want the process that we do in 24 Α. preparation for an election, is that what you are 25

1 asking? That would be great. Thank you. 2 0. Okay. The -- well, we start off, 3 Α. obviously, by training our poll workers, making sure 4 that we have all of our polling locations contracted 5 to be -- to be used on election day. We have the --6 7 our absentee ballots that we, you know, try to advertise; people can request by, you know, coming 8 9 in and picking them up or by phone or whatever. make sure that we mail those out. We absolutely 10 meet the deadline for our overseas military ballots 11 that go out of here. We handle the qualifying of 12 the local candidates. We process those, send them 13 to the state, wait for the state to send us the ones 14 that they have certified and qualified. Then we lay 15 our ballots out. We order our ballots. We get our 16 absentees in first. We mail those out first. 17 18 get our military first, mail those. Then the 19 absentees, we mail those. And then we process and prepare the ballots for the precincts. We deliver 20 our voting equipment to the polls. And on the day 21 22 before the election, our clerks pick up the pertinent data that they need. Obviously we are 23 programming our tabulators. We are programming 24 our -- the events for our voter registration at the 25

1 Then we hope and pray that everything works. polls. 2 Are many of these tasks ongoing during 3 the two months prior to the book closing deadline? Actually earlier than that. Α. Yes. 4 From the -- to the date of the election. 5 yes. 6 Are they all ongoing during that time 0. 7 period? Uh-huh. 8 Α. 9 Did your office in 2004 have any plan to Q. increase staffing in order to complete the tasks 10 11 that you had to complete before the 2004 presidential election? 12 And again, as I explained to you 13 Α. No. earlier, I'd rather pay the overtime to my staff 14 that are experienced and trained in all the jobs 15 that we do than to bring somebody in part-time and 16 try to spend the time training them and then 17 18 worrying about the problems that you might have. It 19 might be archaic to some, but it works for us. 20 Ο. Did the tasks that you had to complete 21 during the two months prior to book closing deadline 22 differ in the 2006 election from the 2004 election? 23 Α. No. The basic concept is the same. 24 prepare and prepare, prepare, prepare and then hope, 25 you know, that you have done your prep work and that

But, you know, if you have 19 somebody just come in and throw applications up on the counter and say, "These are registrations" and 20 leave without any communication with them, that's a 21 problem to me. 22 We have a very open line of 23 communication with all of our third-party groups 24 here in Manatee County, and that doesn't happen with 25

1 They come in. We talk about it. And some of them. those just didn't, you know. We just had no 2 3 communication with them at all. We had -- and I can't -- I didn't 4 mention this because I can't prove it. It was just 5 simply a phone call. But I had a couple of phone 6 7 calls from people saying that people were coming up to their door, asking them to register to vote and, 8 9 you know, and they didn't want to register to vote and they were kind of forceful in that. You know, 10 we had phone calls, like we had people -- and I 11 don't know if they were third-party groups or what 12 they were. But they were out there telling people 13 that they ought to vote absentee because it costs 14 them if they go to the polls. And some of our --15 16 some of our areas, they were telling people that if they would call us and order an absentee ballot, 17 18 they would come pick it up. 19 I mean, it was not a nice atmosphere for an election at all, here in Manatee County. I can't 20 speak for the rest of the state. But from reading 21 22 the newspaper articles in the rest of the state, they had some of the same problems. 23 Okay. Any other problems? 24 0. 25 No. It just -- you know, just the Α.

1 typical things like that that you are just trying to browbeat, you know, people. 2 3 I had problems here where in my early voting, people coming in and trying to influence 4 people in the line on how to vote. They were going 5 up to some of my elderly people saying, "Let me help 6 you vote." You know, "Let me help you go in there." 7 And I caught three of those myself that I know 8 9 personally that had walked in the line with them and they were in there helping them to vote. And when I 10 asked them a question, you know, they didn't go in 11 there and qualify themselves saying, "I need to fill 12 out, you know, the affidavit for assistance to help 13 them vote." They were just there helping them vote. 14 And when somebody would point that out 15 16 to me, I would go over there and ask them. would say, "Oh, no, they just asked me to help 17 18 them." Then they left, you know. And finally after 19 the three or four times after that, we didn't have them come back anymore because I called the police. 20 Were those people from third-party voter 21 0. 22 groups? I have no idea. I am just saying they 23 were not of the norm that we have, you know, coming 24 in the line. And they always picked on elderly 25

1 people or minorities. I mean, that was what they So I mean, you know, the big picture here: 2 did. 3 was just not a nice election there. And --4 0. Or I'm not saying third parties did 5 Α. that. I'm just saying it was not a nice election in 6 7 some of the instances and situations that we had. Do you know that it was members of 8 Ο. 9 third-party groups who went door to door who were responsible for the complaints that you mentioned? 10 11 Α. As I said, I don't know if they were 12 third-party groups or not. It could have been anyone because there was a lot of people out there. 13 I got many phone calls of people that 14 were upset about different things that happened. I 15 do know that one of the people that was out there --16 and the only reason I know this is because I saw the 17 18 car. There was an old, older model car that had 19 shoe polish or something on it, "register to vote 20 here," you know. And we keep a pretty good 6 7 record of that. Q. Did you see any of the applications come 8 9 in? 10 A. No. 11 Q. Did you see the applications after they 12 were date stamped? A. No. 13 O. So did somebody tell you about this? 14 15 A. Yes. Q. Who told you about it? 16 A. One of the staff. And I don't know 17 18 which one. And we have several of us processing 19 these. 20 Q. Is the staff the same -- was the staff the same then as it is now? 21 22 A. Pretty much. Q. Linda, Linda, Nancy, and I think there 23 24 were two other people? A. Yeah, we have a couple of others that 25

1 work back and forth on that. Probably if anybody 2 would remember, it would probably be Nancy. She is 3 the one that handles most of the things that come in 4 here that are questionable. So --Q. Okay. Could you name the other staffers 5 6 who might know? 7 A. It might have been Linda Gabler or Linda Cobb, one of the other of those two. 8 9 Q. Do you know if these applications were submitted by third-party groups? 10 A. I have no idea. 11 12 Q. Okay. Did the voters ever complain about their applications being submitted late? 13 A. No. The only -- the only question --14 questions that we had had --15 And I can't pinpoint, you know, what 16 applications were. 17 I had people call me and want to know 18 19 why they had not gotten their voter registration 20 card. And we would have no record of the card, you know, the applications coming into the office. And, 21 22 now, whether that was from a third-party group or not, I don't know who registered them. It could 23 have been the Department of Motor Vehicles as far as 24 that goes because we had some -- I don't know if you 25

1 recall it or not, but back the first of 2004, we had 2 some real problems with the Department of Motor 3 Vehicles and registrations. 4 O. Could you please describe those 5 problems? 6 A. Well, when we would get the list, the 7 name wouldn't be on the list. So, you know, they would say they registered at the driver's license 8 9 bureau. Well, I don't know if they asked them if 10 11 they wanted to be registered to vote or not. The only thing I know is when I got the list from the 12 DMV, that their names weren't on the list. So all 13 I'm doing now is taking secondhand information when 14 the DMV says they weren't on the list, they didn't 15 register, and the person says, "I registered in the 16 DMV." Where do you go from there? My best recourse 17 18 to that is to say, "Please let me send another application. You fill it out. Let's get you 19 20 registered." 21 Did you manage to get all those people Ο. 22 registered? Yeah. If we had anybody that called us, 23 Α. 24 we tried to get them an application immediately and get them registered. And I think this was maybe a 25

1 responsible for dealing with illegible applications? 2 Α. The assistant supervisor, Nancy Bignell. 3 I don't recall. I am not saying that we didn't or never have. But I don't recall one that's -- that 4 5 we haven't been able to at least decipher something out of, that we could get them that information. 6 7 And then if, in some of these cases, we 8 get phone numbers on some of the logs and the name 9 is on the log and we can't read it, then we can contact them by phone or we can either look up an 10 address and get them some information. 11 12 We -- we try to make a direct contact by phone or by mail on every application that we get in 13 14 here unless it's -- unless we are able to process it 15 right then and, you know, and issue them a voter 16 card. Q. Do you have any logs or any records of 17 18 illegible applications from 2004? 19 A. I don't think so, no. 20 Q. Do you have any logs or any records of potentially fraudulent applications from 2004? 21 22 A. No. Q. Do you have any logs or records of 23 24 applications received after book closing deadline from 2004? 25

1 Not that I am aware of, no. Α. 2 O. Do any of -- let me rephrase. 3 In the documents that you provided to me, there were a number of voter registration logs 4 5 from 2004. As we discussed, I think it was 6 Exhibit 3. 7 Do any of the logs that you provided correspond to any of the applications that you 8 9 testified about in Diaz with regard to applications being held in the trunk of a car or somewhere else? 10 11 A. Not that I am aware of, no. Q. Do you have any logs that do correspond 12 to those applications? 13 A. I don't -- I don't know. I don't think 14 15 so. 16 Q. Why not? A. Well, if we processed them, you know, 17 18 after the election was over, we just -- we put them 19 in a file and sent them a voter registration card. It's not illegal to register to vote and 20 turn in your voter registration card after the books 21 22 close, you know. You have got the second gap there after the window there to go ahead and process them 23 and send them out for the general election or the 24 next election, whichever one, you know, is coming up 25


