## **JOINT STATUS REPORT**

Pursuant to the Court's July 16, 2018, Minute Order, Defendant the Office of Management and Budget ("OMB") and Plaintiff Arab American Institute (collectively, "the Parties") submit the following Joint Status Report:

- 1. Plaintiff Arab American Institute filed its Complaint pursuant to the Freedom of Information Act ("FOIA") on April 13, 2018. (ECF No. 1.) OMB answered on May 17, 2018. (ECF No. 8.)
- 2. Since the last Joint Status Report, OMB produced records to Plaintiff on August 1 and 15, 2018. On September 15, 2018, OMB sent a letter to Plaintiff indicating that there were no responsive non-exempt records among the records it had reviewed that month.
- 3. OMB completed its searches, which resulted in approximately 2,000 potentially responsive documents. The Parties have agreed that OMB will continue to process 300 potentially responsive documents per month and release any responsive, non-exempt records to Plaintiff on

the 15th of each month until production is complete, which the Parties anticipate will be on January 15, 2019.

4. The Parties propose to file an additional Status Report no later than December 3, 2018.
