Dear Ms. Wolfe:

The government writes to notify the Court of an order issued by Justice Ginsburg concerning the above-captioned matters. The government had requested that Justice Ginsburg issue a stay of the depositions of Commerce Secretary Ross and Acting Assistant Attorney General Gore and all further extra-record discovery, pending Supreme Court review. Justice Ginsburg denied the stay without prejudice, "*provided that the Court of Appeals will afford sufficient time* for either party to seek relief in th[e Supreme] Court before the depositions in question are taken." *See In re Department of Commerce*, S.Ct. No. 18A350, Dkt. Entry 2 (Oct. 5, 2018) (emphasis added).

The depositions of Acting AAG Gore and Secretary Ross are currently scheduled to take place on October 10 and October 11, respectively. As ordered by Justice Ginsburg, this Court should issue a stay of those depositions and all further extra-record discovery pending Supreme Court review. Should this Court not choose to do so by Tuesday, October 9, 2018, we intend to refile our stay application with the Supreme Court, as Justice Ginsburg's order contemplates. Sincerely,
