PRELIMINARY PRETRIAL  
CONFERENCE ORDER

The court held a telephonic preliminary pretrial conference on October 16, 2018. Plaintiffs from *Whitford* appeared by Doug Poland, Peter Earle, Ruth Greenwood, Annabelle Harless, and Jerry Hebert. Plaintiffs from *Wisconsin Assembly Democratic Campaign Committee* appeared by Lester Pines and Peter Earle. Defendants appeared by Brian Keenan, Anthony Russomanno, and Karla Kechhaver. Proposed intervenor Wisconsin State Assembly appeared by Kevin St. John.

The court set the trial for April 23–26, 2019, and set the following the pretrial deadlines:

**December 17, 2018:** defendants’ updated expert reports;<sup>1</sup>

**January 15, 2019:** plaintiffs’ rebuttal reports;

**February 5, 2019:** defendants’ rebuttal reports;

**March 1, 2019:** Rule 26(a)(3) disclosures;

**March 15, 2019:** motions in limine and objections to Rule 26(a)(3) disclosures;

**March 29, 2019:** responses to motions in limine;

**April 12, 2019:** a statement of stipulated facts and short trial briefs outlining what the parties believe the evidence will show at trial.

Neither the parties nor the proposed intervenor had any objection to this schedule.

The court also set a tentative briefing schedule for post-trial briefing: (1) opening briefs from both sides due 21 days after the close of trial; and (2) response briefs from both sides due

14 days after opening briefs are filed. The court may revisit the post-trial briefing schedule if necessary at the close of trial.
