## **JOINT STATUS REPORT**

Pursuant to the Court's May 9, 2019, Minute Order, Defendant the Office of Management and Budget ("OMB") and Plaintiff Arab American Institute (collectively, "the Parties") submit the following Joint Status Report:

- 1. Plaintiff Arab American Institute filed its Complaint pursuant to the Freedom of Information Act ("FOIA") on April 13, 2018. (ECF No. 1.) OMB answered on May 17, 2018. (ECF No. 8.)
  - 2. OMB made its final production to Plaintiff on February 22, 2019.
- 3. On April 8, 2019, Plaintiff e-mailed the undersigned Assistant United States Attorney ("AUSA") a list of 17 sets of withholdings or redactions Plaintiff intends to challenge. Plaintiff has requested that OMB prepare a *Vaughn* Index detailing its withholdings.

- 4. OMB had expected to have the *Vaughn* Index to Plaintiff by May 17, 2019. However, due to a heavy workload OMB needs additional time to prepare the *Vaughn* Index and will send it to Plaintiff no later than June 14, 2019.
- 5. The Parties propose to file an additional Status Report no later than July 10, 2019, proposing a briefing schedule and recommending what further action, if any, is necessary.
