JOINT STATUS REPORT

Pursuant to the Court’s June 18, 2018, Minute Order, Defendant the Office of Management and Budget (“OMB”) Plaintiff Arab American Institute (collectively, “the Parties”) submit the following Joint Status Report:

1. Plaintiff Arab American Institute filed its Complaint pursuant to the Freedom of Information Act (“FOIA”) on April 13, 2018. (ECF No. 1.) OMB answered on May 17, 2018. (ECF No. 8.)

2. Per the Court’s June 18, 2018, Minute Order, OMB made its first production to Plaintiff on July 13, 2018.

3. OMB has completed its searches, which have resulted in approximately 2,000 potentially responsive documents. OMB has proposed, and the Parties agree, that it will process 150 potentially responsive documents and release any responsive, non-exempt records to Plaintiff not later than August 1, 2018. OMB will review an additional 150 potentially responsive documents

and release any responsive, non-exempt records to Plaintiff not later than August 15, 2018. Thereafter, OMB will process 300 potentially responsive documents per month and release any responsive, non-exempt records to Plaintiff on the 15th of each month until production is complete.

4. The Parties propose to file an additional Status Report no later than October 1, 2018.
