**JOINT STATUS REPORT**

Pursuant to the Court’s August 12, 2019, Minute Order, Defendant the Office of Management and Budget (“OMB”) and Plaintiff Arab American Institute (collectively, “the Parties”) submit the following Joint Status Report:

1. Plaintiff Arab American Institute filed its Complaint pursuant to the Freedom of Information Act (“FOIA”) on April 13, 2018. (ECF No. 1.) OMB answered on May 17, 2018. (ECF No. 8.)
2. OMB made its final production to Plaintiff on February 22, 2019.
3. The Parties are conferring to determine whether this matter can be resolved without further litigation. OMB anticipates releasing additional documents to Plaintiff by August 23, 2019. Plaintiff will then require some additional time to review the documents and discuss the possibility of any additional releases.

4. The Parties therefore propose to file an additional Status Report no later than September 20, 2019, recommending what further action, if any, is necessary.
