PLAINTIFFS' PROPOSED FINDINGS OF FACT

- 1. The documents attached at App. 0016-0041(Plaintiffs' Documents Nos. 695-720) are true and accurate copies of reimbursement requests submitted to the House of Representatives Office of the Comptroller by the individuals named on each page for the expenses incurred by that individual.
- 2. Plaintiffs' Documents No. 586-613, attached hereto at App. 0043-0069, are true and correct copies of materials downloaded from public websites, as testified to in the Declarations contained therein.
- 3. Plaintiffs' Document No. 150, attached hereto at App. 0070, is a true and correct copy of a letter from Chris Jankowski to "Dear Legislative Leaders".

- 4. Plaintiffs' Documents Nos. 166-537, (not included in the Appendix), are true and correct copies of sworn testimony given by Thomas Hofeller on Thursday, June 28, 2012 and Friday, August 10, 2012, in the case of *County of Wake and Margaret Dickson v. Rucho et al.*
- 5. Packing concentrates members of a group in a single district, thereby allowing the other party to win the remainder of the districts because the members of the packed group have less influence in the rest of the districts.
- 6. Cracking splits a block of party voters among multiple districts, so as to dilute their impact and to prevent them from forming a majority.
- 7. There are four Democratic districts where Democrats won by a larger margin than any Republican winner in any other district of the state by an average of over 75 percent in these four districts.
- 8. Partisan considerations played some role in the drafting of the map, etc. (Jason's proposal).
- 9. The persons who drafted the map that was approved in SB 1249 had the specific purpose of achieving the election of the most Republicans and fewest Democrats possible given the party or political preferences of voters in the state.
- 10. The persons who drafted the map that was approved in SB 1249 did in fact adjust the boundaries in the manner described by the report of Daniel McGlone, the Senior Analyst of Azavea, attached as Exhibit A.
- 11. Those who drew up the Map deliberately sought to influence Pennsylvania's electoral outcomes.

- 12. Those who drew up the Map deliberately sought to favor a class of candidates for Pennsylvania's Congressional delegation—namely, Republicans—and disfavor another class—namely, Democrats.
- 13. Those who drew up the Map deliberately sought to influence the districts in which Plaintiffs and others could vote based upon their party affiliation or likely political views.
- 14. Those who drew up the Map sought to protect one class of candidates namely incumbents over another class of candidates namely challengers for Congressional seats in Congress.
- 15. Defendants Turzai and Scarnati participated in the drawing of the map that was adopted by the Pennsylvania legislature as the Congressional districting plan for 2012 ("the Map").
- 16. The legislators who presented the Map to the legislature for consideration did not inform the legislators that they deliberately sought to influence Pennsylvania's electoral outcomes.
- 17. The legislators who presented the Map to the legislature for consideration did not inform the legislators that they deliberately sought to favor a class of candidates for Pennsylvania's Congressional delegation—namely, Republicans—and disfavor another class—namely, Democrats.
- 18. The legislators who presented the Map to the legislature for consideration did not inform the legislators that they deliberately sought to influence the districts in which Plaintiffs and others could vote based upon their party affiliation or likely political views.
- 19. The legislators who presented the Map to the legislature for consideration did not inform the legislators that they deliberately sought to protect one class of candidates namely

incumbents – over another class of candidates – namely challengers for Congressional seats in Congress.

- 20. The RLCC is dedicated exclusively to supporting the election of more Republicans to state legislatures.
- 21. At the same time, the votes for the Democratic and Republican candidates for Congress on a statewide basis were divided nearly equally, with Republicans winning just 55.5% of the statewide congressional vote in 2014, and 53.9% in 2016.
 - 22. REDMAP states on its website:

REDMAP's effect on the 2012 election is plain when analyzing the results: Pennsylvanians cast 83,000 more votes for Democratic U.S. House candidates than their Republican opponents, but elected a 13-5 Republican majority to represent them in Washington.

- 23. Chris Jankowski's letter to the Republican leadership in the states that REDMAP had identified is shown at https://www.documentcloud.org/documents/537408-hofeller-sglf-rslc-letter. A copy of the letter is reproduced at App. 0070.
- 24. At least one other Republican Legislative Leader in Pennsylvania received a copy of the letter shown at App. 0070.
- 25. Speaker Turazi, someone on his staff, another Republican Legislative Leader, or member of his or her staff, contacted Tom Hofeller.
- 26. The Republican Legislative Leadership received advice or other assistance from Tom Hofeller during the redistricting process.
- 27. On or about March 30, 2011, Speaker Turzai, David L. Reddecliff, and William Schaller attended meeting(s) with Congressmen in Washington, D.C. to discuss redistricting. (Plaintiffs' Document Nos. 715-720, attached hereto at App. 0036-0041).

- 28. All of the Congressmen at the March 30, 2011 meeting(s) were members of Pennsylvania's Republican delegation.
- 29. At none of the three hearings held at locations across the state was a map presented for consideration.
 - 30. No map was introduced for consideration on September 14, 2011.
- 31. The RSLC is a national organization whose mission includes support for the election of Republicans to multiple down-ballot, state-level offices.
- 32. In late 2011, in connection with the drawing of new Congressional district boundaries after the 2010 census, Speak Scarnati participated in a meeting at the Harrisburg Hilton ("the 2011 Meeting").
 - 33. The 2011 Meeting took place before the Congressional districts were finalized.
- 34. The majority of the members of the Republican Congressional delegation attended the 2011 Meeting.
 - 35. Congressman Bill Shuster attended the 2011 meeting.
 - 36. Present at the 2011 Meeting were Speaker Scarnati and Bill Shuster.
- 37. Also present at the 2011 Meeting was at least one person paid by SGLF or working for corporations or entities that received funds from either SGLF or RSLC or both.
- 38. Also present at the meeting were consultants to help the Republican leadership draw proposed Congressional maps.
 - 39. No Democrats were invited to the 2011 Meeting.
 - 40. No Democrats participated in the 2011 Meeting.
- 41. One or more possible Congressional districting plans discussed or considered in the 2011 meeting had been generated or developed by persons paid by SGLF.

- 42. All of the Congressional districting plans discussed or considered in the 2011 meeting had been generated or developed by persons paid by SGLF.
 - 43. REDMAP data were referred to at the meeting.
 - 44. REDMAP data were used in drawing the district lines.
- 45. At the 2011 Meeting, the participants put two incumbent Democratic congressmen from Western Pennsylvania, Mark Critz and Jason Altmire into the same district to eliminate one of their seats in Congress.
- 46. At the 2011 Meeting, the participants then took away portions of this same district that were likely to favor the election of either Critz or Altmire, to hinder either one from being elected from the district.
- 47. At the 2011 Meeting, the participants discussed and approved of plans developed with the help of persons paid by SGLF and that attempted to pack the Democratic voters into as few Congressional districts as possible.
- 48. The participants in the 2011 Meeting also received legal advice from attorneys paid by SGLF.
- 49. The participants in the 2011 Meeting also discussed removing Scranton from the 11th District to increase the likelihood that Republican incumbent Louis Barletta of the 11th District could retain his seat.
- 50. The participants at the 2011 meeting also discussed linking together Wilkes-Barre and Scranton into one heavily Democratic majority district, the PA 17th District.
- 51. In creating the PA 17th, the participants at the 2011 Meeting discussed absorbing or locating as many likely Democratic voters as possible into the 17th district from the

surrounding areas in order to make it more likely that voters in the districts surrounding the 17th district would elect Republicans.

- 52. At the 2011 Meeting, the participants heard from one or more Republican Congressmen or one or more of the members of their staffs as to their preferences for the boundaries of their districts in the redistricting plan.
- 53. At the 2011 Meeting, those present went over the Pennsylvania map district by district.
- 54. At the 2011 Meeting, those present considered one or more plans developed with election records and lists and computer software by persons paid by SGLF and part of the REDMAP Project to design a plan that they believed would maximize the number of Republican candidates elected to the U.S. House of Representatives from Pennsylvania.
- 55. A number of such 18 Congressional districts were drawn with the use of techniques known by the terms of "packing" and "cracking."
- 56. Speaker Scarnati and one or more of the participants in the 2011 Meeting were familiar with the techniques of "packing" and "cracking."
- 57. Speaker Scarnati favored and were aware of the use of these techniques in the development of the Congressional districting plan adopted in 2011.
- 58. Speaker Scarnati was aware of and did not disavow the use of these techniques in the development of the Congressional districting plan.
- 59. The goal of the Republican Leadership in the PA House and Pa Senate ("Republican Leadership") was to create as many reliable Republican seats across Pennsylvania as possible as a result of the 2011 Congressional redistricting.

- 60. The goal of Republican Leadership was also to ensure that Districts facing a migration of Democrats into majority Republican Districts would not shift to become Democratic seats or competitive seats over the course of the decade from 2011 to 2021.
- 61. The new 2011 PA Congressional District map for Pennsylvania (the "New Map") had the intended effect of combining incumbents Democrats Mark Critz and Jason Altmire into a single district so that one or the other would be eliminated in the Democratic Primary.
- 62. The 2011 Plan removed inner ring suburbs around Pittsburgh from this new combined district, and added white working-class Johnstown with the intent of making the election of a Republican more likely.
- 63. The Congressional districting map that was ultimately approved for Pennsylvania ("the 2011 Plan") is substantially similar to the map developed at the 2011 Meeting.
- 64. At the same time, the votes for the Democratic and Republican candidates for Congress on a statewide basis were divided nearly equally, with Republicans winning just 55.5% of the statewide congressional vote in 2014, and 53.9% in 2016.
 - 65. REDMAP states on its website:

REDMAP's effect on the 2012 election is plain when analyzing the results: Pennsylvanians cast 83,000 more votes for Democratic U.S. House candidates than their Republican opponents, but elected a 13-5 Republican majority to represent them in Washington.

- 66. The SGLF 501(c)(4) offered, among other resources, the assistance of experts and lawyers to help legislators in targeted states draw their new Congressional district maps.
- 67. As of the time that you and others in the Republican leadership were participating in drawing the new Congressional districting map for 2011, Chris Jankowski was the Executive director of the RSLC.

68. Speaker Scarnati received a copy of the letter shown at App. 0070.

69. Someone on Speaker Scarnati's staff received a copy of the letter shown at App.

0070.

70. At least one other Republican Legislative Leader or member of his or her staff

requested help from SGLF.

71. Speaker Scarnati, someone on his staff, another Republican Legislative Leader, or

member of his or her staff, contacted Tom Hofeller.

72. The Republican Legislative Leadership received advice during the redistricting

process from lawyers at Blank Rome.

73. The Republican Legislative Leadership received advice or other assistance from

Tom Hofeller during the redistricting process.

74. At the 2011 Meeting, there was a computer.

75. Some or all of the programs on that computer had been supplied by REDMAP.

76. The computer at the 2011 Meeting was programmed to generate district maps.

77. Someone took notes at the 2011Meeting.

78. The 2011 Meeting was recorded.





Pennsylvania Congressional Districts Act 464 of 1951





Pennsylvania Congressional Districts Act 1 of 1962





Pennsylvania Congressional Districts Act 3 of 1972







Enacted by rder of the Supreme Court of Pennsylvania 10 March 1992





Pennsylvania Congressional Districts Act 34 of 2002






Republican Seat Majority in the PA Congressional Delegation

How a Strategy of Targeting State Legislative Races in 2010

Led to a Republican U.S. House Majority in 2013

On November 6, 2012, Barack Obama was reelected President of the United States by nearly a three-point margin, winning 332 electoral votes to Mitt Romney's 206 while garnering nearly 3.5 million more votes. Democrats also celebrated victories in 69 percent of U.S. Senate elections, winning 23 of 33 contests. Farther down-ballot, aggregated numbers show voters pulled the lever for Republicans only 49 percent of the time in congressional races, suggesting that 2012 could have been a repeat of 2008, when voters gave control of the White House and both chambers of Congress to Democrats.

But, as we see today, that was not the case. Instead, Republicans enjoy a 33-seat margin in the U.S. House seated yesterday in the 113th Congress, having endured Democratic successes atop the ticket and over one million more votes cast for Democratic House candidates than Republicans. The only analogous election in recent political history in which this aberration has taken place was immediately after reapportionment in 1972, when Democrats held a 50 seat majority in the U.S. House of Representatives while losing the presidency and the popular congressional vote by 2.6 million votes.

To be sure, the National Republican Congressional Committee (NRCC) built on its strong recruitment and successful strategy that gave them a Republican majority in 2010 by going on offense over Democratic cuts to Medicare and by linking their Democratic opponents to President Obama's most unpopular policy proposals.

However, all components of a successful congressional race, including recruitment, message development and resource allocation, rest on the congressional district lines, and this was an area where Republicans had an unquestioned advantage.

Today, nearly two months after Election Day, and one day after the 113th United States Congress took the Oath of Office on Capitol Hill, the Republican State Leadership Committee (RSI.C) is releasing this review of its strategy and execution of its efforts in the 2010 election cycle to erect a Republican firewall through the redistricting process that paved the way to Republicans retaining a U.S. House majority in 2012.

2010 State Elections: REDMAP's Execution

As the 2010 Census approached, the RSLC began planning for the subsequent election cycle, formulating a strategy to keep or win Republican control of state legislatures with the largest impact on congressional redistricting as a result of reapportionment. That effort, the REDistricting MAjority Project (REDMAP), focused critical resources on legislative chambers in states projected to gain or lose congressional seals in 2011 based on Census data.

The rationale was straightforward: Controlling the redistricting process in these states would have the greatest impact on determining how both state legislative and congressional district boundaries would be drawn. Drawing new district lines in states with the most redistricting activity presented the opportunity to solidify conservative policymaking at the state level and maintain a Republican stronghold in the U.S. House of Representatives for the next decade.

To fund the initiative, the RSLC raised more than \$30 million in 2009-2010, and invested \$18 million after Labor Day 2010 alone. Specifically, the RSLC:

- Spent \$1.4 million targeting four New York State Senate seats, winning two and control of the New York State Senate. (-2 Congressional seats).
- Spent nearly \$1 million in Pennsylvania House races, targeting and winning three of the toughest races in the state. (-1 Congressional seat).
- Spent nearly \$1 million in Ohio House races, targeting six seats, five of which were won by Republicans. Notably, President Obama carried five of these six legislative districts in 2008. (-2 Congressional scats).
- Spent \$1 million in Michigan working with the Michigan House Republican Campaign Committee and Michigan Republican Party to pick up 20 seats. (-1 Congressional seat).
- Spent \$750,000 in Texas as part of an effort that resulted in 22 House pick-ups. (+4 Congressional seats).
- Spent \$1.1 million in Wisconsin to take control of the Senate and Assembly.
- Committed resources to Colorado (more than \$550,000) and North Carolina (more than \$1.2 million).
- The RSLC also invested more than \$3 million across a number of other states including Illinois, Indiana, Iowa, Kentucky,
 Maine, Nevada, New Hampshire, New Jersey, Oregon, Tennessee and Washington. (Five of these eleven states gained or lost
 Congressional seats).

Election Day 2010 proved to be a "wave" election nationally, in both REDMAP targeted states and others across the country. Prior to Election Day 2010, Democrats controlled 60 state legislative chambers to the Republicans' 36. After the 2010 elections, Democrats

controlled 40 chambers. Republicans controlled 55 chambers, and two remained tied. In all. Republicans took control of 21 legislative bodies and moved one from Democratic control to being evenly divided. After Election Day 2010, Republicans held majorities in both legislative chambers in 25 states – and, in most cases, control of redistricting – up from 14. The result can clearly be seen in the following chart showing partisan control over redistricting from 1980 to 2010:

2012 Congressional Elections: REDMAP's Impact

President Obama won reelection in 2012 by nearly 3 points nationally, and banked 126 more electoral votes than Governor Mitt Romney. Democratic candidates for the U.S. House won 1.1 million more votes than their Republican opponents. But the Speaker of the U.S. House of Representatives is a Republican and presides over a 33-seat House Republican majority during the 113th Congress. How? One needs to look no farther than four states that voted Democratic on a statewide level in 2012, yet elected a strong Republican delegation to represent them in Congress: Michigan, Ohio, Pennsylvania and Wisconsin.

Michigan

The effectiveness of REDMAP is perhaps most clear in the state of Michigan. In 2010, the RSLC put S1 million into state legislative races, contributing to a GOP pick-up of 20 seats in the House and Republican majorities in both the House and Senate. Republican Rick Snyder won the gubernatorial race, and with it Republicans gained control of redrawing Michigan's 148 legislative and 14 congressional districts. The 2012 election was a huge success for Democrate at the statewide level in Michigan: voters elected a Democratic U.S. Senator by more than 20 points and reelected President Obama by almost 10 points. But Republicans at the state level maintained majorities in both chambers of the legislature and voters elected a 9-5 Republican majority to represent them in Congress.

Oltio

Ohio once again proved to be the national beltwether, voting to reelect President Obama to a second term in the White House by almost two points. On the statewide level, Ohioans also elected a Democrat to the U.S. Senate by more than five points. But the Republican firewall at the state legislative and congressional level held. In 2010, REDMAP allocated nearly \$1 million to Ohio House races, resulting in a Republican take over of the House and increasing the GOP majority in the Senate. With the election of Republican John Kasich to the governor's mansion, the GOP controlled the redrawing of 132 state legislative and 16 congressional districts. Republican redistricting resulted in a net gain for the GOP state House caucus in 2012, and allowed a 12-4 Republican majority to return to the U.S. House of Representatives – despite voters casting only 52 percent of their vote for Republican congressional candidates.

Pennsylvania

A REDMAP target state, the RSLC spent nearly \$1 million in Pennsylvania House races in 2010 – an expenditure that helped provide the GOP with majorities in both chambers of the state legislature. Combined with former Republican Attorney General Tom Corbett's victory in the gubernatorial race, Republicans took control of the state legislative and congressional redistricting process. The impact of this investment at the state level in 2010 is evident when examining the results of the 2012 election: Pennsylvanians reelected a Democratic U.S. Senator by nearly nine points and reelected President Obama by more than five points, but at the same time they added to the Republican ranks in the State House and returned a 13-5 Republican majority to the U.S. House.

Wisconsin

In 2010, the RSLC spent \$1.1 million to successfully flip both chambers of the Wisconsin legislature. With the election of Republican Governor Scott Walker, the GOP gained control of the redistricting process and gave Wisconsinites and all of America a firsthand look at what bold conservative leadership looks like. In mid-2012, Democrats were able to regain control of the Wisconsin Senate, albeit for a period of time when the chamber was out of session. In November 2012, however, running on lines redrawn after the successes of 2010, Republicans were able to retake the Senate and add to their margins in the House. On a statewide level, in 2012, Wisconsin voters elected a Democratic U.S. Senator by nearly six points and reelected President Obama by nearly seven points, but still returned a 5-3 Republican majority to Congress, including the GOP vice presidential nominee. Representative Paul Ryan.

Conclusion

After REDMAP's success on Election Day 2010, Republicans held majorities in 10 of the 15 states that gained or lost U.S. House seats and where the legislature played a role in redrawing the state legislative and congressional district map. In the 70 congressional districts that were labeled by National Public Radio as "competitive" in 2010, Republicans controlled the redrawing of at least 47 of those districts; Democrats were responsible for 15, and a non-partisan process determined eight.

REDMAP's effect on the 2012 election is plain when analyzing the results: Pennsylvanians cast 83,000 more votes for Democratic U.S. House candidates than their Republican opponents, but elected a 13-5 Republican majority to represent them in Washington; Michiganders cast over 240,000 more votes for Democratic congressional candidates than Republicans, but still elected a 9-5 Republican delegation to Congress. Nationwide, Republicans won 54 percent of the U.S. House seats, along with 58 of 99 state legislative chambers, while winning only 8 of 33 U.S. Senate races and carrying only 47.8 percent of the national presidential vote.

State elections can have a big impact on a political party's performance in future federal elections, not only by building a strong "bench" and strengthening party infrastructure, but also through the decennial redistricting process. As the largest caucus of

RSLC Launches REDMAP 2020, Sets \$125 Million Investment Goal

washington, D.C. – Today, the Republican State Leadership Committee (RSLC) – in partnership with its strategic policy partner, the State Government Leadership Foundation (SGLF) – launched REDMAP 2020 with a \$125 million investment goal through 2022. REDMAP 2020 is modeled after the RSLC's successful REDistricting Majority Project (REDMAP) program in 2010 that was instrumental in Republicans picking up 21 new legislative majorities that year and putting Republicans in a strong position before the decade's redistricting. Similarly, REDMAP 2020 will prioritize electing Republican legislators in states across the country in an effort to keep and expand Republican-controlled legislative chambers in advance of 2020 redistricting. Also as part of REDMAP 2020, the SGLF will now help the Republican redistricting data acquisition efforts and provide targeted legal strategic advice in redistricting cases.

"We are launching REDMAP 2020 to stay on offense at a time when Republicans are at historic highs in state chambers around the country," said RSLC Chairman Bill McCollum. "The launch of REDMAP 2010 marked the beginning of strong gains in the number of Republican-controlled legislative bodies at the state level that led to helping both solidify a Republican majority in the U.S. House of Representatives and winning back the U.S. Senate a few years later. It's important to maintain that success at all levels of government, and by investing \$125 million over the next seven years, we plan to help do just that."

"When we started REDMAP in 2010, we were able to utilize the in-depth knowledge and resources of the RSLC's vast network of Republican elected leaders who represent all 50 states," said SGLF Chairman and former NRCC Chairman Tom Reynolds. Reynolds served as REDMAP Chairman in 2010. "To now expand that role from winning critical legislative majorities that help shape the redistricting process to also providing targeted legal strategic advice and commentary for ongoing redistricting legislation is exciting for the REDMAP 2020 program. It's exciting for the future of the Republicans Party."

Through REDMAP 2010, the RSLC raised \$30 million and led Republicans to take control of 21 new chambers, including capturing control of both chambers in several states President Obama went on to win twice: Michigan, Ohio, Pennsylvania, and Wisconsin. Republicans today control a Party-record 69 of 99 state legislative chambers. REDMAP 2020 will work to maintain the historic highs we hold



today, including those in Obama-blue states, while working to pick up additional majorities in states like Kentucky, Maine and New Mexico where the legislatures play a vital role in crafting district boundaries, and Republicans currently control only one of the two state chambers.

As part of REDMAP 2020, the RSLC's strategic policy partner the SGLF will take on an increased role in helping to support the Republican Party's data acquisition efforts. The SGLF will also actively file amicus briefs with controlling authorities for select cases in states as it relates to redistricting.



The 2020 redistricting war is (already) on

There's a hundred-million-dollar battle brewing for control of Congress, but it's not going to be resolved for seven more years, and the battles will take place in lands far away from Washington.

Both Democrats and Republicans think controlling state legislatures in 2020 is one of the most important political battles to fight, mostly for one reason: The power of the pen — the kind that draws district lines, that is.

Five years out, both sides are in a fundraising battle to build war chests of \$70 million to \$125 million to swing state legislatures their way by 2020, when new electoral maps will get drawn across the country. The Republican State Leadership Committee announced Thursday it's launching RedMap 2020 and aiming to invest \$125 million to expand their majority in the statehouses and redraw the nation's electoral lines.

They're playing the long game, but as Republicans showed in 2010, investing in state races is one of the best bangs-for-your-buck to swing Washington the way you want it.

"The implications of the state-level races reach all the way up to the U.S. Capitol," said Matt Walter, the president of the RSLC, which works to keep Republicans in state legislatures.

Redistricting has always been important to the political process, but in an age in which Americans are increasingly polarized — and technology allows for even-more-effective gerrymandering — the shapes and demographics of the districts that are drawn is even more decisive when it comes to control of Congress.

Every 10 years, based on new U.S. Census data, states redraw their legislative and congressional districts. In about 43 states (http://www.washingtonpost.com/blogs/the-fix/wp/2015/06/29/the-supreme-courts-ruling-in-favor-of-redistricting-commissions-explained/), state lawmakers get to decide how to do this. It's an inherently political tool to help create beneficial districts for whichever party's in power.

And in 2010, Republicans showed just how much can be gained from dominating that process. Fueled by millionaire Art Pope, they invested \$30 million into winning state legislature battles — particularly states where the legislature was up for grabs, and it had a say in redistricting. In the grand scheme of politics, that's not that much money — but it had a huge impact (thanks in part, of course, to the GOP wave year).

Republicans picked up 675 state legislative seats, gaining control of 12 more state legislatures. The GOP in total controlled about three times as many states in the redistricting process — including many big, swing-y states where the lines are even more fungible and important.

New lines were drawn, and in 2012, Republicans took over the House of Representatives with a commanding 234-201 majority — despite the fact Democratic House candidates got 1.4 million more votes than Republican candidates. Some analysts think the current map is such that Democrats simply won't be able to win a majority on it, barring a massive wave in their direction.

"It really helped redefine how the American political system looks at the redistricting process," Walter said.

After another great 2014 midterm election for Republicans, the party now controls an all-time high of 68 of 98 state chambers. That's the potential to rewrite a lot of lines.

Sensing a winning game plan, Democrats are getting in now, too. They launched Advantage 2020 last year, a super PAC that hopes to raise \$70 million to play exclusively in states where redistricting is on the line. (Compare that with the \$10 million they raised in 2010.)

They'll play in state races in more than a dozen states with the end game of capturing "a couple dozen" congressional seats in the midterms of 2022, Advantage 2020 Director Mark Schauer said.

"Once the lines are redrawn in 2021, the Democrats will have a tremendous opportunity to recapture the majority," Schauer said.

Expect the first of the redistricting battles to take place a little closer to Capitol Hill: Control of the Virginia senate is in question in the fall.

You can bet RedMap 2020 and Advantage 2020 will be there, with an eye toward the future.

Political Report: July 2010

Introduction | The REDistricting MAjority Project (REDMAP) is a program of the Republican State Leadership Committee (RSLC) dedicated to winning Republican control of state legislatures that will have the most impact on Congressional redistricting in 2011. This inaugural REDMAP report is intended to more fully explain how the RSLC views a path to success in the 2010 state legislative races, how that will impact policy-making on a state level and examine what it means for long-term Congressional redistricting. This report, and its outlook, assumes that REDMAP is fully funded, an assumption that is consistent with the current state of fundraising.

The Landscape | This edition of the REDMAP Political Report includes two key findings:

- 1. That Democrats will not take control of a single state legislative chamber in the country this year, including key REDMAP chambers such as the Texas House, Michigan Senate and Tennessee House; and
- 2. That, as of today, Republicans will pick up four chambers with 12 additional Democrat controlled chambers in key REDMAP states solidly in play.

The bottom line, as of July, is that if Republicans win only half of those remaining 12 legislative chambers in play, the result will be a net gain of 10 legislative chambers.

Legislative Impact | Voters are looking for legislative policies to sufficiently address the hardships they are facing on a day-to-day basis. At the same time, voters, including large blocs of Independents are weary of the Democrats' over reaching approach on taxes, spending, healthcare and a myriad of other issues. Surveys continue to demonstrate they are more inclined to support Republican policies on these issues. The result of these switches of party control with new Republican Speakers, Majority Leaders and other legislative leaders will be a move towards smaller government, lower taxes and protection from Democrat over-reach.

Historical Context | This year will not be a typical election cycle in terms of shift in partisan control. As of today, it appears that 2010 will be more successful for Republicans than 1982 was for the Democrats and could even rival the Republican successes seen on the state level in 1994. The year, for either party, which is viewed as most successful, would be 1974 when, in the wake of Watergate, Democrats gained a net of 21 chambers. In raw numbers, Democrats gained a net of nine chambers in 1982, while Republicans gained a net 19 chambers in 1994. The Democrat's performance in 2006, when they gained a net of eight chambers, simply will not compare to 2010.

Impact on Congressional Redistricting If and when Republicans are successful in the races addressed in this report, the Republican Party will have an impact on the redrawing of numerous Congressional districts across the country, an effect that will be felt for the next decade. Republicans have an opportunity to create 20-25 new Republican Congressional Districts through the redistricting process over the next five election cycles, solidifying a Republican House majority. In fact, 33 of the 75 most competitive congressional districts, as identified in National Public Radio's June report, are located in REDMAP target states this year. If REDMAP achieves its goals, nearly half of the traditionally swing districts will be redrawn by Republicans before the 2012 election cycle. The remaining seats will either be subject to Democrat control or part of a partisan-neutral redistricting process.

As you well know, the decennial process of redistricting is underway in most states across the country. Some states have already concluded their redistricting processes and others have yet to begin.
