Dear Ms. Dreibelbis:

Pursuant to our telephone conversation yesterday, attached to this email are the underlying data files for the sole map exhibit Respondent Lt. Gov. Stack presented at the trial, Stack Exhibit 9. Three flash drive copies will follow via Federal Express.

Stack Exhibit 9 is duplicative of the shape file and the underlying raw data for Petitioners' expert Dr. Jowei Chen's Simulation Set 1, Simulation 308 map. Stack Exhibit 9 merely superimposes the addresses of Pennsylvania's current congressional delegation onto the map.

Please note that the incumbent addresses set forth in Stack Exhibit 9 were based on Joint Stipulation ¶ 155. In developing potential remedial maps, it has come to our attention that certain listed addresses were inaccurate. We have confirmed through the voter files that the following addresses should be substituted, and, of course, invite any party to offer any further clarification as appropriate:
