MOTION FOR LEAVE TO SUBMIT AMICUS CURIAE BRIEF IN SUPPORT OF PLAINTIFFS' MOTION FOR PRELIMINARY INJUNCTION

The following organizations move this Court for leave to file the attached Amicus Curiae Brief in Support of Plaintiff's Motion for Preliminary Injunction:

In this brief we provide background information about (a) the legislative process culminating in the enactment of HB 566 which is under constitutional challenge and (b) the legislative process in HB 515, a similar bill proposed in the Georgia General Assembly two years later. Our purpose is to add insight into the issue of impermissible racial motivation which was behind both bills.

In addition, we argue that mid-decade redistricting should be barred in the circumstances of this case where the **sole** purpose behind the district boundary changes was to increase the probability that an incumbent would win reelection. The Georgia General Assembly did not consider or give any weight to the constitutional protected interest of the citizenry in the affected districts to retain the existing district boundary lines as they were drawn following the 2010 census.
