
Louisiana

Registration Deadline

Forms must be received or postmarked 30 days before an election. T¹



Database Implementation Status

Since the mid-1980s, Louisiana has used a voter registration database built in-house, and currently known as the Elections and Registration Information Network (ERIN). ERIN is a top-down system: county officials directly access a centralized state database. Louisiana is currently upgrading this database architecture.²

Entering Voter Registration Information

Who inputs voter registration information? Parish officials generally review and enter information from voter registration forms in their jurisdictions into the statewide system.

What happens to voter registration forms submitted at state registration agencies? Forms received by the Secretary of State, Office of Motor Vehicles ("OMV"), or another voter registration agency are sent to the Registrar of Voters in the appropriate parish for review and entry.³

How are most forms submitted? Louisiana reported that in 2004, 30% of forms were submitted by mail, 14% were submitted in person to election officials, 37% were submitted at the DMV, 5% were submitted at another voter registration agency, and 15% were submitted by other means.⁴

The relevant portions of the voter registration form are included at the end of this section.

Processing of Forms Without Identifying Numbers

How will the state treat an application with an affirmative indication that the applicant has no valid identifying number? Louisiana's form does not clearly state how an applicant should indicate that she has no valid identifying number.

How will the state treat an application without an identifying number and without an affirmative indication that the applicant has no such number? If uncorrected (see below), and if otherwise eligible, the applicant will be registered as an "inactive" voter, and must provide identification and affirm her residence at the polls in order to vote a regular ballot.⁵

Making the List LA - 1

How will the state treat an application listing an identifying number that is either incomplete or illegible? If uncorrected (see below), and if otherwise eligible, the applicant will be registered as an "inactive" voter, and must provide identification and affirm her residence at the polls in order to vote a regular ballot.⁶

Matching Against Motor Vehicle and Social Security Records

What fields from the voter registration form will the state seek to match to motor vehicle or Social Security records? Identifying number, first name, last name, maiden name, and address.

How precise is the match standard? Louisiana intends to use an exact match standard (accounting for a maiden name), but has not yet finalized the criteria by which a match will be sought.

How much human intervention is involved in determining whether information is matched? The matching process will be fully automated.

Description of matching process: Louisiana has not finalized the details of its matching process. At present, state officials periodically submit a compact disc containing new applicants' information to the OMV, which attempts to match records against its own database of driver's license records. Each applicant's record is then tagged as verified or unverified, and sent back to the state, which forwards results to the appropriate parish office. Louisiana is currently attempting to upgrade its system to provide for real-time matching.

Note: Louisiana also mails a verification notice to every voter submitting an application; if the notice is returned undeliverable, the application is rejected.⁷

What are the consequences if the state cannot find a match? If otherwise eligible, the applicant will be registered as an "inactive" voter, and must provide identification and affirm her residence at the polls in order to vote a regular ballot.

Notice and Opportunity to Resolve Errors

Does the applicant have the opportunity to correct a missing or incomplete identifying number, without submitting a new form? Yes. The applicant may correct missing or incomplete information within 21 days, and may submit a new form at any point before the close of registration.⁸

Does the applicant have the opportunity to resolve a failed match without submitting a new form? Yes. The applicant may submit information to resolve a failed match within 21 days, and may submit a new form at any point before the close of registration.

If information on an otherwise timely application is corrected after the voter registration deadline, is the correction timely? Louisiana has no stated policy on whether an application may be corrected after the voter registration deadline, if the 21 days has not yet expired.

Description of notice and correction process: The parish registrar will attempt to notify by mail an applicant whose identifying number is missing, incomplete, illegible, or unverified. The applicant may offer corrections or additional information to resolve the failure within 21 days. Thereafter, the applicant will be tagged as "inactive," and if otherwise eligible, she will be able to vote upon providing identification and affirming her residence.

Identification Requirements at the Polls

Who must provide identification at the polls? Every voter must provide photo identification.⁹ Any applicant tagged as "inactive" may vote upon further affirming that she currently resides within the appropriate parish.¹⁰

Forms of ID:

voter without verified identifying "generally recognized" photo ID affirmation of residence

every voter:

"generally recognized" photo ID

An applicant registering in person must also submit, at registration, either a current Louisiana driver's license or, if she has none, documentation which establishes her identity, age, and residency. If the registrar has reason to believe that the applicant is not the person she represents himself to be, the applicant must produce two witnesses who live in the precinct. 11 Furthermore, a naturalized applicant must submit proof of naturalization; if she is a first-time registrant, such proof must consist of a certified certificate of naturalization or a current passport.¹²

What forms of identification are accepted? Any "generally recognized picture identification card" is accepted as identification at the polls. 13

What are the consequences of failing to show identification? A voter who has no such card must sign an affirmation stating that she has no such card, and must then provide "other information stated in the precinct register that is requested by the [election] commissioners." ¹⁴ If the voter does not sign the affirmation or cannot provide the additional information, she will be able to cast a provisional ballot in a federal election; in a non-federal election, she will not be able to cast a ballot.¹⁵ The provisional ballot will be counted if the parish board of election supervisors determines that the voter was registered and eligible to vote. 16

Making the List LA - 3

Statutes and Regulations

LA. REV. STAT. ANN. §§ 18:101 *et seq.* generally concern registration. LA. REV. STAT. ANN. § 18:31(A) directs the Secretary of State to establish and maintain a single statewide voter registration database. There are no applicable regulations.

TO REGISTER TO VOTE AND BE ELIGIBLE TO VOTE YOU MUST: 1) be a United States citizen 2) be at least 17 years old to register but must be 18 years old to vote 3) not be under an order of imprisonment for conviction of a felony 4) not be under a judgment of full interdiction or limited interdiction where your right to vote has been suspended 5) reside in the state and parish in which you seek to register and vote.

INSTRUCTIONS FOR COMPLETING THIS FORM: All information except your signature should be printed clearly in ink, preferably black, or typed. Fill in all boxes that apply to you.

Box 1: Indicate whether you are a citizen of the United States of America. Indicate whether you will be 18 years of age on or before election day.

Box 2: Provide full name. Do not use initials for middle or maiden name.

Box 3: 'Residence Address' means the address where you live and are registering to vote. If you claim a homestead exemption, you must list the address of that residence. Do not use a post office box for your 'Residence Address'. If you use a rural route and box number, draw a map in the space labeled 'Give Location.' Write in the names of the crossroads (streets) nearest to where you live. Draw an X to show where you live. Use a dot to show any schools, churches, stores or landmarks near where you live and write the name of the landmark. Complete 'Mailing Address' only if it is different from the 'Residence Address'.

Box 4: Provide your age.

Boxes 6 & 16: You must provide your Louisiana driver's license number, if issued. If not issued, you must provide at least the last four digits of your social security number, if issued. The full social security number may be provided on a voluntary basis. If neither a social security number nor a Louisiana driver's license number has been issued, and this form is submitted by mail, and you are registering to vote for the first time, in order to avoid additional identification requirements for first time voters, attach either a) a copy of a current and valid photo identification or b) a copy of a current utility bill, bank statement, government check, paycheck, or other government document that shows your name and address.

Boxes 8, 11 & 12: The items 'race/ethnic origin', 'daytime phone' and 'home phone' are not required but are helpful.

Box 9: If you do not complete this item, your party affiliation will be listed as 'none'. If you are not affiliated with a political party, please circle 'none'. The recognized political parties are Democrat, Republican, Libertarian, Green and Reform or you may specify any other party affiliation.

Box 17: If you are using this form to request a change of name, you must print the name to be changed here.

Box 19: Date and sign the card with your signature or mark.

If returned by mail, either complete the Mail to: box found on the reverse side or place in an envelope, using the address of the appropriate registrar of voters found on the reverse side. If you have not been issued a social security number or Louisiana driver's license number, you must mail it in an envelope so that you can include the required documentation with your application. Your application or envelope must be postmarked 30 days prior to the first election in which you seek to vote based on the residence listed on this application.

NOTE: 1. If you decline to register to vote, this fact will remain confidential and will be used only for voter registration purposes. If you register to vote, the office where your application was submitted will remain confidential and will be used only for voter registration purposes. 2. Your social security number will also remain confidential and is intended to be used for voter registration purposes only.
